

On December 9, 2014, this Board received the declaration of the Code Enforcement Officer in the above-referenced matter. 

16 The above-captioned matter came on regularly for hearing on December 9, 2014, before the  
17 Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor  
18 Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real  
19 property described as 13955 United Road, Desert Hot Springs, Assessor's Parcel Number 663-222-  
20 006 and referred to hereinafter as "THE PROPERTY."

21 Sophia Choi, Deputy County Counsel, appeared along with Michelle Cervantes, Senior Code  
22 Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

23 Owner did not appear.

24 The Board of Supervisors received the Declaration of the Code Enforcement Officer together  
25 with attached Exhibits, evidencing the substandard structure on THE PROPERTY as violation of  
26 Riverside County Ordinance ("RCO") No. 457 and as a public nuisance.

1 **SUMMARY OF EVIDENCE**

2 1. Documents of record in the Riverside County Recorder's Office identify the owner of  
3 THE PROPERTY as Iris Johnson ("OWNER").

4 2. Documents of title indicate that other parties may potentially hold a legal interest in  
5 THE PROPERTY, to wit: Sunshine Holdings, LTD., Option One Mortgage Corporation, 13955  
6 United Trust, Southwest Financial Corporation, HSBC Bank, USA and Mission Springs Water  
7 District (hereinafter referred to as "INTERESTED PARTIES").

8 3. THE PROPERTY was inspected by Code Enforcement Officers on May 1, 2014, June  
9 25, 2014, July 31, 2014, August 18, 2014 and November 5, 2014.

10 4. During each inspection, a substandard structure (dwelling) was observed on THE  
11 PROPERTY. The structure was observed to be dilapidated and contained numerous deficiencies,  
12 including but not limited to: lack of or improper water closet, lavatory, bathtub, shower or kitchen  
13 sink; hazardous wiring; members of walls, partitions, or other vertical supports that split, lean, list or  
14 buckle due to defective material or deterioration; members of ceilings, roofs, ceiling and roof  
15 supports or other horizontal members which sag, split, or buckle due to defective material or  
16 deterioration; faulty weather protection; general dilapidation or improper maintenance; public and  
17 attractive nuisance – abandoned/vacant.

18 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance  
19 No. 457 by the Code Enforcement Officer.

20 6. A Notice of Pendency of Administrative Proceedings was recorded on July 9, 2014, as  
21 Document Number 2014-0255209 in the Office of the County Recorder, County of Riverside.

22 7. On May 1, 2014, a Notice of Violation, Notice of Defects and a "Danger Do Not  
23 Enter" sign were posted on THE PROPERTY. On June 10, 2014, Notice of Violation and Notice of  
24 Defects for the substandard structure were mailed to OWNER and INTERESTED PARTIES by first  
25 class mail and certified mail with return receipt requested.

26 8. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance"  
27 providing notice of the public hearing before the Board of Supervisors on December 9, 2014, was  
28 mailed to OWNER and INTERESTED PARTIES and was posted on THE PROPERTY.

1 **FINDINGS AND CONCLUSIONS**

2 WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in  
3 regular session assembled on December 9, 2014, finds and concludes that:

4 1. WHEREAS, the substandard structure (dwelling) on the real property located at  
5 13955 United Road, Desert Hot Springs, Riverside County, California, also identified as Assessor's  
6 Parcel Number 663-222-006 violates RCO No. 457 and constitutes a public nuisance.

7 2. WHEREAS, the OWNER, occupants and any person having possession or control of  
8 THE PROPERTY shall abate the substandard structure by razing, removing and disposing of the  
9 substandard structure, including the removal and disposal of all structural debris and materials, and  
10 contents therein or by reconstruction and rehabilitation of said structure provided that said  
11 reconstruction or demolition can be accomplished in strict accordance with all Riverside County  
12 Ordinances, including but not limited to RCO No. 457 within ninety (90) days.

13 3. WHEREAS, the OWNER AND INTERESTED PARTIES ARE FURTHER  
14 NOTICED that the time within which judicial review of the administrative determinations made  
15 herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact,  
16 Conclusions and Order To Abate Nuisance, and is governed by California Code of Civil Procedure  
17 Section 1094.6.

18 **ORDER TO ABATE NUISANCE**

19 IT IS THEREFORE ORDERED that the substandard structure (dwelling) on THE  
20 PROPERTY be abated by the OWNER, or anyone having possession or control of THE  
21 PROPERTY, by razing and removing the substandard structure including the removal and disposal  
22 of all structural debris and materials, as well as the contents therein, or by reconstruction and  
23 rehabilitation of said structure provided such reconstruction and rehabilitation can be accomplished  
24 in strict accordance with all Riverside County Ordinances, including but not limited to RCO No.  
25 457 within ninety (90) days of the posting and mailing of this Order to Abate Nuisance.

26 IT IS FURTHER ORDERED that if the substandard structure is not razed, removed and  
27 disposed of, or reconstructed and rehabilitated in strict accordance with all Riverside County  
28 Ordinances, including but not limited to RCO No. 457, within ninety (90) days of the posting and

1 mailing of this Order to Abate Nuisance, the substandard structure, contents therein, and structural  
2 debris and materials, may be abated by representatives of the Riverside County Code Enforcement  
3 Department, a contractor, or the Sheriff's Department upon receipt of the owner's consent or a Court  
4 Order, where necessary, under applicable law authorizing entry onto THE PROPERTY.

5 FURTHERMORE, the OWNER is ordered to ascertain the existence or non-existence of  
6 asbestos containing materials in said structure by survey and materials sample testing by a duly  
7 licensed and certified asbestos consultant; and, prior to the abatement ordered hereinabove, to secure  
8 the removal of all asbestos containing materials discovered through such survey and testing by  
9 contract with a duly certified and licensed contractor for the handling of such materials to avoid  
10 citations and/or fines by South Coast Air Quality Management District (SCAQMD).

11 IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity  
12 for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special  
13 assessment against THE PROPERTY pursuant to Government Code section 25845 and Riverside  
14 County Ordinance Nos. 457 and 725. Under Riverside County Ordinance No. 725, "abatement  
15 costs" means "any costs or expenses reasonably related to the abatement of conditions which violate  
16 County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation,  
17 collection and administrative costs, attorneys fees, and the costs associated with the removal or  
18 correction of the violation." Reasonable abatement costs accrued by the Code Enforcement
