BACKGROUND:

Summary (continued)

In 2002, the Riverside County Board of Supervisors and the Governor declared a local emergency in regards to the high volume of dead trees caused by the bark beetle epidemic. Following the 2003 wildfires, the Riverside County Fire Department received federal grant funds for reducing the fire hazard on non-federal lands in the San Jacinto Mountains starting in 2004. In July of 2013 and September 2014, the County received a one year extension of the grant funds through December 2015. There is approximately \$765,000 in grant funds remaining that are planned to be expended between now and the end of the grant period. This will allow for full use of the grant funds for various fire mitigation programs.

Impact on Citizens and Businesses

In light of the two fires that affected the mountain communities in the summer of 2013, an additional one year period to this contract would allow landowners in the mountain communities to continue to abate their properties and bring them into compliance with Riverside County ordinances 695, 787, and Public Resources Code (PRC) 4291. Both the Board of Supervisors and the Governor have active emergency proclamations for the San Jacinto Mountains. Increasing and extending this contract will enable the County to continue with this critical and highly successful project.

SUPPLEMENTAL:

Additional Fiscal Information

The Fire Department estimates expending \$ 330,000 in FY 14/15 and \$50,000 in FY 15/16 with Pacific Slope Cooperative Inc. The cost of this contract is 100% funded by 09/10 State Fire Assistance Grant (SFA). This grant was accepted by the Board of Supervisors on July 21, 2009, agenda #3.57. There is a 25% match related to the grant; which will be met by the private property owners when the work is completed on their property or met with in-kind services of existing County staff time, equipment use and facility use.

Contract History and Price Reasonableness

The single tree fuel reduction contract was bid under Request for Proposal #FPARC-073 released in 2009. The resulting contract was awarded to Pacific Slope Tree Cooperative, Inc. in the amount of \$130,000 annually for a period of up to five (5) years. The requested contract extension with Pacific Slope Tree Cooperative, Inc. is to continue the single tree fuel reduction services for an additional one (1) year period with no change in rates from the previous contract year of \$10 to \$29 per DBH (diameter at breast height) inch. This request is due to an increase in necessary fire reduction services and to accommodate the one (1) year grant extension.

The Agreement between Riverside County, herein referred to as COUNTY and Pacific Slope Tree Cooperative, Inc. herein referred to as CONTRACTOR, is amended as follows:

- 1. On page 4 of the Agreement, amend Section 2, "Period of Performance": Amend all reference to the Period of Performance from expiration of December 14, 2014 to a Period of Performance of December 15, 2014 through December 14, 2015, unless terminated as specified in Section 5 TERMINATION. All other terms of the Period of Performance in the Agreement shall apply.
- 2. On page 4 of the Agreement, amend Section 3, "Compensation" to read: The COUNTY shall pay the CONTRACTOR for services performed, products provided and expenses incurred in accordance with the terms of Exhibit B, Payment Provisions. Maximum payments by COUNTY to CONTRACTOR shall not exceed (\$380,000) annually including all expenses.
- 3. All other terms and conditions of the Agreement are to remain unchanged.
