Born on June 26, 1915 in Pittston, Pennsylvania, Frank moved to Riverside with his family in 1927. While attending Riverside Poly High School, he was encouraged to try singing because of his "wonderful" speaking voice. In 1936 he won a state-wide KFI radio contest for his baritone singing skills and then went to New York as the featured soloist on the nationally syndicated Maxwell House Radio program. Using the stage name Frank Travis, he appeared with Lucille Ball, Fanny Brice, Edward Arnold, Adolphe Menjou, and Walter Huston. He loved opera and performed across the nation and in Europe.

During World War II, Frank proudly served our country with the 38th Infantry as a sergeant. He was awarded a Good Conduct medal, American Defense Service medal, and an African Middle Eastern Campaign medal. As the first to sing on the BBC in uniform, he performed for King Peter and Princess Alexandrea of Yugoslavia. After his performing career, he taught voice at UC Riverside and continued as a private voice instructor until the last few months of his life.
