ORDINANCE NO. 452.237
AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 452
RELATING TO PRIMA FACIE SPEED LIMITS

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 2.3 of Ordinance No. 452, entitled "Thirty-five miles per hour," is hereby amended to add new subsections 125 and 126 to read as follows:

"125. On Lincoln Street from a point 1,320 feet west of Noble Street to Bellflower Avenue, a total distance of approximately 1.25 miles, in the Beaumont area.

126. On Skyridge Drive between Lincoln Street and South Cliff Court, a total distance of approximately 1.16 miles, in the Riverside area."

Section 2. Section 2.4 of Ordinance No. 452, entitled "Forty miles per hour," is hereby amended to add new subsections 143 & 144 to read as follows:

"143. On Corkill Road from a point 3,500 feet south of Aurora Road to Dillon Road, a total distance of approximately 0.92 miles, in the Desert Edge area.

144. On Orchard Street between Beaumont Avenue and Noble Street, a total distance of approximately 0.5 miles, in the Cherry Valley area."

Section 3. Section 2.5 of Ordinance 452, entitled "Forty-five miles per hour," is hereby amended to add new subsection 164 to read as follows:

"164. On Briggs Road between Pat Road and Leon Road, a total distance of approximately 1.5 miles, in the Murrieta area."

Section 4. Section 2.6 of Ordinance 452, entitled "Fifty miles per hour," is hereby amended to add new subsection 78 to read as follows:

"78. On Briggs Road between Golden J. Lane and Pat Road, a total distance of approximately 1.0 miles, in the Murrieta area."

Section 5. Section 2.7 of Ordinance 452, entitled "Fifty-five miles per hour," is hereby amended to add new subsection 27 to read as follows:

"27. On Domenigoni Parkway between a point 1,900 feet west of Leon Road to a point 1 mile west of Leon Road, a total distance of approximately 0.64 mile."

Section 6. Subsection 14 of Section 2.7 of Ordinance 452 adopted on September 16, 2008, pursuant to Ordinance No. 452.224, is repealed in its entirety. Subsection 14 of Section 2.7 established a fifty-five miles per hour speed limit on Domenigoni Parkway from Menifee Road to a point 1,900 feet west of Leon Road.

Section 7. Subsection 117 of Section 2.3 of Ordinance 452 adopted on August 20, 2013, pursuant to Ordinance No. 452.234, is repealed in its entirety. Subsection 117 of Section 2.3 established a thirty-five miles per hour speed limit on Briggs Road between Barn Road and Thorens Road.

Section 8. Subsection 163 of Section 2.5 of Ordinance 452 adopted on April 22, 2014, pursuant to Ordinance No. 452.236, is repealed in its entirety. Subsection 163 of Section 2.5 established a forty-five miles per hour speed limit on Orchard Street between Beaumont Avenue and Noble Street.

Section 9. This ordinance shall take effect 30 days after its adoption.

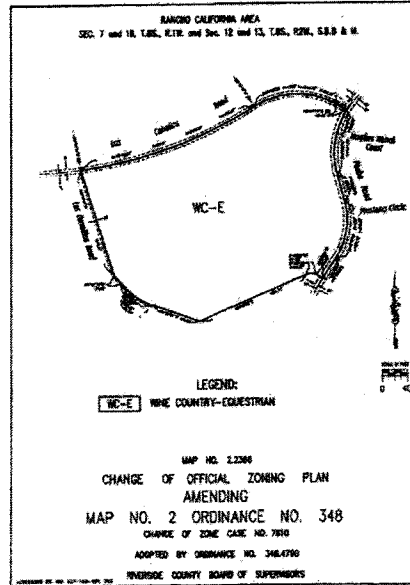
