RECOMMENDED MOTION: That the Board of Directors:

1. Finds that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Sections 15301 and 15302; and
2. Adopt Resolution No. 2015-5 Declaring that the Lake Cahuilla Recreation Park Entry Road Repairs as Emergency Work where such emergency would not permit a delay resulting from a competitive solicitation for bids, that this action is necessary to respond to the emergency pursuant to state guidelines for public agencies for emergency work; and

BACKGROUND:

Summary

On September 8, 2014, the Lake Cahuilla Recreation Area primary park entrance road was significantly damaged as a result of flash floods from a storm. The road collapsed in one area, and sustained significant levels of erosion on both banks along its entire length.

3. Accept the bid submitted by Dateland Construction Co. for Lake Cahuilla Recreation Park emergency entry road repairs, approve the Agreement in the amount of \$136,642 and authorize the Chairman of the Board to execute the Agreement on behalf of the District; and
4. Direct the Clerk of the Board to file a Notice of Exemption with the County Clerk within five (5) days of the approval of the emergency repairs and bid.

BACKGROUND:

Summary (continued)

The Transportation and Land Management Agency (TLMA) was contacted immediately to provide a cost estimate and timeline for repairs. TLMA was unable to complete the work due to the volume of other storm-related road damage throughout the County. TLMA invited three current County vendors to make emergency proposals for the Lake Cahuilla road repairs. Two vendors responded and provided proposals. TLMA and the District reviewed the fee proposal with the lowest, most responsive bidder, Dateland Construction Co. With Central Purchasing's assistance, the District issued an Emergency Purchase Order to Dateland Construction.

The road repairs at Lake Cahuilla Recreation Park are categorically exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Sections 15301 – Existing Facilities and 15302 – Replacement or Reconstruction. The project is to make repairs to an existing road that was washed out by storm waters where there is negligible or no expansion of the existing road. The storm waters made the road impassable and unsafe to the public so the project replaces dirt and paving to restore the road to the same size with no expansion of capacity.

Resolution No. 2015-5 and the Agreement has been approved as to form by County Counsel.

Impact on Citizens and Businesses

Lake Cahuilla Recreation Area and Regional Park is an important outdoor facility for the residents and visitors throughout Coachella Valley and long term tourists who frequent the park in November through March. The road damage was so severe that guests were unable to enter the park safely. This road also serves as the primary access point to the Riverside County shooting range which is utilized by County Law Enforcement, to water district facilities and used by local adjacent property owners.

SUPPLEMENTAL:

ADDITIONAL FISCAL INFORMATION:

The Board of Supervisors approved a budget adjustment in the FY14/15 First Quarter Budget Report on 11/04/2014 for \$200,000. Actual costs were \$136,642, and were paid to Dateland Construction from Fund Balance in the District's Fund 33100 which is reserved specifically for repairs, maintenance, and new construction of District assets and infrastructure.

Contract History and Price Reasonableness:

The actual cost of the road repair was less than the original amount submitted by Dateland Construction; therefore, resulting in cost savings for the District for this necessary work.

9 WHEREAS, on September 8, 2014, a storm and flash floods significantly damaged and
10 washed away a portion of the primary park entrance road to the Lake Cahuilla Recreation Area; and

11 WHEREAS, the road repair work was urgently needed to restore the road to its condition
12 before the storm and alleviate the dangerous condition of the road to allow safe access and passage by
13 those who use the park area, the local water district to access its water tanks and facilities that serves the
14 surrounding community, the shooting range used by Riverside County law enforcement and other area
15 property owners; and

16 WHEREAS, the Riverside County Regional Park and Open-Space District ("District") has
17 found that the circumstances involved with the damage and destruction of the Lake Cahuilla Recreation
18 Area access road warrants a declaration that the public interest and necessity demands the immediate
19 expenditure of public money to safeguard life, health or property;

20 WHEREAS, the District received assistance from the Riverside County Transportation and
21 Land Management Agency and obtained bid proposals from two contractors able to perform this
22 emergency work; and

23 WHEREAS, Dateland Construction Co. submitted the lowest bid for this emergency road
24 repair work;

25 NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the
26 Board of Directors of the Riverside County Regional Park and Open-Space District ("Board"), in regular
27 session assembled on February 3, 2015, that the Lake Cahuilla Recreation Park Emergency Entry Road
28 Repairs is an emergency that would not permit a delay resulting from a competitive solicitation for bids,



AGREEMENT FORM

Page 1 of 2

THIS AGREEMENT, entered into this 16th day of September, 2014, by and between Dateland Construction Co. INC., hereinafter called the "Contractor," and the Riverside County Regional Park and Open-Space District, hereinafter called "District."

WITNESSETH: That the parties hereto have mutually covenanted and agreed as follows:

CONTRACT: The complete contract includes all of the Contract documents, to wit: The Notice Inviting Bids, Instructions to Bidders, Contractor's Quote, Wage Schedule according to the State of California, Payment and Performance Bonds, Plans and Specifications plus any Addenda thereto, General Conditions, including all terms and conditions to the Agreement. All Contract documents are intended to cooperate and become complimentary so that any work called for in one and not mentioned in the other, or vice versa, is to be executed the same as if mentioned in all Contract Documents.

STATEMENT OF WORK: The Contractor hereby agrees to furnish all tools, equipment, services, apparatus, facilities, transportation, labor, and materials necessary for road repairs at Lake Cahuilla Park, in strict accordance with the plans and specifications as prepared by the District, including addenda thereto as listed in the Contractor's Quote, all of which are made part hereof.

TIME FOR COMPLETION: The work shall be commenced on a date to be specified in a written order of the Contractor and shall be completed within **Twenty (20) calendar days** from and after said date. It is expressly agreed that except for extensions of time duly granted in the manner and for the reasons specified in the General Conditions, time shall be of the essence.

COMPENSATION TO BE PAID TO CONTRACTOR: The District agrees to pay and the Contractor agrees to accept in full consideration for the performance of the Contract, subject to additions and deductions as provided in the General Conditions, the sum of One Hundred Thirty-Six Thousand Six Hundred Forty-Two dollars and no cents \$(136,642.00) being the total of the base bid.

The sum is to be paid according to the schedule as provided in the General Conditions.

Pursuant to Labor Code Section 1861, the Contractor gives the following certification: "I am aware of the provisions of section 3700 of the Labor Code which requires every employer to be insured against liability for Worker's Compensation or to undertake self-insurance in accordance with the provisions of that code, and I will comply with such provisions before commencing the performance of work of this contract".



The Riverside County Parks and Open-Space District is requesting immediate approval for emergency road repair work at Lake Cahuilla Park. The park is currently closed to the public and cannot re-open until the road is repaired.

The park's entry road was significantly damaged as a result of flash floods that occurred on 9/8/14 in the early morning hours. The road collapsed in one area and sustained significant levels of erosion on both banks along its entire length. This road is the primary access point to the park for customers as well as service providers.

The standard process for planning, bidding, and completing this work could take up to eight months to complete, during which time the park would have to remain closed to the public. This long of a closure would negatively impact not only the park but hundreds of constituents that enjoy using this venue. Snow bird season will open in October 2014, and fishing season will also be in high gear shortly thereafter. If road repairs are not completed in a timely manner, the District would miss out on that revenue and could lose those customers for future seasons.

The Transportation and Land Management Agency (TLMA) was contacted immediately to provide a cost estimate and timeline for repair. TLMA is unable to complete the work due to the volume of other storm-related road damage throughout the County, but invited three current County vendors to make emergency proposals for the Lake Cahuilla work. Two vendors responded and provided proposals. TLMA and the District have reviewed the fee proposal with the selected Consultant and its team, and believe the fees are fair and in accordance with industry standard for this type of work.

With Central Purchasing's approval, the District will issue a Purchase Order to the consultant to begin work at Lake Cahuilla immediately so as not to extend the park's closure any longer than absolutely necessary. The District will bring the signed contract forward to the Board of Supervisors for ratification at the next available Board date.

Lake Cahuilla Park, Emergency Road Repair Justification

Lake Cahuilla's entry road (primary access to the park for customers as well as service providers) was significantly damaged as a result of flash floods that occurred on 9/8/14 in the early morning hours. The road has collapsed in one area and has been significantly eroded on both banks of the road for the entire length of the road.

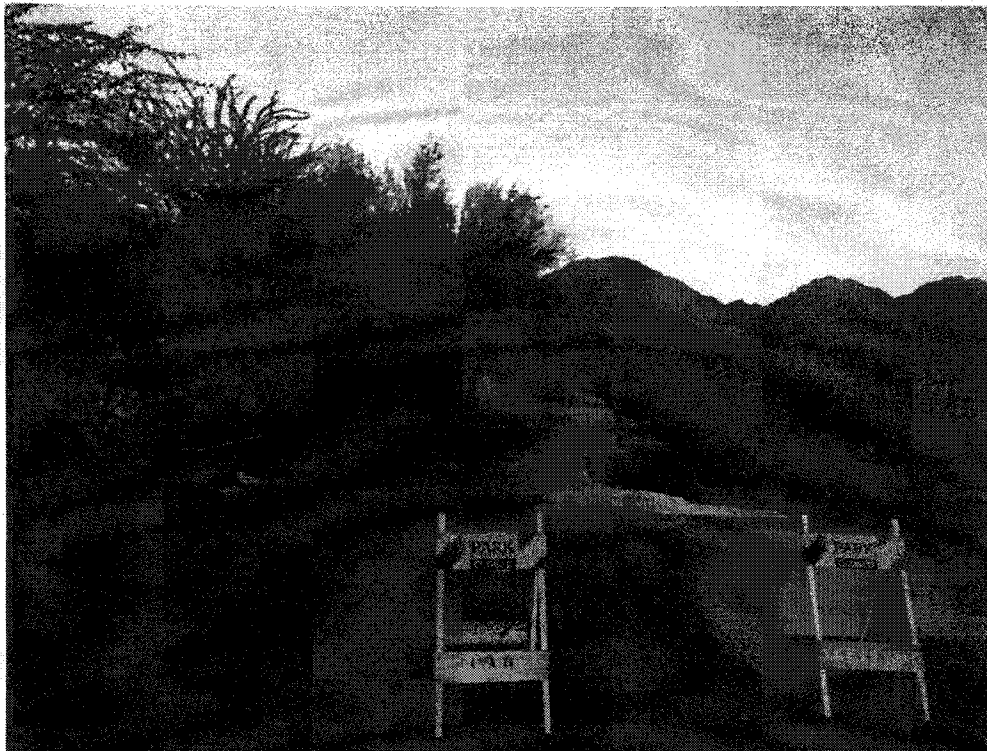
The Riverside County Transportation and Land Management Agency (TLMA) was contacted immediately to provide a cost estimate and timeline for repair; however, they informed the District they are unable to complete the work due to other damage sustained to roads throughout the Count. Transportation staff invited three current County vendors to make emergency proposals for repair. Two vendors responded and provided proposals. While the cost is expected to be around \$150,000, we are requesting a NTE amount of \$200,000 due to the condition of the soil and unknown repairs that may be required once the damaged portions of the road are removed (may require additional soil compaction, additional off-site soil to replace what was eroded, soil compaction testing, etc.)

Lake Cahuilla Park must remain closed until the road is reconstructed as there is no safe access to the park. In addition, the neighboring Quarry housing development cannot access their maintenance yard, Coachella Valley Water District has limited access to test and maintain their water storage facility (lake), and Riverside Sheriff's Organization cannot access their shooting range. It is estimated this closure will further negatively impact revenue estimates as day use and camping cannot occur.

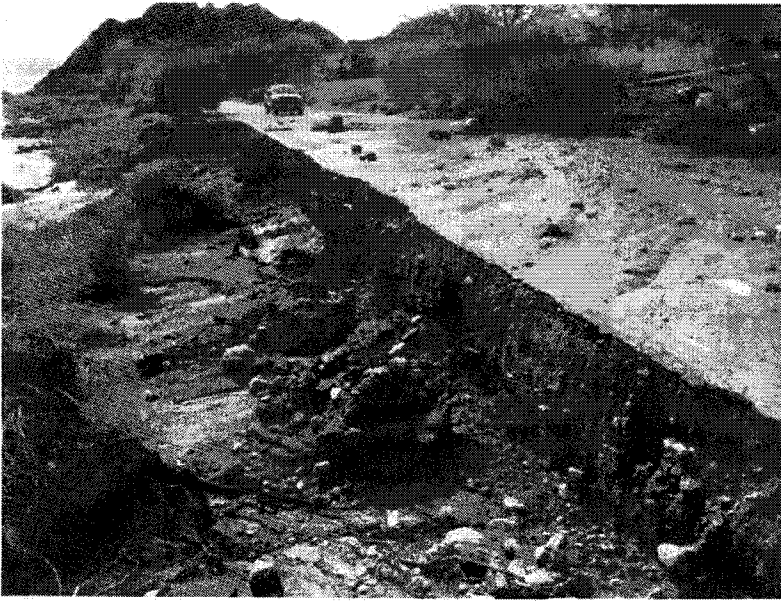
Collapsed portion of the road.


