In 1970 he began his successful career in real estate working for pioneer broker Mary Flake of Menifee at General Estate in Perris and then joined Charles Motte and myself in real estate investment activities.

Born on November 20, 1920 in Turbot, Northumberland County, Pennsylvania, Woody grew up in Williamsport, Lycoming County, in north-central Pennsylvania. After graduating from Williamsport High School in 1939, he enrolled in Duke University where he graduated and completed his first year of law school. He passed the California and Illinois Bar Exams in 1946.

An instrumental force in the community, Woody came to Riverside in 1947 and was employed by W.O. Mackey in the District Attorney's Office. At thirty-two he ran for the position of Municipal Court judge in the Riverside Judicial District and was elected in 1952, serving for eighteen years.

In 1971 he was appointed to the Riverside Superior Court by then Governor Ronald Reagan and founded what is now California Southern Law School in Riverside. He was dean of the law school until 2014.

After retiring in 1980, Woody worked two days a week as a mediator for Riverside Superior Court from 1984 until 2012 and privately in mediation and arbitration from 1981 until 2013. He was also a generous financial supporter of Eden Lutheran Church.

Woody was a loving husband to his wife who preceded him in death and a devoted father, grandfather, great-grandfather, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.

A 1960 graduate of Riverside Poly High School, he attended Oregon State University for two years before transferring to Cal Western in San Diego.

After Woody married Virginia Frazier (Ginny), his wife of 48 years, they settled in Riverside, where he began his prominent career in library administration with the Riverside City and County Public Library. An instrumental force in the community, he oversaw the construction of many permanent libraries around the County that "stand as a testament to his dedication."

When he retired in 1997, Greg enjoyed researching and writing books on the history and geography of Baja California, lesser-known characters of the early American West, and the story of an 82-year-old dentist who sailed a 24-foot dory from Nova Scotia back to his home in Oceanside. He also wrote dozens of articles for boating periodicals about California maritime subjects and maintained an extensive nautical library.

Greg was a wonderful father to his son Matthew who preceded him in death in 1972 and a loving and devoted husband, brother, uncle, and friend. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.

Following his retirement, he worked with Price Waterhouse as a strategic consultant for financial institutions. He also served as a Director on the Board of Affiliated Managers Group and was a long standing member of the Council on Foreign Relations, New York.

After settling in Palm Springs, Harold joined the Board of Trustees of Palm Springs Art Museum in 2003 and drafted what came to be known as "The Meyerman Plan" which was adopted and implemented over a series of years. He worked "tirelessly" to improve the museum's financial position which helped make possible the expansion of the museum's collections and geographic footprint with the addition of both Palm Springs Art Museum in Palm Desert, the Galen and the Faye Sarkowsky Sculpture Garden, and Palm Springs Art Museum Architecture and Design Center, Edwards Harris Pavilion. He actively supported and assisted the museum in raising endowment funds to ensure the success of the museum's future. In 2014, as part of the 75th Anniversary Capital Campaign, Harold and his wife Dorothy made a \$4 million-dollar pledge commitment to endow the position of Director of Development, which now bears their names. At its 75th Anniversary Gala, he was honored for his "unparalleled leadership and steadfast commitment to the museum." Among his many honors, Harold and his wife Dorothy were acknowledged for their philanthropic contributions to Palm Springs with a star placed in their honor on the Palm Springs Walk of Stars on February 14, 2012.



Born in 1933 in St. Louis, Missouri, James "led a life notable for extraordinary achievement and significance." He was a Navy journalist in the Korean War from 1951 to 1954 and then worked as a clerk in the prison population on Alcatraz Island. His professional career began in the Mission District of San Francisco where he taught from 1962 to 1964, then at Laney College in Oakland from 1964 to 1969, followed by San Francisco State University from 1969 to 2002, from which he retired as a full professor. He was also a well-known author and critic of historical fiction.

A resident of San Francisco for 47 years and Coachella Valley since 2002, James was committed to community service, volunteerism, and equal rights. He was a member of the Gay & Lesbian Historical Society of Northern California, where he initiated the "Uncles" oral history project. He supported San Francisco's Horizons Foundation and National Center for Lesbian Rights, as well as the Lambda Literary Foundation, where he was instrumental in the creation of the annual Emerging Writers Retreat. He created and funded the James Duggins Mid-Career Novelist Award, one of the most prestigious prizes awarded annually in LGBT literature. He also volunteered at organizations in support of gay youth, including suicide prevention work.

James was a member of National Teachers of English, International Reading Association, California Teachers of English, the California Reading Association, the original Palm Springs Writers Guild, and the Authors Guild, as well as the Historical Fiction Novel Society. At his home in Oaxaca, Mexico, he was part of a project that provided books to underserved youth. He was also a major collector of Mexican art, from which he made donations to museums in the United States and Mexico including the Palm Springs Art Museum.
