BACKGROUND:
Summary

The Riverside County Department of Mental Health (DMH) approved a project to convert a nine patient unit at the Indio Mental Health Oasis Treatment Facility into office space to accommodate 28 staff members. The conversion to office space required significant work to comply with Office of Statewide Health Planning and Development (OSHPD) standards, but all construction work has been completed per approved construction documents.

On October 16, 2012, the Board of Supervisors approved the construction agreement for the Job Order Contract No. 005 between the County of Riverside and De La Riva Construction, Inc. Pursuant to the contract, three job orders were issued for the Indio Mental Health Oasis Treatment Center Unit B Space Conversion project in the combined amount of \$220,668.

The project has been fully inspected and found to comply with all contract requirements. This Board action will release the contract retention funds of \$11,034 to De La Riva Construction, Inc. The contract retention funds are within the overall project budget and no department budget adjustment is required.

Impact on Citizens and Businesses

Before the nine patient units at the Indio Mental Health Oasis Treatment Facility were converted to office space, staff was overcrowded, sharing space, and scattered throughout other areas of the facility. The new offices will better serve clients by providing a centralized location for staff and increasing client privacy.
