



**BACKGROUND:**

**Summary (continued)**

The Expedition will provide depth with in the Fire Department and will be used within the Integrated Cooperative System. Once title is transferred, the Fire Department will be responsible for the maintenance, repair, and replacement of the vehicle. The vehicle has very low mileage (19,928) and has a code 3 equipment package installed. This type of package on a new vehicle is approximately \$12,000. This donation will save the Department the cost of a new vehicle and outfitting it with code 3 equipment.

The transfer is beneficial to the City of La Quinta as well as the surrounding Cities and Unincorporated areas of the County. The vehicle will be stationed at the City's La Quinta Fire Station #32 and will be used primarily by the Emergency Services Coordinator assigned to the City of La Quinta.

**Additional Fiscal Information**

The maintenance and repair of this vehicle will be allocated through the Department's Cost Allocation Plan and is estimated at \$750 at 30,000 miles. This cost estimate is not anticipated to be an annual cost and the maintenance will vary dependent on the use of the vehicle. All vehicles that are maintained by the Department that are utilized in providing Fire Services are allocated in our annual Cost Allocation Plan.

**Contract History and Price Reasonableness**

The City of La Quinta has been contracting for Riverside County Fire Service since 1991.
