AN ORDINANCE OF THE COUNTY OF RIVERSIDE
APPROVING DEVELOPMENT AGREEMENT NO. 80

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Pursuant to Government Code Section 65867.5, Development Agreement No. 80, a copy of which is on file with the Clerk of the Board of Supervisors and incorporated herein by reference, is hereby approved.

Section 2. The Chairman of the Board of Supervisors is hereby authorized to execute said Development Agreement on behalf of the County of Riverside within ten (10) days after the Effective Date of this ordinance, provided that all landowners listed in Development Agreement No. 80 have executed said Development Agreement within thirty (30) days after adoption of this ordinance.

Section 3. Effective Date. This ordinance shall take effect thirty (30) days after its adoption.

ORDINANCE NO. 914.1

AN ORDINANCE OF THE COUNTY OF RIVERSIDE
AMENDING ORDINANCE NO. 914 RELATING TO THE
REIMBURSEMENT OF INCARCERATION COSTS AND
INCORPORATING BY REFERENCE PENAL CODE
SECTION 1203.1c

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 4 of Ordinance No. 914 is amended to read as follows:

"Section 4. COLLECTION OF MONEYS. The Riverside County Superior Court Enhanced Collections Division is responsible for collection of moneys ordered to be paid pursuant to Penal Code Section 1203.1c. Pursuant to subdivision (b) of Penal Code Section 1203.1d, incarceration costs imposed by this Ordinance shall be Priority 4 reimbursable costs to be disbursed after restitution ordered to or on behalf of, the victim pursuant to subdivision (f) of Section 1202.4 (Priority 1), state surcharge ordered pursuant to Section 1465.7 (Priority 2) and fines, penalty assessments, and restitution fines ordered pursuant to subdivision (b) of Section 1202.4 (Priority 3)."

Section 2. Section 6 of Ordinance No. 914 is amended to read as follows:

"Section 6. PER DAY COST. The average per-day cost of incarceration in County Jail facilities is hereby determined to be \$142.42. Defendants will be charged \$142.42 per day up to and including ten (10) days. Any days over ten (10) will be charged a flat fee of \$1,500.00."

Section 3. EFFECTIVE DATE. This ordinance shall take effect thirty (30) days after its adoption.
