**BACKGROUND:** The donation to the Casa Blanca Home of Neighborly Services will help them maintain services to the community, such as food distribution, translation and interpretation, advocacy and notary, as well as other human, social and supportive services; the donation to the Riverside Downtown Partnership will be used for their retail initiative which will establish Riverside as a premier destination, fashion and dining district which will increase tourism; the donation to the Riverside Ending Homeless Fund will support the 25 Cities Initiative which is a collaboration between government agencies, social service, and faith based organizations in the western region of Riverside County to end homelessness by the end of 2015 and chronic homelessness by the end of 2016; the donation to Service Through Action will be used to help sponsor the Horse Town Brew n Que Festival which raises money for students at Norco High School and to further their mission of foster youth leadership and arts and education programs.
