The originally authorized amount of the contract was \$322,000. The total amended contract is \$262,920, which is 18.3% less than the originally authorized amount.

The work was completed at the direction of the Transportation Department on November 25, 2014, Work Order Number 15-00003.

The emergency repairs were necessary for public safety to protect the roadway and properties located upstream and downstream of the return basin.

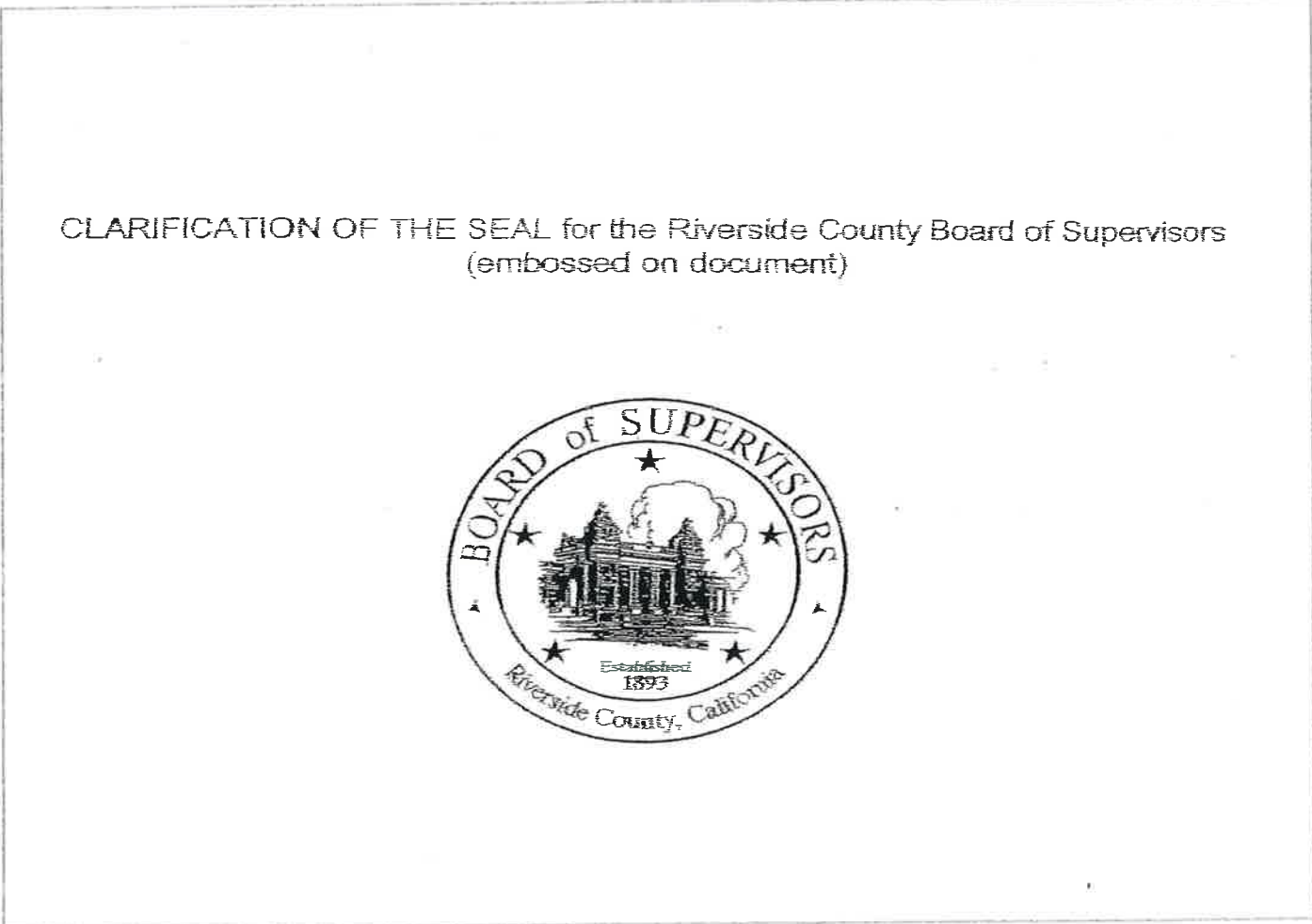

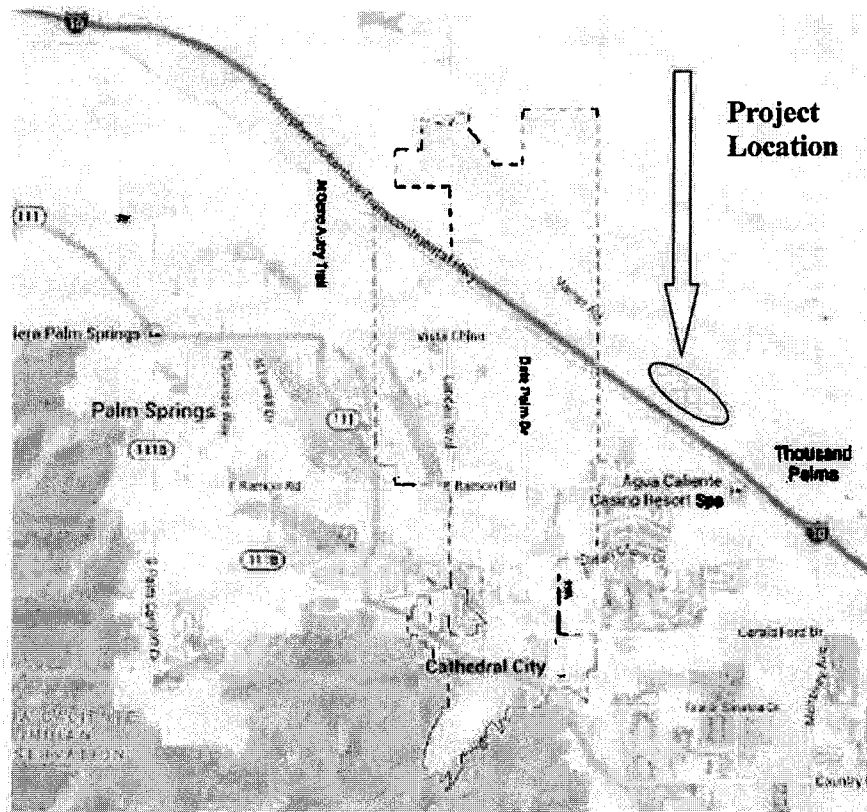
