BACKGROUND:

Summary (continued)

Prior to coming to Riverside County, Chief Crogan served as the Chief Probation Officer of San Diego County, from November 1993 to July 2003, and Santa Barbara County, from March 1980 to September 1988. In addition to his many accomplishments within the local jurisdictions he has worked, Chief Crogan has had significant statewide influence on public policy for community corrections. His accomplishments include appointment by California State Association of Counties (CSAC) to the California Probation Services Task Force under the direction of the California State Supreme Court; a two time Governor's appointment to the California Board of Corrections; Governor's appointment to State Advisory Group for Juvenile Justice and Delinquency Prevention; President of the Chief Probation Officers of California (CPOC); Legislative Chair for CPOC; Co-author and principal lobbyist for the first statewide Juvenile Facility Construction Bond of 1982, the Juvenile Justice Crime Prevention Act of 2000, and the 2010 Youthful Offender Facility Construction bond bill.

Under Chief Crogan's leadership, the Riverside County Probation Department met budget goals each year without any staff layoffs or demotions; fully implemented the juvenile and adult case management and data collection system; established an award winning countywide kiosk reporting system for adult probationers; established local youthful offender programs to treat and supervise juveniles previously committed to state institutions and supervised by state parole; implemented Senate Bill 678, Evidence Based Probation Supervision Program; began implementation of Assembly Bill 109, Public Safety Realignment, to assume county supervision responsibility for adult state parolees; upgraded command centers and security systems for all 3 juvenile halls; repaired and improved the physical plant and grounds of Twin Pines Ranch boys camp and instituted new and upgraded treatment, educational, and vocational programming; and obtained state construction grant funding to build the Youth Treatment and Education Center (YTEC), a 106-bed secure treatment facility to serve male and female juvenile offenders.

The need for YTEC was directly related to the passage of Senate Bill 81, requiring state facilities to only accept juvenile offenders adjudicated for violent crimes or certain sexual offenses. Per the provisions of SB 81, the Local Youthful Offender Rehabilitative Facility Construction Funding Program authorized \$100 M in lease-revenue bond-financing for the acquisition, design and construction of county juvenile facilities to house juvenile offenders no longer accepted by state facilities. In January 2009, the Riverside County Probation Department submitted a proposal for a new secure treatment facility to house this youthful offender population. Although the proposal was not selected for a conditional award, Chief Crogan remained steadfast in his quest to provide Riverside County with a much-needed treatment facility. Chief Crogan persuaded the Executive Board of the Corrections Standards Authority (CSA) to support the Chief Probation Officers of California in their effort to obtain new legislation that would restore SB 81 funding that had been reduced from \$400 M to \$100 M during the legislative process and, thereby, provide funding to counties that had submitted proposals but were not selected to receive conditional awards. Through Chief Crogan's lobbying efforts, a legislative sponsor was found in California Senator Denise Ducheny. On October 19, 2010, the Governor approved Assembly Bill 1628, which increased the \$100 M in lease-revenue bond-financing to \$300 M. This additional funding became affectionately known as "Crogan Cash." On November 18, 2010, the CSA Board motioned to fully fund eight previously unfunded counties, including Riverside County.
