BACKGROUND:

Summary

By Minute Order dated February 10, 2015 (Agenda Item 3-26), the Board of Supervisors authorized the Clerk of the Board to advertise for the reconstruction of Rudell Road from Ontario Avenue to westerly 0.23 miles and also for the modification of existing traffic signal and street improvements at the intersection of Temescal Canyon Road/Ontario Road and El Cerrito Road/Minnesota Road. Both projects are in the community of El Cerrito.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the plans and specifications. Bidders were required to acknowledge and take into account all issued addenda on their Contractor's Bid in order to be considered for award. The addendum was issued to clarify and modify the approved contract documents. The addendum is attached and designated as Addendum No. 1.

Eight bids were received on March 4, 2015, ranging from \$595,007 to \$785,566. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by All American Asphalt (Contractor) in the amount of \$595,007, which is \$59,490 (9%) below the Engineer's Estimate.

Required corrections, in accordance with the Instructions to Bidders, Section 15, "Like Bid Items" were made to the Contractor's Bid. Unit bid prices for bid items 4, 5, 6, 7, 27, 28, and 29 were revised. As a result of these corrections, the Contractor's Bid cost total is revised from \$635,015 to \$595,007. The Contractor was verbally notified of these required corrections after bids were reviewed on the day of the bid opening. The Contractor was notified again in writing when they were issued an Intent to Award letter on March 11, 2015. By signing the contract, All American Asphalt agrees to the corrections made to their bid.

The Contractor is qualified to perform the work as outlined in the bid, has executed the contract, and has provided bonds, which meet the requirements of the contract.

Impact on Residents and Businesses

The proposed improvements will benefit the project area by significantly improving the existing infrastructure, preserving and extending the service life, as well as providing upgrades to enhance safety.

The work is scheduled to begin in June 2015. The work will be phased to keep the roads open during construction and will take approximately two months to complete.

Additional Fiscal Information

Project is funded with Gas Tax (ABX8-9 Mar 2010 New HUTA) Funds, West County DIF Signal Mitigation Fund, and DIF-AP6 Major Improvement Fund – Temescal Canyon Road Funds.

The Development Impact Fee (DIF) program, which is governed under Ordinance 659, allows for the use of DIF funds for traffic signal facilities.

The DIF-AP6 funds were authorized for use under Board of Supervisors Item 3-35 on June 19, 2007.

There are no General Funds used in this project.

Contract

THIS CONTRACT is entered into at Riverside, California as of the date set forth below is between County of Riverside hereafter called "County" and All American Asphalt, hereafter called "Contractor".

WITNESSETH

Recitals:

1. Contractor has submitted to County his Contractor's Proposal for the construction of County Project, **Rudell Road Reconstruction Project, and Temescal Canyon Road, Street Improvements and Traffic Signal Modification Project, Project No. B3-0470 and C4-0069, Community of El Cerrito**, in strict accordance with the Contract Documents identified below and County has accepted said Proposal.
2. Contractor states that he has reexamined his Contractor's Proposal and found it to be correct, has ascertained that his subcontractors are properly licensed and possess the requisite skill and forces, has reexamined the site and Contract Documents and is of the opinion that he can presently do the work in accordance with the Contract Documents for the money set forth in his Proposal to be paid as provided in the Contract Documents.

Agreement:

It is agreed by the parties as follows:

1. **Contract Documents**

The entire Contract consists of the following: (a) The Construction Contract, (b) The Notice Inviting Bids. (c) The Instruction to Bidders, (d) The Bid, (e) The Bid Bond, (f) The Payment Bond, (g) The Performance Bond, (h) The General Conditions, (i) The Special Provisions, (j) The Standard Specifications of the State of California Department of Transportation edition of **2010** as modified in other portions of the Contract Documents and as amended by the State of California Department of Transportation, (k) The Standard Plans of the Department of Transportation identified on the plans or in the Special Provisions, (l) The Plans, (m) Addenda **(One)**, (n) The Determination of Prevailing Wage Rates for Public Work, (o) Any Change Orders issued, (p) Any additional or supplemental specifications, notice, instructions and drawings issued in accordance with the provisions of the Contract Documents. All of said Documents presently in existence are by this reference incorporated herein with like effect as if here set forth in full and upon the proper issuance of other documents they shall likewise be deemed incorporated. The Bid Bond is exonerated upon execution of this Contract and the Payment Bond and Performance Bond.

2. The Work

Contractor shall do all tasks necessary to construct the work generally described in Recital No. 1 in accordance with the Contract Documents.

3. Prosecution, Progress and Liquidated Damages

Attention is directed to the provisions in Section 8-1.04, "Start of Job Site Activities", Section 8-1.05, "Time", and in Section 8-1.10 "Liquidated Damages" of the Standard Specifications and these Special Provisions.

Standard Specification Section 8-1.04B, "Standard Start" is modified to read as follows:

The Contractor shall begin work within fifteen (15) calendar days, or as revised in the Special Provisions, of the date stated within the written "Notice to Proceed".

The Contractor shall notify the Engineer, in writing, of the Contractor's intent to begin work at least 72 hours before work is begun. If the project has more than one (1) location of work, Contractor shall submit a separate notice for each location. The notice shall be delivered to the Transportation Department's Construction Engineer and shall specify the date the Contractor intends to start at said location.

Should the Contractor begin work in advance of receiving a written "Notice to Proceed", any work performed by the Contractor in advance of the date stated in the "Notice to Proceed" shall be considered as having been done by the Contractor at his own risk and as a volunteer and subject to the following:

- A. The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
- B. All work done according to the Contract, prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
- C. The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".

4. Compensation

Contractor shall be paid in the manner set forth in the Contract Documents the amount of his Proposal as accepted by County, the above rates, subject to additions and deductions as provided in the Contract Documents. Said Proposal is on file in the Office of the Clerk of the Board of Supervisors of County.

- a. The repaint of the centerline (Detail 22) and two edge lines (Detail 27B) along Temescal Canyon Road is added to this project, starting at STA. 2+65 and proceed southerly to the City of Corona boundary (street length is approximately 2,400 linear feet).
- b. Replace all missing and existing PAVEMENT MARKERS (REFLECTIVE), starting at STA. 2+65 and proceed southerly to the City of Corona boundary (street length is approximately 2,400 linear feet).

Item 2: Registration with the Department of Industrial Relations (DIR)

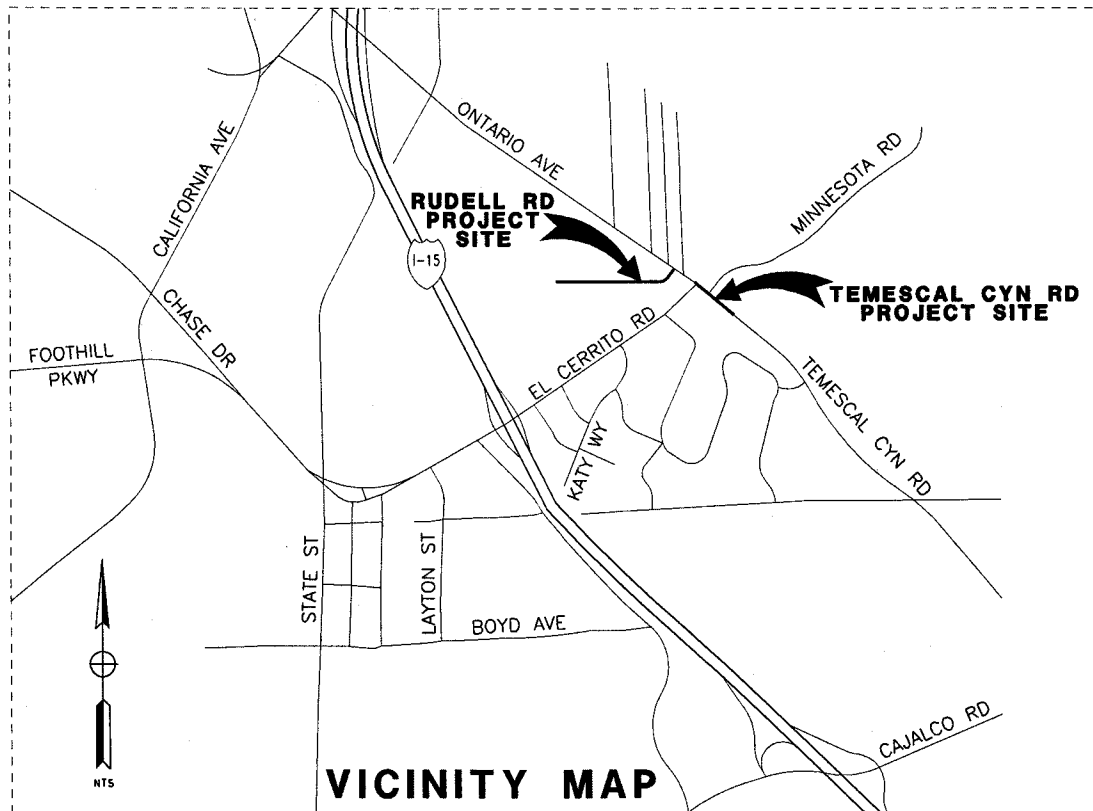
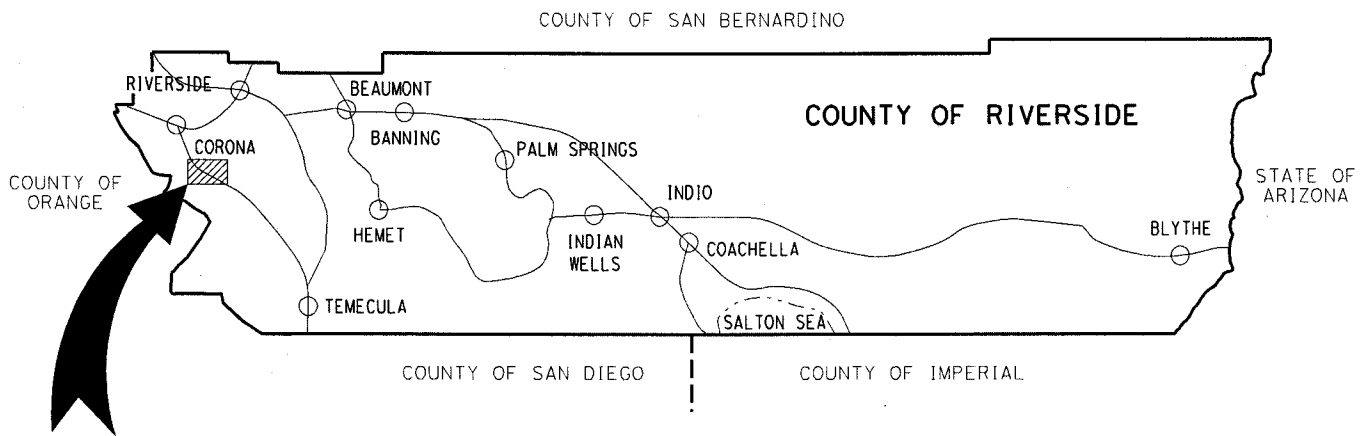

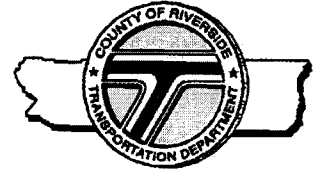
