can be efficiently and cost effectively completed using Transportation Department crews, compared to the traditional bidding process. It should be noted that the Transportation Department contracts out the vast majority of its construction work to private contractors. Certain projects that are less complex and of a maintenance nature can be more efficiently and quickly accomplished using our road crews due to the time and cost savings realized through not having to generate engineered plans and contract specifications, surveying, and inspection costs. Our crews are well versed in construction of roads to County standards.

Assembly Bill 720 (AB720) sets forth modified requirements by which new road construction and road reconstruction can be performed by employees of a public agency. Under AB720, an agency may elect to utilize public employees to perform force account work, provided this work does not exceed 30% of the total value of all work performed by force account other than maintenance, as reported in the State Controller's Streets and Roads Annual Report as of January 1 of each year. The intent to use this authority must be declared prior to commencing the work.

**Impact on Residents and Businesses**

The proposed projects do necessary pavement repair work, and for the current unpaved roads will reduce dust and improve access to local residents.

**Additional Fiscal Information**

The Good Hope area road paving will be funded by Gas Tax Funds in the amount of \$355,000. The Blythe area road paving will be funded by Gas Tax Funds (\$975,000) and Measure A/Palo Verde Funds (\$117,000). The Beaumont/Cabazon area road paving will be funded by Gas Tax Funds in the amount of \$641,000. The Lake Elsinore area road paving will be funded by remaining 1<sup>st</sup> District Developer Agreement (DA) Funds in the amount of \$187,200. The Woodcrest area road paving will be funded by remaining 1<sup>st</sup> District DA Funds in the amount of \$428,400.
