- 3. If the owner or whoever has possession of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. BACKGROUND:

- 1. An inspection was made on the subject property by Senior Code Enforcement Officer Cynthia Black on July 2, 2014. The Inspection revealed the excess outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinances Nos. 348 and 541. The items included but were not limited to: tools, plywood, railroad, ties, appliances, couches, recliner chair, scrap metal, and approximately 100 tires in excess of 10,000 square feet.
- 2. There have been two (2) subsequent follow up inspections, with the last inspection occurring on January 15, 2015. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

I, Cynthia Black, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:

- I am currently employed by the Riverside County Code Enforcement Department as a 1. Senior Code Enforcement Officer. My current official duties as a Senior Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On July 2, 2014, I conducted an inspection of the real property described as 34550 Vista Road, Winchester, Riverside County, California and further described as Assessor's Parcel Number 472-140-009 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Richard L. Gonzales (hereinafter referred to as "OWNER"). A certified copy of the County Equalized Assessment Roll for 2014-2015 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." THE PROPERTY is approximately 20 acres in size, is unimproved, and is located within the R-A (Residential Agricultural) zone classification. Since this is an unimproved parcel, no amount of outside storage is allowed on THE PROPERTY. Accumulated rubbish is not permitted on any property within the County of Riverside.

- 4. Based on the Lot Book Reports from RZ Title Service dated July 7, 2014 and updated on January 8, 2015, it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: Preben and Gail Hansen, State of California Employment Development Department, (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by reference as Exhibit "C."
- 5. On July 2, 2014, I arrived at THE PROPERTY to conduct an inspection. I observed excess outside storage and accumulated rubbish on THE PROPERTY. The outside storage of materials and accumulated rubbish were intermingled and consisted of, but was not limited to: tools, plywood, windows, railroad ties, appliances, couches, recliner chair, scrap metal, and approximately 100 tires, in excess of 10,000 square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") Nos. 348 and 541.
- 6. On August 28, 2014, a Notice of Violation was mailed to OWNER and INTERESTED PARTIES by first class mail and was posted on THE PROPERTY on September 4, 2014.
- 7. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "E."
- 9. There have been two (2) subsequent follow up inspections, with the last being on January 8, 2015. Each inspection revealed the accumulated rubbish and excess outside storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.
- 10. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 11. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO Nos. 348 and 541.

- 12. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the County Recorder, County of Riverside, State of California, on July 16, 2014, as Instrument Number 2014-0264784. A true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F."
- 13. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER and INTERESTED PARTIES, by first class mail and was posted on THE PROPERTY. True and correct copies of the Notices, together with the Proofs of Service, and the Affidavit of Posting of Notices are attached hereto and incorporated herein by reference as Exhibit "G."
- 14. The removal of all accumulated rubbish and all excess outside storage of materials currently on THE PROPERTY is required to bring THE PROPERTY into compliance with RCO Nos. 348 and 541, and the Health and Safety Code. Since the parcel is unimproved, no amount of outside storage is allowed on THE PROPERTY under RCO No. 348. Under RCO No. 541, no amount of rubbish is allowed to be accumulated on THE PROPERTY.
 - 15. Accordingly, the following findings and conclusions are recommended:
- (a) the excess outside storage of materials and accumulated rubbish on THE PROPERTY to be deemed and declared a public nuisance; and
- (b) the OWNER, or whoever has possession or control of THE PROPERTY, be required to remove all outside storage of materials and accumulated rubbish on THE PROPERTY in strict accordance with the provisions of RCO Nos. 348 and 541.
- (c) that if the excess materials and rubbish are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541, within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, the excess outside storage of materials and accumulated rubbish may be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon receipt of owner's consent or a Court Order when necessary under applicable law.
