She ran for city council in 2008 and was also in charge of all of the news media for Dinah Shore in the 20 years she was involved.

On motion of Supervisor Benoit, seconded by Supervisor Ashley, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, April 28, 2015, be adjourned in memory of Raul Bejarano Loya, a prominent resident of Coachella Valley who passed away on April 1, 2015.

An instrumental force in the community, Raul and his wife Servita moved to the Coachella Valley in 1965 and became dedicated educators and pillars in the farm worker cause. He started a newspaper, IDEAL, in a small house in Indio with Alfredo Fuller and Ray Rodriguez. In 1969, he was falsely imprisoned for clapping in unison to drown out Rep. Tunney, who opposed the boycott of non-union grapes. When the Supreme Court of California overturned the sentence, Raul and his co-defendants became known as "The California Four" and the "Unity Clap" became a "hallmark" of the Chicano movement. Although Raul and Servita faced pressure to stop their political work, including death threats, they continued to teach and stand up for what was right. Their work is memorialized in many books, including Forty Acres by Mark Day.

After being denied promotions and noting few Latinos in such roles, Raul filed a lawsuit against Desert Sands Unified School District. Twelve years into the suit, he became a Dean and later a Principal, paving the way for Latino Educators. As Principal, he moved Indio's continuation high school from trailers to its own campus and transformed it into an award-winning school, named Amistad. He also served with MAPA; was part of the CV Federation of Teachers; and co-founded the Mexican American Scholarships.
