BACKGROUND:

Summary (continued)

The Cerner services are a vital component needed for Riverside County Regional Medical Center (RCRMC) for the preparation of medical records, charting and scanning. The required services will supplement hospital staff efforts to meet the standards of Occupational Safety and Health Administration (OSHA).

Cerner is familiar with the proprietary software referred to as Soarian Hospital Information System (HIM) and is able to provide qualified staff to handle the hospital's medical records charting and scanning to become current.

Impact on Citizens and Businesses

This service impacts the patients residing in Riverside County receiving care from Riverside County Regional Medical Center.

Contract History and Price Reasonableness

On September 04, 2007, agenda item 3.50, the Board approved the contract agreement with Siemens Medical Solutions USA, Inc. for a total contract term of 122 months which included ongoing operations, support and maintenance on the hospital's information system. Recently, Cerner Health Services, Inc. acquired Siemens Medical Solutions USA, Inc. Cerner Health Services, Inc. will now be the "Contractor".

To ensure the hospital maintains strict HIPAA regulations, these records are not able to leave the facility and must stay on-site as they are individually imaged.

This amendment is a one-time request until the project is complete and brought up-to-date, not to exceed \$74,000. This amendment is essential in successfully achieving improved workflow production for patient care continuity. The change in practice will enable RCRMC staff to remain current and reduce overtime costs.

**TWENTY-FOURTH AMENDMENT TO THE AGREEMENT
WITH

That certain Agreement between County of Riverside, Riverside County Regional Medical Center ("COUNTY") and **Siemens Medical Solutions USA, Inc.**, ("INITIAL CONTRACTOR"), dated as of September 28, 2004 (as amended, the "Agreement"), one significant amendment to which was dated as of September 26, 2007 and initially approved by the Board of Supervisors September 04, 2007, Agenda Item #3.50, is hereby amended as follows effective April 14, 2015:

1. Delete all references to "Siemens Medical Solutions USA, Inc." and replace with "Cerner Health Services, Inc." to reflect that the Agreement was assigned by Initial Contractor to Cerner Health Services, Inc. ("Contractor").
2. Amend to include the attached Cerner RNER Sales Order for product / service for backscanning value-add consulting services not to exceed a one-time payment for Professional Services Fees of \$74,000.
3. Notices to Contractor shall be sent to the following address and contract instead of the address and contact previously specified in Section 31.4 of the Agreement:
