
SUBJECT: Resolution No. 2015- 131 Approving the Proposed Resolution of Intent of Coachella Valley Water District to Form Assessment District No. 34

RECOMMENDED MOTION: That the Board of Supervisors adopt Resolution No. 2015- 131 approving, pursuant to Section 10104 of the California Streets and Highways Code, the proposed resolution of intention of the Coachella Valley Water District to form Assessment District No. 34.

BACKGROUND: Section 10104 of the California Streets and Highways Code requires the Board of Supervisors to approve the proposed Resolution of Intention of the Coachella Valley Water District (District) to form Assessment District No. 34. The property slated to be included in Assessment District No. 34 is located in the District's boundaries and within the unincorporated Riverside County.

The District proposes to form the assessment district to construct irrigation systems improvements to benefit 7,101 acres of agricultural land. These improvements will provide growers access to Colorado River water in areas where they previously relied on groundwater.

All documents required under Section 10104 of the California Streets and Highways Code have been submitted to the Clerk of the Board. The District passed resolution number 2015-34, requesting the Board's approval.





4 RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE,

5 CALIFORNIA, APPROVING THE INITIATION OF PROCEEDINGS AND THE ASSUMPTION OF

11 WHEREAS, the Board of Directors of the Coachella Valley Water District (the "District") is

12 contemplating the acquisition of certain improvements for the benefit of approximately 7,101 acres of

13 agricultural property located within the unincorporated area of the County of Riverside, California (the

14 "County") under the provisions of the Municipal Improvement Act of 1913; and

16 WHEREAS, pursuant to the Municipal Improvement Act of 1913, the consent of the Board of

17 Supervisors of the County is required for the above proceedings; and

18

19 WHEREAS, the District, in accordance with Section 10104 of the Streets and Highways Code, has

20 submitted to this Board of Supervisors the proposed Resolution of Intention and a map indicating the

21 extent of the territory included in the proposed assessment district;

23 NOW, THEREFORE, the Board of Supervisors of the County of Riverside DOES HEREBY

24 RESOLVE as follows:

26 SECTION 1. The Board of Supervisors hereby approves of and consents to the initiation of

27 proceedings and the acquisition of the improvements as described by said proposed Resolution of

28 Intention, within the area shown on said map.
