

**BACKGROUND:**

**Summary (continued)**

On July 29, 2014 item 3-47, the Board approved the selection of General Electric Healthcare as the vendor for the Radiology Suites Modification Project at RCRMC. At that time, RCRMC Foundation was actively seeking donations to offset some of the estimated \$3.5 million in project costs. KB Home has donated \$250,000 to be used solely toward the purchase of the CT/MRI equipment.

The \$250,000 from KB will be transferred in total amount from the Riverside County Regional Medical Center Foundation to the County of Riverside's Hospital Enterprise Fund. The total \$250,000 from KB Home is to be used solely and specifically for the purchase of new MRI and CT Scanners for the hospital.

RCRMC has sufficient appropriations therefore a budget adjustment is not needed.
