17 The above-captioned matter came on regularly for hearing on April 28, 2015, before the
18 Board of Supervisors of the County of Riverside, State of California in the Board Room, First Floor
19 Annex, County Administrative Center, 4080 Lemon Street, Riverside, California regarding the real
20 property described 34550 Vista Road, Winchester, Riverside County, Assessor's Parcel Number
21 472-140-009 and referred to hereinafter as "THE PROPERTY."

22 Sophia Choi, Deputy County Counsel, appeared along with Regina Keyes, Senior Code
23 Enforcement Officer, on behalf of the Director of the Code Enforcement Department.

24 Mr. Gonzales appeared, but did not address the Board of Supervisors.

25 The Board of Supervisors received the Declaration of the Code Enforcement Officer together
26 with attached Exhibits, evidencing the excessive outside storage of materials and accumulation of
27 rubbish on THE PROPERTY as violations of Riverside County Ordinance Nos. 348 and 541 and as
28 a public nuisance.

1 **SUMMARY OF EVIDENCE**

2 1. Documents of record in the Riverside County Recorder’s Office identify the owner
3 of THE PROPERTY as Richard L. Gonzales (“OWNER”).

4 2. Documents of title indicate that other parties appear to potentially hold a legal interest
5 in THE PROPERTY, to wit: Preben and Gail Hansen and State of California Employment
6 Development Department (hereinafter referred to as “INTERESTED PARTIES”).

7 3. THE PROPERTY was inspected by Code Enforcement Officers on July 2, 2014, and
8 on three other occasions, the last being April 23, 2015.

9 4. During each inspection an accumulation of rubbish and excess outside storage was
10 observed throughout THE PROPERTY consisting of but not limited to: tools, plywood, windows,
11 railroad ties, appliances, couches, recliner chair, scrap metal and approximately 100 tires, in excess
12 of 10,000 square feet.

13 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance
14 Nos. 348 and 541 by the Code Enforcement Officer.

15 6. On July 16, 2014, a Notice of Pendency of Administrative Proceedings was recorded
16 at the Riverside County Recorder’s Office as instrument number 2014-0264784.

17 7. On August 28, 2014, a Notice of Violation was mailed to OWNER and
18 INTERESTED PARTIES by first class mail and was posted on THE PROPERTY on September 4,
19 2014.

20 8. A “Notice to Correct County Ordinance Violations and Abate Public Nuisance”
21 providing notice of the public hearing before the Board of Supervisors was mailed to OWNER and
22 INTERESTED PARTIES and was posted on THE PROPERTY.

23 **FINDINGS AND CONCLUSIONS**


24 WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in
25 regular session assembled on April 28, 2015, finds and concludes that:

26 1. WHEREAS, the excessive outside storage of materials and accumulation of rubbish
27 on the real property located at 34550 Vista Road, Winchester, Riverside County, California, also
28 identified as Assessor's Parcel Number 472-140-009 violates Riverside County Ordinance Nos. 348


1 County Ordinance Nos. 348, 541, and 725. Under Riverside County Ordinance No. 725, "abatement
2 costs" means "any costs or expenses reasonably related to the abatement of conditions which violate
3 County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation,
4 collection and administrative costs, attorneys fees, and the costs associated with the removal or
5 correction of the violation." Reasonable abatement costs accrued by the Code Enforcement
6 Department will be recoverable from OWNER even if THE PROPERTY is brought into
7 compliance within ninety (90) days of the date of this Order to Abate Nuisance.

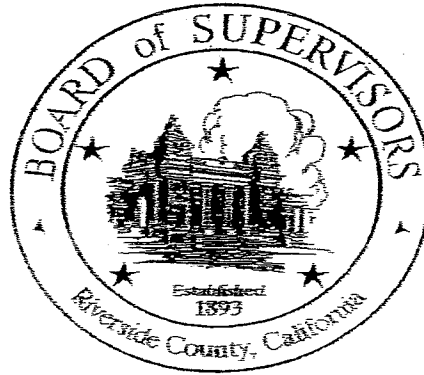
