## **BACKGROUND:**

#### **Summary**

On July 1, 2014, the Board of Supervisors adopted Ordinance No. 348.4473 amending Ordinance No. 348 related to a County of Riverside initiated Change of Zone No. 7819 to amend Section 18.8 "Nonconforming Structures and Use" under Riverside County Ordinance 348. The initiated change removed the time limits on how long a business could continue to operate (amortization period) when the underlying land use or zoning designation is changed from the original designation in place when the business become operational. Subsequently, a Notice of Exemption pursuant to the California Environmental Quality Act was filed and posted with the County Clerk's Office.

## **Summary (continued)**

A Writ of Mandate in Protect Wine Country v. County of Riverside (RIC 1407608), challenging the Notice of Exemption was filed with the Riverside County Court on August 5, 2014 asserting violations of CEQA related to the use of the exemption process for the approval of Ordinance No. 348.4473. The parties subsequently entered into a Settlement Agreement and Release of the lawsuit, which included a condition to repeal Ordinance No. 348.4473.

#### Impact on Citizens and Businesses

The repeal of Ordinance No. 348.4473 will return the amortization period that previously existing under Section 18.8 of Ordinance No. 348.
