

- 1. The excess outside storage of materials on the real property located at 28870 Lakeview Avenue, Nuevo, Riverside County, California, APN: 307-190-020 be declared a public nuisance and a violation of Riverside County Ordinance No. 348.
- 2. Dan W. Eatherton and Carolle R. Eatherton, the owners of the subject real property, be directed to abate the excess outside storage of materials on the property by removing the same from the real property within ninety (90) days.

RECOMMENDED MOTION (continued):

- 3. If the owners or whoever has possession of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property when necessary under applicable law, may abate the excess outside storage by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the excess outside storage of materials on the real property is declared to be in violation of Riverside County Ordinance No. 348, and a public nuisance. Further, County Counsel shall prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial inspection was made on the subject property by Code Enforcement Officer James Pike on August 29, 2013. The inspection revealed the excess outside storage of materials on the subject property in violation of Riverside County Ordinance No. 348. The excess outside storage consisted of, but not limited to: irrigation piping, scrap wood, masonry supplies, construction supplies and equipment, in excess of 99,752 square feet.
- 2. There have been approximately 4 subsequent follow up inspections, with the last inspection occurring on March 23, 2015. The property continues to be in violation of Riverside County Ordinance No. 348.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of excess outside storage.

Impact on Citizens and Businesses

Failure to abate will have a negative impact on citizens or businesses due to health and safety hazards, nuisance and potential impact on real estate values.

- I, James Pike, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On August 29, 2013, I conducted an inspection of the real property described as 28870 Lakeview Avenue, Nuevo, Riverside County, California, and further described as Assessor's Parcel Number 307-190-020 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Dan W. Eatherton and Carolle R. Eatherton (hereinafter referred to as "OWNERS"). A certified copy of the County Equalized Assessment Roll for the 2014-2015 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." THE PROPERTY is approximately 2.29 acres in size, is unimproved, and is located within the R-A (Rural Agricultural) zone classification. Since this is an unimproved parcel, no amount of outside storage is allowed on THE PROPERTY.

- 4. Based on the Lot Book Report from RZ Title Service dated October 21, 2014, and updated on March 26, 2015, it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: State of California Franchise Tax Board, and the State of California Board of Equalization (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by reference as Exhibit "C."
- 5. On August 29, 2013, I drove to THE PROPERTY to conduct an inspection. I observed excess outside storage of materials on THE PROPERTY consisting of, but was not limited to: irrigation piping, scrap wood, masonry supplies, construction supplies and equipment, in excess of 99,752 square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No 348.
- 6. On August 29, 2013, a Notice of Violation was generated and was posted on THE PROPERTY on September 10, 2013.
- 7. On September 20, 2013, a Notice of Violation was mailed to OWNERS by certified mail, return receipt requested.
- 8. On November 20, 2014, a Notice of Violation was mailed to OWNERS and INTERESTED PARTIES by certified mail, return receipt requested.
- 9. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 10. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "E."
- 11. There have been approximately four (4) subsequent follow up inspections, with the last inspection occurring on March 23, 2015. Each inspection revealed the excess outside storage of materials remained on THE PROPERTY in violation of RCO No. 348.
- 12. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and general public.

Furthermore, a recent inspection showed THE PROPERTY remained in violation on RCO

- 14. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the County Recorder, County of Riverside, State of California, on October 2, 2013, as Instrument Number 2013-0475671. A true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F."
- 15. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNERS and INTERESTED PARTIES, by first class mail and was posted on THE PROPERTY. True and correct copies of the Notice, together with Proof of Service and the Affidavit of Posting of Notice are attached hereto and incorporated herein as Exhibit "G."
- 16. The removal and disposal of all excess outside storage of materials on THE PROPERTY is required to abate the nuisance and bring THE PROPERTY into compliance with RCO No. 348, and the Health and Safety Code. Since the parcel is unimproved, no amount of outside storage is allowed on THE PROPERTY under RCO No. 348.
 - 17. Accordingly, the following findings and conclusions are recommended:
- (a) the excess outside storage of materials on THE PROPERTY be deemed and declared a public nuisance;
- (b) the OWNERS, or whoever has possession or control of THE PROPERTY be required to remove all outside storage of materials on THE PROPERTY in strict accordance with the provisions of RCO No. 348.
- (c) if the materials are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to Riverside County Ordinances No. 348, within ninety (90) days after posting and mailing of the Board's Order and Findings, the excess outside storage of materials may be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon receipt of an owner's consent or a Court Order, where necessary under applicable law.

1	(d) that reasonable costs of abatement, after notice and opportunity for hearing, shall be
2	imposed as a lien on THE PROPERTY, which may be collected as a special assessment against THE
3	PROPERTY pursuant to Government Code Section 25845 and RCO Nos. 348 and 725.
