- 1. An inspection was made on the subject property by Code Enforcement Technician Jurden on August 7, 2014. The Inspection revealed excess outside storage of materials and an accumulation of rubbish on the subject property in violation of Riverside County Ordinances Nos. 348 and 541. The items included but were not limited to: burned remains of a frame and contents of a mobile home, in excess of 5,544 square feet.
- 2. There have been approximately 7 subsequent follow up inspections, with the last inspection occurring on March 6, 2015. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

DECLARATION OF CODE ENFORCEMENT TECHNICIAN DAVID JURDEN

- I, David Jurden, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:
- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Technician. My current official duties as a Code Enforcement Technician include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On August 7, 2014, I conducted an inspection of the real property described as 51940 Maxine Avenue, Cabazon, Riverside County, California and further described as Assessor's Parcel Number 528-032-023 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Estate of Chris J. Winekoff and Albert W. Winekoff (hereinafter referred to as "OWNERS"). A certified copy of the County Equalized Assessment Roll for 2014-2015 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." The property is an improved parcel approximately .11 acres in size and is located within the W-2-M (Controlled Development Area with Mobilehomes) zone classification. The zone allows for outside storage of materials on improved lots or parcels of one acre or more provided the amount is limited to two hundred (200) square feet with a maximum height of three (3) feet. Due to this size of the parcel no outside storage is allowed. Accumulated rubbish in not permitted on any property within the County of Riverside.

- 4. Based on the Lot Book Reports from RZ Title Service dated August 19, 2014 and updated on January 29, 2015, it is determined that other parties may potentially hold a legal interest in THE PROPERTY, to wit: Marguereite W. Winekoff, Edward J. Szynkowski, Jr. and Cabazon Water District, (hereinafter referred to as "INTERESTED PARTIES"). True and correct copies of the Lot Book Reports are attached hereto and incorporated herein by reference as Exhibit "C."
- 5. On August 7, 2014, I drove to THE PROPERTY to conduct an inspection. I observed excess outside storage and accumulated rubbish on THE PROPERTY. The outside storage of materials and accumulated rubbish were intermingled and consisted of, but was not limited to: burned remains of a frame and contents of a mobile home, in excess of 5,544 square feet. This condition causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") Nos. 348 and 541.
- 6. On August 7, 2014, a Notice of Violation for the excess outside storage of materials and accumulated rubbish was posted on THE PROPERTY.
- 7. On October 22, 2014, October 23, 2014 and September 18, 2014, a Notice of Violation was mailed to OWNERS and INTERESTED PARTIES, Marguereite W. Winekoff and Edward J. Szynkowski, Jr., by certified mail, return receipt requested and was posted on THE PROPERTY on October 28, 2014 and September 23, 2014.
- 8. On February 18, 2015, a Notice of Violation was mailed to INTERESTED PARTY, Cabazon Water District by certified mail, return receipt requested and was posted on THE PROPERTY on February 20, 2015.
- 9. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 10. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "E."
- 11. There have been approximately seven (7) subsequent follow up inspections, with the last inspection being March 6, 2015. Each inspection revealed the accumulated rubbish and excess outside storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.
