RECOMMENDED MOTION: That the Board of Supervisors:
Approve the use of 1st District Development Agreement Public Facilities Funds for the upgrades and general improvements of Good Hope Community Center.

BACKGROUND:

Summary

Good Hope is an economically disadvantaged community located along the Hwy 74 Corridor between the Cities of Perris and Lake Elsinore. It has a small park and the modestly sized Moses-Schaffer Community Center, both of which are in need of upgrades and general improvements. There is funding available in the Developer Agreement Public Facilities (DA-PF-SD-1) account that is designated specifically for community improvements in the 1st District. By transferring the funds to the Riverside County Parks and Open Space District, who is responsible for operation and maintenance of these facilities, many of these capital improvements to the park and community center can be expedited.


