



BACKGROUND:

1. Riverside County Economic Development Agency- \$10,000- The funding will provide a free kids' zone for children attending the inaugural 2015 French Valley Airport air show. The air show will enhance and increase the economic development of the airport as well as the surrounding Southwest Riverside County area. This event's estimated attendee's based on similar events are 40,000 residents.
2. Idyllwild Help Center - \$3,500- The funding will support the Summer Safety Net Program which has two objectives summer utility assistance and providing perishable foods, (fruits, vegetables and proteins) for low income residents.
3. Debbie Chisholm Memorial Foundation - \$2,500- the allocated funding will grant the wishes of sick and terminally ill children in Riverside County.
4. Michelles Place, Breast Cancer Resource Center- \$5,000- Provides diagnostic services directly related to breast health for uninsured and underinsured women less than 40 years old and have a symptom of breast cancer.
