

**BACKGROUND:** Community Improvement Designation Funds will be utilized by the Riverside County Economic Development Agency to provide cleanup access, services, and equipment to eligible low income residential property owners in CDBG-eligible unincorporated neighborhoods within the 1<sup>st</sup> Supervisorial District as part of the "Community Beautification Program." Cleanup services, collection, removal of waste, and equipment will be provided under contract by the area "Franchisee" as defined in the Riverside County Code of Ordinance, "Chapter 8.132 - Solid Waste Collection and Disposal" for Riverside County's Supervisorial District One.
