

### BACKGROUND: Summary

- 1. Desert Hot Springs Elks Lodge #2639 is providing low-income youth in Desert Hot Springs with scholarships for little league, soccer and football. CID funding will be used to support these scholarships.
- 2. Rec-N-Crew raises funds to support the youth sports programs offered at the Joe Wine Recreation Center in Blythe. Residents from three years of age to senior citizens use the facility for low-cost sports and exercise programs. The gym floor is 20 years old and is in need of repair. The CID funds will be used to repair the gym floor at the recreation center.

- 3. The Blythe Police Activities League is sponsoring a summer aquatics program at the Palo Verde High School pool in Blythe. The City of Blythe has limited recreational programs available to residents. This summer program will open the pool to youth, adults and families, providing a safe environment to have fun during the summer months. This program offers swim lessons, water aerobics, jobs for youth and adults, and provides the necessary equipment for the handicapped to swim. CID funds will be used to support this program.
- 4. The Colorado River Fair 54<sup>th</sup> District Agricultural Association organizes the annual Colorado River Fair in Blythe. The fair showcases agriculture in the Palo Verde Valley and supports 4-H and Future Farmers of America programs. More than 18,000 people attend the fair annually. Throughout the year, approximately 82,000 people attend other special events and activities at the Colorado River Fairgrounds. CID funds will be used to replace the compressor on the walk-in refrigerator which is utilized for food storage during the fair and other events.
- 5. The Regional Access Project Foundation is working with the Caster Family Center for Nonprofit and Philanthropic Research to create a report focusing on nonprofits throughout Riverside County. The report, "Riverside County Causes Count," will provide an overview of the social and economic impacts nonprofits have throughout Riverside County. This report will be presented at the RAP Foundation's communication conference. CID funding will be used to support the project.
- 6. The Regional Access Project (RAP) Foundation serves as the fiscal agent for the scholarship fund for the Fourth District Youth Advisory Council (YAC). YAC members are high school students who participate in monthly community and county service projects in the Fourth District. CID funds will go to the RAP foundation to support the scholarship fund.
- 7. The Regional Access Project (RAP) Foundation will hold its communications conference "Changing Lives, Making Impact" on Oct. 21, 2015. The conference will bring together more than 200 nonprofits that serve eastern Riverside County residents. One of the conference events, "Desert Fast Pitch," is a competition among nonprofits that teaches them how to effectively communicate their organization's message to potential supporters. Improving nonprofits' abilities to secure more funding for their vital services and projects will have a greater impact for eastern Riverside County residents. CID funds will be used to support this conference
- 8. The Desert Recreation District will be providing summer activities in the eastern Coachella Valley. Many of the youth and families in this area are low-income and have few options for family recreation. These programs will provide families with a healthy, safe and fun environment at no cost to enjoy movies, family nights and a Teen Scene program. These activities will run throughout the summer and benefit 20 to 30 children on average at each location. CID funding will be used to support the summer programs in North Shore, Oasis and Thermal.
