#### **BACKGROUND:**

#### Summary

The Department of Mental Health (DMH) operates a continuum of care system that consists of County-operated and contracted service providers delivering a variety of mental health treatment services within each geographic region of Riverside County.

On December 9, 2014, (3-17) the Board of Supervisors approved the combined aggregate for Mental Health Children's Services in the amount of \$20,810,625 for FY 14/15. DMH is requesting that the Board approve and execute the one year Agreements with the updated list of vendors as listed in Attachment A for the same aggregate amount of \$20,810,625 for Children's Mental Health Services for FY 15/16, through June 30, 2016.

Services provided by vendors listed in Attachment A include the following:

- Day Treatment
- Case Management/Brokerage
- Mental Health Services (Individual, Group and Family Therapy)
- Therapeutic Behavioral Services
- Behavioral Coaching Services (MHSA funded)
- Medication Evaluation and Monitoring
- Crisis Intervention
- Intensive Home Based Services

In addition, these vendors will be providing "Katie A" services, which are required by the state. The "Katie A" lawsuit settlement requires California counties to provide mental health services to an increased population of children under the age of 18 and their families, who are either in foster care or at imminent risk of entering the child welfare system.

Due to the specialized services provided by the vendors listed in Attachment A, DMH requires the flexibility to add vendors if necessary to ensure continuity of care. Such vendors are subject to providing proof of Medi-Cal or other certification, appropriate licensing and/or other standard review qualifications. Additionally, the reserve amount listed in the attachment is intended to be used for the five (5) county Joint Powers Agreement for the Van Horn Regional Treatment Facility, to provide children and adolescents mental health services, funded through Medi-Cal. This agreement is currently in the negotiation process and is anticipated to be finalized and presented to the Board within the next few months.

#### **Impact on Citizens and Businesses**

These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.

#### **Additional Fiscal Information**

The Agreements outlined in Attachment A are based on established negotiated rates and/or Mental Health Services Act (MHSA) funds and have termination clauses in the event that applicable funds become unavailable for service provision. There are sufficient funds in the Department's FY 15/16 budget, and no additional County funds are required.

#### **Contract History and Price Reasonableness**

These Agreements are scheduled for re-bid in FY 15/16. The Department is requesting approval of these vendors in the interim to avoid interruption of services and ensure continuity of care for consumers. The established rates were negotiated based upon the predetermined Riverside County Maximum Allowable Rates as set by the State.
