RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and authorize the Chairman to execute the Second Amendment to the Contract Agreement with Lydia David, M.D., to provide physician services for RCRMC's Detention Health effective July 1, 2015 through June 30, 2020,
2. Approve and authorize the Chairman to execute the Second Amendment to the Contract Agreement with Nerizza Andrada, M.D., to provide physician services for RCRMC's Detention Health effective July 1, 2015 through June 30, 2020,
3. Authorize the Purchasing Agent to move dollars between these agreements as needs dictate as long as the total maximum amount does not exceed \$84,000 annually, and;
4. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise renewal options, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation no to exceed ten percent above the annual aggregate amount of the contract, as approved by County Counsel.

BACKGROUND:

Summary

In accordance with Title XV, Riverside Juvenile Hall is mandated to provide professional medical services as it pertains to sick calls, medical evaluations and routine medical screenings to all juveniles housed in detention health. With only one full time physician for the department covering after hours, there is a critical need for contracted physicians to assist in the provision of on-call duties. Dr. Lydia David and Dr. Nerizza Andrada have provided after hour coverage for five years, and have agreed to continue providing services at the juvenile hall sites, as requested until permanent recruitment and hiring of physicians could be completed by Riverside County Regional Medical Center (RCRMC) human resources.

The hospital continues to process hiring of two full time physicians to begin on call duties. Once they have completed orientation, it will alleviate the need for contracted physicians to provide this needed service.

Impact on Citizens and Businesses

This service impacts the patients in Riverside County receiving care from Riverside County Regional Medical Center.

Contract History and Price Reasonableness

On July 20, 2010, contract agreements with both Dr. Lydia David and Dr. Nerizza Andrada were established without securing competitive bids in accordance with Board Policy A-18 and Ordinance 459.4. Then on June 19, 2012; agenda item number 3.43, the Board of Supervisors approved the First Amendment to increase the annual amount for both contracted physicians. This amendment extends the period of performance for each contracted physician for an aggregate amount not to exceed \$84,000 annually. The hourly rates which were originally established for one hundred dollars (\$100) per hour for each hour of service performed will remain the same for this amendment.
