BACKGROUND:

Summary

Landscaping and Lighting Maintenance Districts (L&LMD's) are formed for the purpose of creating a funding mechanism to pay for the installation and maintenance of landscaping, streetlights, traffic signals, drainage inlet water quality filters, decorative fencing, and other roadside features within the road right of way. Within an established L&LMD, zones are created for specific developments, a fee structure is developed specific to the features within that zone, and the zone is then assessed through a tax levy on annual basis for the installation and maintenance of the features within that particular zone.

L&LMD No. 89-1-C was formed in 1994, Resolution No. 94-389, and currently consists of 124 individual zones with different fee structures spread throughout Riverside County. The commercial property owner of Parcel Map No. 33530 and Plot Plan No. 23332, as described in the attached Exhibit "A", has petitioned the County to annex their property into L&LMD No.89-1-C, creating Zone 193. The boundaries of Zone 193 will encompass the entire Parcel Map No. 33530 and Plot Plan No. 23332 and will include drainage inlet fossil filters, streetlights, and traffic signals.

Pursuant to the Landscaping and Lighting Act of 1972 and Resolution 2015-067 adopted May 12, 2015, the Board of Supervisors noticed a public hearing for June 30, 2015, to receive testimony regarding the Annexation of Zone 191 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated (L&LMD No. 89-1-C). Annexation of Zone 193 will fund the maintenance and servicing of fossil filters, streetlights, and traffic signals within public rights-of-way located easterly of Webster Avenue, westerly of Harvill Avenue, southerly of Citrus Avenue, and northerly of Nuevo Road in the Mead Valley area and includes 18 assessable commercial parcels totaling 92.15 acres.

On May 13, 2015 a notice of the public hearing and information sheet, a mail-in ballot, an impartial analysis, and a copy of Resolution No. 2015-067 was mailed to the property owner within Zone 193, proposed for annexation to L&LMD No. 89-1-C. Pursuant to the notice, all ballots must be returned prior to the conclusion of the public hearing.

Notice of the public hearing was also given by publication of a certified copy of Resolution No. 2015-067 in an appropriate newspaper at least ten (10) days prior to the public hearing date and by posting a certified copy of the Resolution No. 2015-067 on the official bulletin board customarily used by the Board of Supervisors for the posting of notices and in two (2) other public locations within the County.

Reference

At the direction of the County of Riverside Board of Supervisors, L&LMD No. 89-1-C was formed in 1994 by Resolution No. 94-389 authorizing the annexation of new zones into L&LMD No. 89-1-C for the purpose of levying assessments to pay for the installation and maintenance of landscaping, streetlights and other right-of-way approved improvements.

The zone specific Engineer's Report for fiscal year 2015-2016 was prepared in compliance with the requirement of Article 4, Chapter, 1, of the Landscaping and Lighting Act of 1972, which is Part 2, Division 15 of the California Streets and Highways Code. The County initiates annexation proceedings for the annual levy of assessments by passing a resolution, which proposes the new levy under the Landscaping and Lighting Act of 1972. This resolution also describes the improvements, describes the location of the zone within the District and finally orders an engineer, who is a registered professional engineer, certified by the State of California, to prepare and file a detailed report.

In November 1996, California voters passed Proposition 218, Right to Vote on Taxes Act which added Articles XIII C and XIII D to the California Constitution, new procedures must be followed to levy annual assessments under the Landscaping and Lighting Act of 1972. A County may levy annual assessments for an assessment district after complying with the requirements of the Landscaping and Lighting Act of 1972, and the provisions of Proposition 218 Right to Vote on Taxes Act.

Impact on Residents and Businesses

The new assessment will provide the maintenance and servicing of fossil filters, streetlights, and traffic signals within public right-of-way.

Only the commercial property owners within the proposed boundaries of Zone 193, which are represented by Parcel Map No. 33530 and Plot Plan No. 23332, as described in the attached Exhibit "A" (a two page exhibit containing a description and diagram) are impacted by the cost of this annexation. By setting up an assessment for the maintenance of certain infrastructure required by the development, the County requires that the development pay for its maintenance impact, rather than the obligation falling upon public funding sources.

SUPPLEMENTAL:

Additional Fiscal Information

The proposed budget for fiscal year 2015-16 for Zone 193 is \$7,722. This will result in an assessment for fiscal year 2015-16 within Zone 193 of \$75 per acre. The annual assessment may be adjusted annually by the greater of 2% or the cumulative percentage increase in the Consumer Price Index for all Urban Consumers (CPI-U), if any, as it stands as of March of each year over the base index for March of 2015.

Location Map

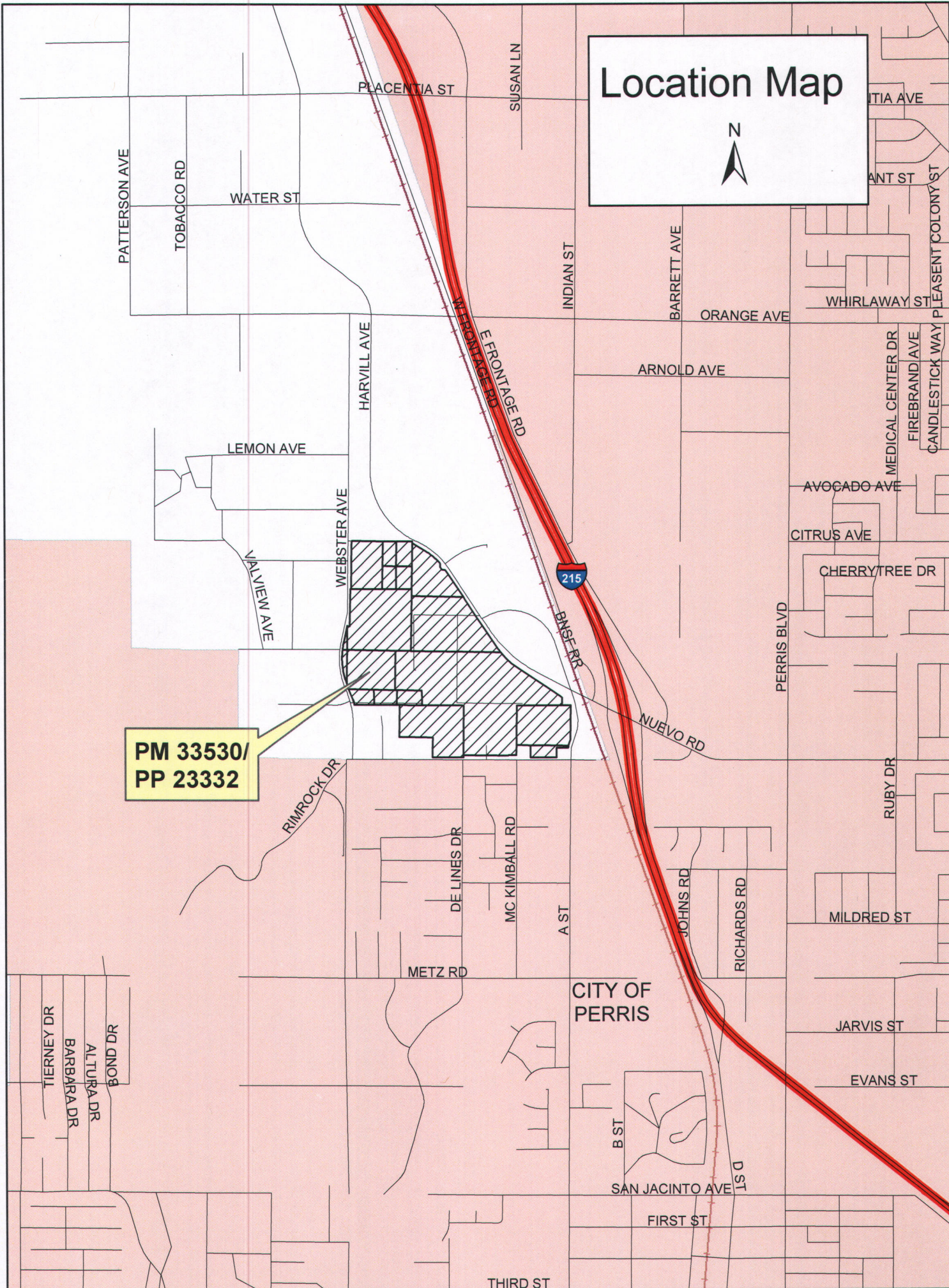

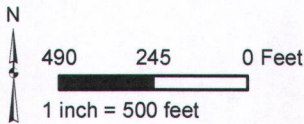

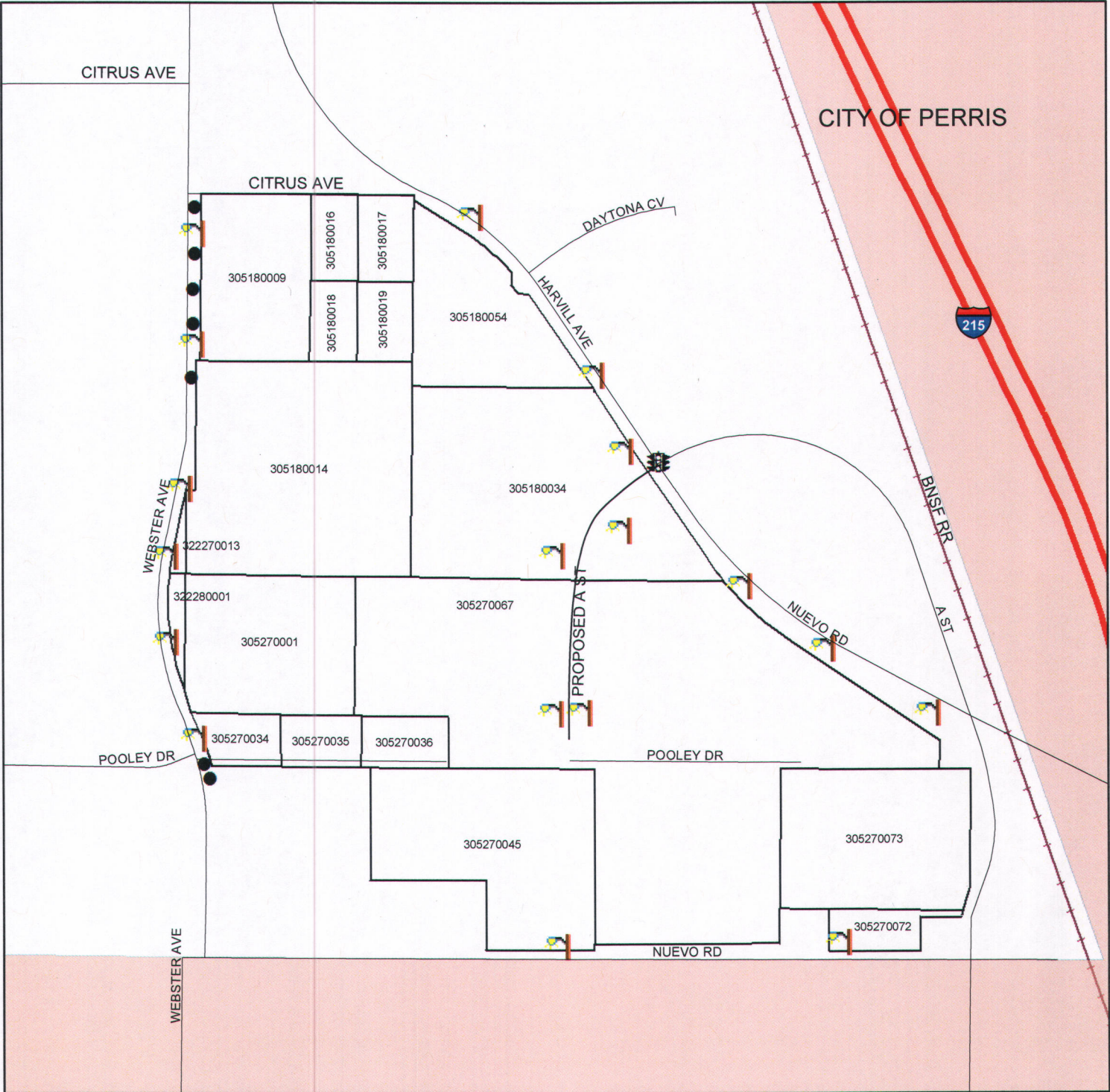

BACKGROUND:

Summary

Adoption of Resolution No. 2015-066 appoints the Director of the Transportation and Land Management, or his designee, as the engineer to prepare a report regarding the proposed annexation of Zone 193 to Landscaping and Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C").

Resolution No. 2015-067 declares the Board of Supervisors' intention of ordering the annexation of Zone 193 to L&LMD No. 89-1-C. The annexation of Zone 193 to L&LMD No. 89-1-C will fund the maintenance and servicing of fossil filters, streetlights, and traffic signals within public right-of-way located easterly of Webster Avenue, westerly of Harvill Avenue, southerly of Citrus Avenue, and northerly of Nuevo Road in the Mead Valley area and includes 18 commercial parcels totalling 92.15 acres.

Consistent with the Board of Supervisors' direction regarding compliance with Article XIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on June 30, 2015, to receive testimony for and against the proposed assessment. Each property owner within the proposed Zone 193 will receive a notice of the public hearing and mail-in ballot, an impartial analysis, a copy of Resolution No. 2015-067, and an information sheet.

Ballots must be returned prior to the conclusion of the public hearing. If at the time designated for the tabulation of the ballots, the ballots submitted in favor of the annexation and levy of the assessment exceed the ballots submitted in opposition of said annexation and levy, Zone 193 will be annexed to L&LMD No. 89-1-C.

There is only one individual/entity, which owns all of the property within the proposed boundaries of Zone 193, and said property owner has executed a "Waiver and Consent Regarding Date of Assessment Ballot Election," allowing for the election and public hearing to be held on June 30, 2015.

Impact on Residents and Businesses

The new assessment is for the purpose of providing the maintenance and servicing of fossil filters, streetlights, and traffic signals within public right-of-way.

The property owners within the proposed boundaries of Zone 193, which are represented by Parcel Map No. 33530 and Plot Plan No. 23332, as described in the attached Exhibit "A" (a two page exhibit containing a description and diagram), are impacted by the cost of this annexation. The property owners within the proposed boundaries of Zone 193 have petitioned the County of Riverside to annex their property to L&LMD No. 89-1-C and understand that this annexation will result in an assessment on their property to fund the maintenance and servicing of the aforementioned improvements (fossil filters, streetlights, and traffic signals).



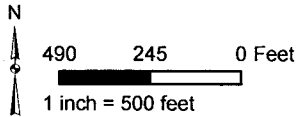

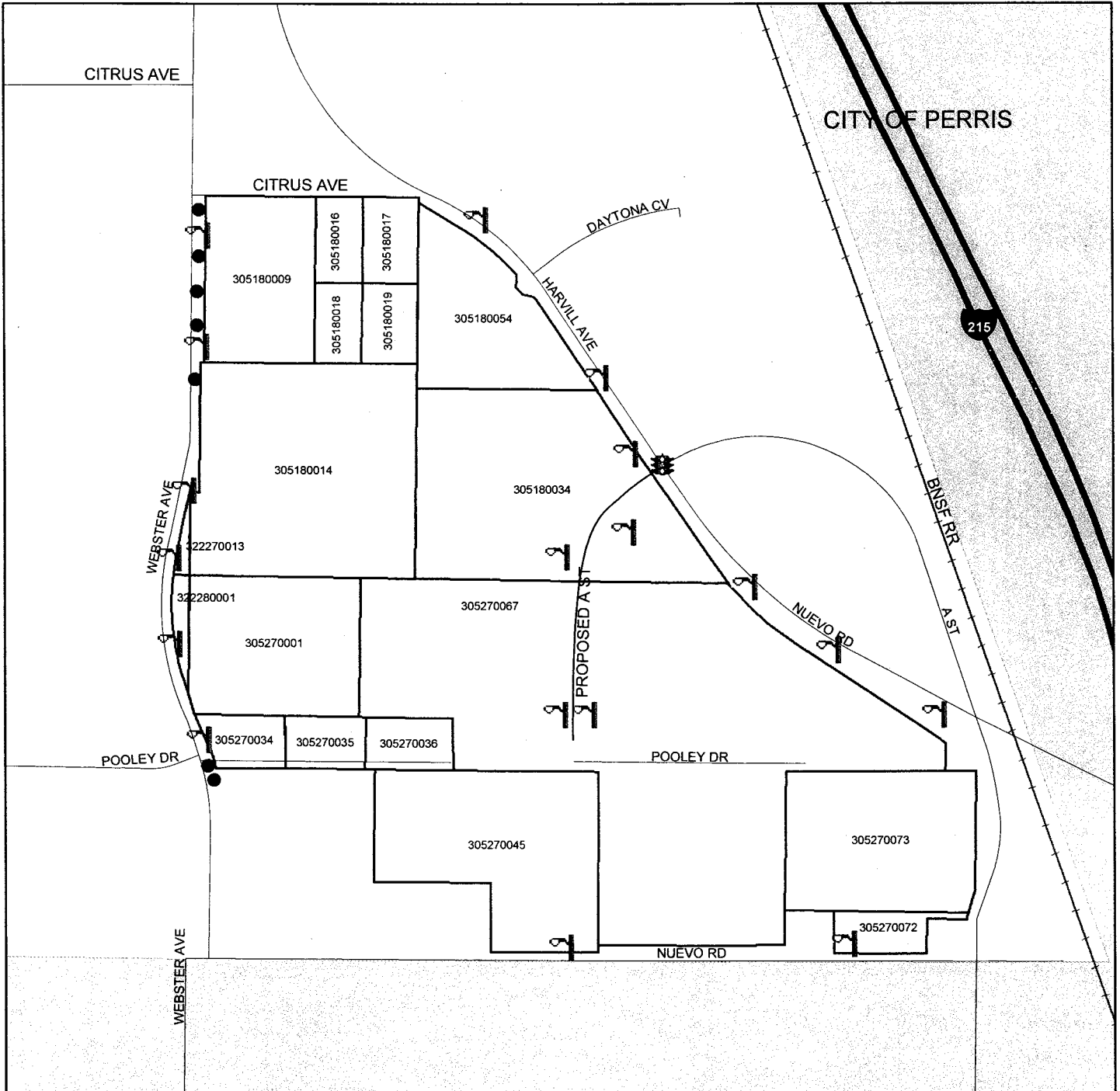

9 Section 22626 of the Streets and Highways Code, of the time and place of a public hearing on said
10 Report, the annexation of Zone 193, and the assessments to be levied on parcels within Zone 193
11 beginning in fiscal year 2015-16;

12 **NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED** by the
13 Board of Supervisors in regular session assembled on May 12, 2015 as follows:

14 **Section 1. Findings.** The Board of Supervisors, after reviewing the Report, finds that:

- 15 (a) The foregoing recitals are true and correct;
- 16 (b) The Report contains all matters required by Sections 22565 through 22574 of the
17 Streets and Highways Code and Section 4 of Article XIID and may, therefore, be
18 approved by the Board of Supervisors;
- 19 (c) The annual assessment for fiscal year 2015-16 on all parcels within Zone 193 will be
20 \$76 per acre.

21 **Section 2. Intent.** The Board of Supervisors hereby declares its intention to order the
22 annexation of Zone 193, as described and shown in Exhibit "A", to L&LMD No. 89-1-C, and to levy and
23 collect an annual assessment on all assessable lots and parcels of property within Zone 193
24 commencing with the fiscal year 2015-16 as set forth in the Report. The Report expressly states that
25 there are no parcels or lots within Zone 193 that are owned by a federal, state or other local
26 governmental agency that will benefit from the services to be financed by the annual assessments. The

1 annual assessments will be collected at the same time and in the same manner as property taxes are
2 collected, and all laws providing for the collection and enforcement of property taxes shall apply to the
3 collection and enforcement of said assessments.

4 **Section 3. Boundaries.** All the property within boundaries of Zone 193 is proposed to be
5 annexed to L&LMD No. 89-1-C and shall include that property in the unincorporated area of the County
6 as described and shown in Exhibit "A".

7 **Section 4. Description of Services to be Provided** . The services authorized for Zone 193
8 of L&LMD No. 89-1-C are:

- 9 (a) The maintenance and servicing of fossil filters within the public right-of-way including the
10 removal of petroleum hydrocarbons and other pollutants from water runoff; and
11 (b) Providing electricity to and the maintenance and servicing of
12 streetlights and traffic signals within the public right-of-way including incidental costs and
13 expenses.

14 **Section 5. Amount to be Levied.** The assessment to be levied upon each parcel that
15 benefits from the annexation of Zone 193 to L&LMD No. 89-1-C will be \$75 per acre for fiscal year
16 2015-16. As stated in the Report, the total budget for Zone 193 for the fiscal year 2015-16 is \$7,772.00;
17 there are 18 parcels that are to be assessed that aggregate to 92.15 acres. Each succeeding fiscal
18 year the special assessment may be subject to an annual adjustment that is the greater of two percent
19 (2%) or the cumulative percentage increase, if any, in the Consumer Price Index for all Urban
20 Consumers ("CPI-U") for the Los Angeles-Riverside-Orange County California Standard Metropolitan
21 Statistical area ("Index") published by the Bureau of Labor Statistics of the United States Department of
22 Labor. The annual CPI-U adjustment will be based on the cumulative increase, if any, in the "Index" as
23 it stands on March of each year over the base Index for March of 2015. Any increase larger than the
24 greater of 2% or the CPI-U annual adjustment requires a majority approval of all the property owners in
25 Zone 193. The Board of Supervisors will levy the assessment in each subsequent fiscal year until the
26 Board of Supervisors undertakes proceedings for the dissolution of Zone 193 of L&LMD No. 89-1-C.

1 The annual assessment will fund the services described in Section 4 of this Resolution. For further
2 particulars, reference is to be made to the Report on file in the Office of the Clerk of the Board of
3 Supervisors.

4 **Section 6. The Property to be Annexed.** The property to be annexed to L&LMD No.
5 89-1-C is Zone 193. The boundaries of Zone 193 are located within the unincorporated area of the
6 County and are described and shown in the Report and Exhibit "A".

7 **Section 7. Report.** The Report, which is on file with the Clerk of the Board of Supervisors
8 and which has been presented to the Board of Supervisors, is hereby approved. Reference is made to
9 the Report for a full and detailed description of the services, the boundaries of Zone 193, and the
10 annual assessment to be levied upon assessable lots and parcels within Zone 193 proposed to be
11 annexed to L&LMD No. 89-1-C.

12 **Section 8. Public Hearing.** The question of whether Zone 193 shall be annexed to L&LMD
13 No. 89-1-C and an annual assessment levied beginning with fiscal year 2015-16 shall be considered at
14 a public hearing (hereinafter the "Public Hearing") to be held on June 30, 2015, at 9:30 a.m. at the
15 meeting room of the Board of Supervisors of the County at 4080 Lemon Street, 1st Floor, Riverside,
16 California.

17 **Section 9. Majority Protest.** Each owner of record of property within Zone 193 is to receive
18 by mail an assessment ballot that shall conform to the requirements of Section 4 of Article XIID and
19 Section 4000 of the California Elections Code. The assessment ballots are to be returned prior to the
20 Public Hearing. The agency shall not impose an assessment if there is a majority protest. A majority
21 protest exists if, upon the conclusion of the hearing, ballots submitted in opposition to the assessment
22 exceed the ballots submitted in favor of the assessment. In tabulating the ballots, the ballots shall be
23 weighted according to the proportional financial obligation of the affected property.

24 **Section 10. Information.** Any property owner desiring additional information regarding
25 Zone 193 of L&LMD No. 89-1-C, the Report, or the proposed assessment is to contact Ms. Brigitte
26 Hahn, Senior Engineering Technician, Transportation Department of the County of Riverside, 4080

Lemon Street, 8th Floor, Riverside, California, 92501, or by telephone at 951-955-6263, or by e-mail at bhahn@rctlma.org.

Section 11. Notice of the Public Hearing. Notice of Public Hearing with regard to the annexation of Zone 193 to L&LMD No. 89-1-C shall be given consistent with Section 22626 of the Streets and Highways Code and Section 4 of Article XIID. The Clerk of the Board of Supervisors shall give notice of the Public Hearing by causing a certified copy of this Resolution to be published once in an appropriate newspaper at least ten (10) days prior to the date of the Public Hearing that is June 30, 2015. Publication of this Resolution is to be effected by the Clerk of the Board of Supervisors. Notice shall also be given by mailing first-class, postage prepaid, those notices, as prepared by County Counsel, assessment ballot and information sheets as required by Section 4 of Article XIID and Section 4000 of the California Elections Code to all owners of record of property within Zone 193 as shown on the last equalized assessment roll of the County. Mailing is to be made by the Engineer and deposited with the U. S. Post Office at least forty-five (45) days prior to the Public Hearing on June 30, 2015.

Section 12 Effective Date. This Resolution shall take effect from and after its date of adoption.



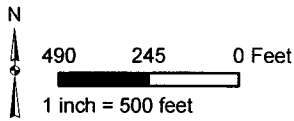

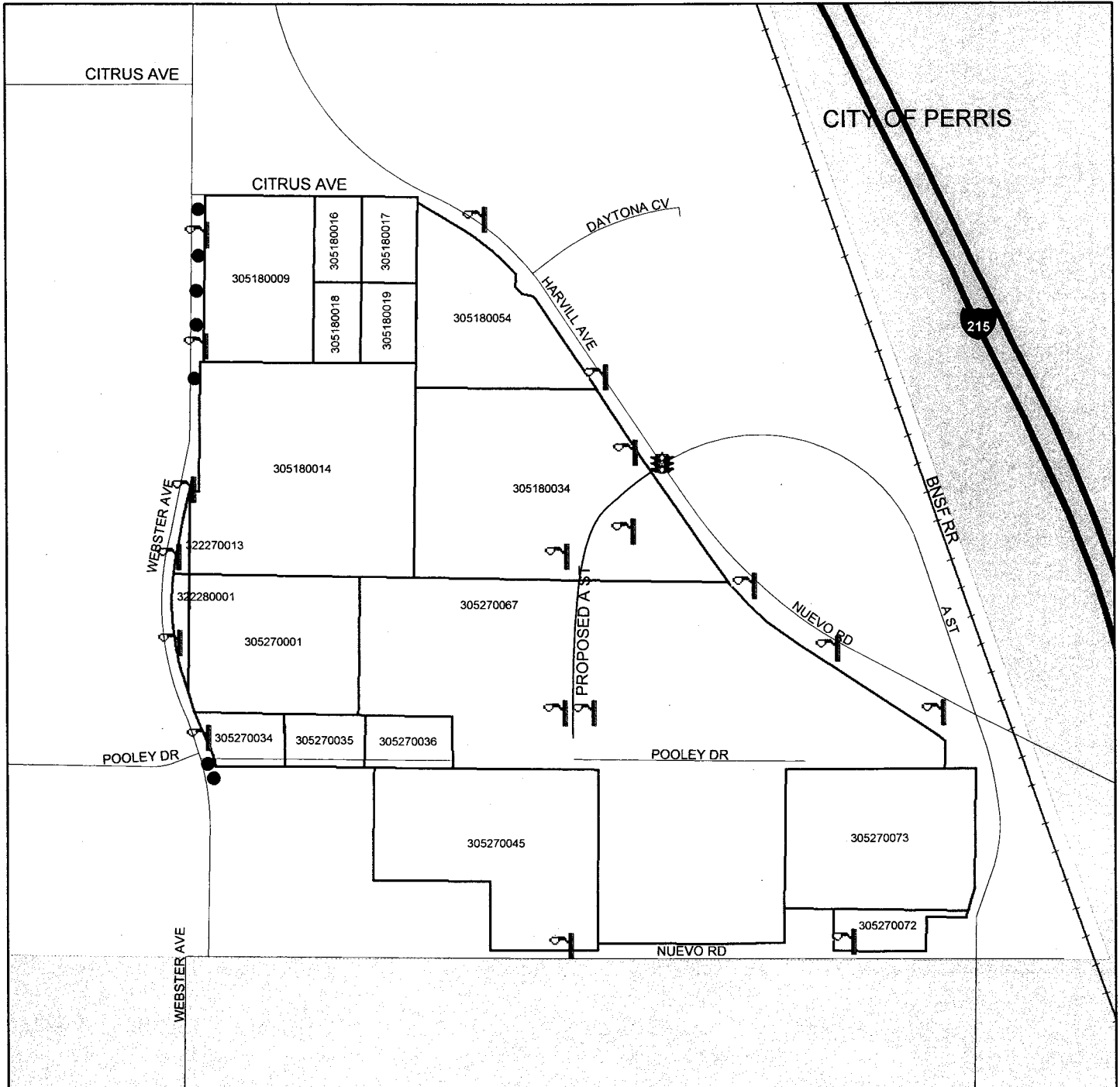

This Report provides for the annexation of Parcel Map 33530 / Plot Plan 23332 ("PM 33530/PP 23332") to Landscape & Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C") as Zone 193 ("Zone 193") and establishes the Maximum Assessment to be levied in the 2015–2016 Fiscal Year (from July 1, 2015 to June 30, 2016) and all subsequent fiscal years, for this area to be known and designated as:

EXECUTIVE SUMMARY

A. Introduction

Pursuant to the provisions of law, the costs and expenses of Zone 193 have been assessed upon the parcels of land in Zone 193 benefited thereby in direct proportion and relation to the estimated benefits to be received by each of said parcels. For particulars as to the identification of said parcel, reference is made to the Assessment Diagram, a reduced copy of which is included herein. WHEREAS, on this 12th of May, 2015 the Board of Supervisors of the County of Riverside ("Board"), State of California, ordering the preparation of the Engineer's Report ("Report") providing for the annexation of Parcel Map 33530 / Plot Plan 23332 ("PM 33530/PP 23332") to Landscape & Lighting Maintenance District No. 89-1-Consolidated ("L&LMD No. 89-1-C") as Zone 193 ("Zone 193"), pursuant to the provisions of the Landscaping and Lighting Act of 1972 ("1972 Act"), being Division 15 of the Streets and Highways Code of the State of California, did adopt Resolution No. 2015-066 for a special assessment district zone known and designated as:

Zone 193 PM 33530/PP 23332

The annexation of Zone 193 includes all parcels of land within the commercial development known as PM 33530/PP 23332, also identified by the following Assessor Parcel Number(s), which are valid as of the date of this Report:

As required by law, an Assessment Diagram is filed herewith, showing Zone 193, as well as the boundaries and dimensions of the respective parcels and subdivisions of land within said Zone 193 as the same exist, each of which subdivisions of land into lots or parcels, respectively, have been given a lot or parcel number and/or Assessor Parcel Number within a specific tract/parcel map and indicated on the Assessment Diagram and in the Assessment Roll contained herein. Psomas submits this Report, for the annexation of said Zone 193 and the establishment of the Maximum Assessment to be levied and collected commencing Fiscal Year 2015-2016 and all subsequent fiscal years, consisting of five parts.

PART I

Plans and Specifications: This section contains a description of Zone 193's boundaries and the proposed improvements within Zone 193. Zone 193 shall consist of a benefit zone encompassing all of the properties within the commercial development known as PM 33530/PP 23332.

The proposed improvements described in this Report are based on the current development and improvement plans provided to Psomas as of the date of this Report. Improvement plans ("Plans") include (1) Riverside County Transportation Department Conditions of Approval for Parcel Map 33530 and Plot Plan 23332; (2) Street Light Plans for Parcel Map 33530/Plot Plan 23332 I.P. No. 130041, approved by Riverside County Plan Check Oversight Engineer dated 5/30/2014; (3) Unapproved Riverside County Flood Control and Water Conservation District Storm Drain Plans IP No. 130041 by Thienes Engineering, Inc. with date drawn of March 2014, (4) Unapproved Parcel Map No. 33530, IP No. 130041 by Thienes Engineering, Inc. dated April 2013, and (5) Approved Tentative Parcel Map No. 33530R1 by Thienes Engineering, Inc. dated September 11, 2009

PART II

The Method of Apportionment: A narrative of the property benefits from the improvements and the method of calculating each property's proportional special benefit and annual assessment. The proposed Initial Maximum Assessment and assessment range formula established for Zone 193 is based on the Plans and estimated annual costs and expenses associated with all improvements to be accepted and maintained by Zone 193 at build-out. At build-out there will be 18 streetlights, one traffic signal and seven fossil filters to maintain and service. The Initial Maximum Assessment may be adjusted by the greater of two percent, the cumulative percentage increase in the Consumer Price Index for all Urban Consumers (CPI-U) for All Items, or the CPI-U for Electricity (as applicable) for the Los Angeles-Riverside-Orange County California Standard Metropolitan Statistical Area ("Index") published by the U.S. Department of Labor's Bureau of Labor Statistics (BLS), if any. The annual CPI-U for All Items or CPI-U for Electricity (as applicable) adjustment will be based on the cumulative increase, if any, in the Index as it stands in March of each year over the base Index of 2015. The Initial Maximum Assessment established within Zone 193 shall be \$7,722. Zone 193 includes 9 assessable lots or parcels and no non-assessable lots or parcels.

PART III

The Cost Estimate: An estimate of the cost of the streetlight, traffic signal and fossil filter maintenance including incidental costs and expenses in connection therewith for Fiscal Year 2015–2016, is as set forth on the lists thereof, attached hereto.

PART IV

Assessment Diagram: The Assessment Diagram shows the parcels of land included within the boundaries of Zone 193. For details concerning the lines and dimensions of the applicable Assessor's Parcel Numbers, refer to the County Assessor's Maps as of the date of this Report.

PART V

Assessment Roll: A listing of the Assessor's Parcel Numbers, and the initial Annual Assessment per lot or parcel to be applied on the tax roll for Fiscal Year 2015–2016.

B. Assessment Zone

The services to be provided by L&LMD No. 89-1-C Zone 193 generally includes local street lighting, a traffic signal and fossil filters. The annexation of PM 33530/PP 23332 to L&LMD No. 89-1-C as Zone 193 will provide the financial mechanism (annual assessments) by which the ongoing operation and maintenance of these services will be funded. Zone 193's structure, proposed services, method of apportionment and assessments described in this Report are based on the Plans provided to Psomas as of the date of this Report, including all estimated direct expenditures, incidental expenses, and reserves associated with the maintenance, energizing and servicing of the streetlights and traffic signal as well as the maintenance and servicing of the fossil filters as indicated in the Plans.

PART I – PLANS AND SPECIFICATIONS

A. Description of the Assessment Zone

Zone 193 is located within the unincorporated area known as Perris Valley in the County of Riverside, State of California and is comprised of PM 33530/PP 23332. The area for PM 33530/PP 23332 is generally located north of Nuevo Road, south of Citris Avenue, east of Webster Avenue, and west of Harvill Avenue. PM 33530/PP 23332 includes 9 assessable commercial lots or parcels and no non-assessable lots or parcels. Zone 193 consists of all subdivisions of land into lots or parcels located in the following development area(s):

B. Description of Improvements and Services For Landscape & Lighting Maintenance District No. 89-1-C

The following services were authorized pursuant to County of Riverside Board of Supervisors approved Resolution No. 94-389 for L&LMD No. 89-1-C:

- L&LMD No. 89-1-C will annually levy an assessment on property within its boundaries to pay the cost of the following services and improvements:
 - The installation and planting of landscaping, including trees, shrubs, grass and other ornamental vegetation;
 - The installation or construction of statuary, fountains and other ornamental structures and facilities;
 - The installation or construction of public lighting facilities including but not limited to, traffic signals;
 - The installation or construction of any facilities which are appurtenant to any of the foregoing, or which are necessary or convenient for the maintenance or servicing thereof, including, but not limited to, grading, clearing, removal of debris, the installation or construction of curbs, gutters, walls, sidewalks or paving, water irrigation, drainage or electrical facilities, and,
 - The maintenance or servicing, or both of any of the foregoing.

C. Description of Services for Landscape & Lighting Maintenance District No. 89-1-C Zone 193

The services to be funded by L&LMD No. 89-1-C Zone 193 include the maintenance and servicing of public lighting facilities, specifically streetlights and one traffic signal as well as seven fossil filters within the commercial development designated as PM 33530/PP 23332 on public rights-of-way known as:

- Webster Avenue
- Nuevo Road
- Harville Avenue
- A Street

PART II – METHOD OF APPORTIONMENT

A. Benefit Analysis

The proposed improvements, the associated costs, and assessments have been carefully reviewed, identified, and allocated based on special benefit.

Street lighting, traffic signals and fossil filters are the responsibility of L&LMD No. 89-1-C Zone 193.

The 1972 Act permits the establishment of assessment districts by agencies for the purpose of providing certain public improvements, which include the construction, maintenance, and servicing of public lights, landscaping, dedicated easements for landscape use, and appurtenant facilities. The 1972 Act further provides that assessments may be apportioned upon all assessable lot(s) or parcel(s) of land within an assessment district in proportion to the estimated benefits to be received by each lot or parcel from the improvements rather than assessed value.

"The net amount to be assessed upon lands within an assessment district may be apportioned by any formula or method which fairly distributes the net amount among all assessable lots or parcels in proportion to the estimated benefits to be received by each such lot or parcel from the improvements."

The formula used for calculating assessments reflects the composition of the parcels and the improvements and services provided by Zone 193 to fairly apportion the costs based on the estimated benefit to each parcel. Any lot or parcel that is dedicated to or used for right of way, easement or common area ("Exempt Property"), if any, within Zone 193 is specifically excluded from the apportionment calculation and are exempt from assessment.

In addition, Article XIII(D) of the California Constitution ("Article") requires that a parcel's assessment may not exceed the reasonable cost of the proportional special benefit conferred on that parcel. The Article provides that only special benefits are assessable, and the County must separate the general benefits from the special benefits conferred on a parcel. A special benefit is a particular and distinct benefit over and above general benefits conferred on the public at large, including real property within the district. The general enhancement of property value does not constitute a special benefit.

Special Benefit

The streetlight, traffic signal and fossil filter improvements within Zone 193 provide direct and special benefit to the lots or parcels within Zone 193. Therefore, the maintenance of these improvements also provides direct and special benefit by maintaining the functionality of the improvements and allowing the improvements to operate in a proper manner.

Each and every lot or parcel within the Zone 193, receives a particular and distinct benefit from the improvements over and above general benefits conferred by the improvements. First, the improvements were conditions of approval for the creation or development of the parcels. In order to create or develop the parcels, the County required the original developer to install streetlights, a traffic signal and fossil filters and to guarantee the maintenance of the streetlights, traffic signal and fossil filters and appurtenant facilities serving the lots or parcels. Therefore, each and every lot or parcel within the proposed Zone 193 could not have been developed in the absence of the installation and expected maintenance of these facilities.

In addition, the improvements continue to confer a particular and distinct special benefit upon parcels within Zone 193 because of the nature of the improvements. The proper maintenance of streetlights and the traffic signal specially benefit parcels within Zone 193 by improving neighborhood property protection, increased traffic safety by improving visibility, control and restriction of traffic into and out of the development by defining a specific path, and providing an enhanced quality of life and sense of well-being for properties within Zone 193. Streetlights also provide safety for pedestrians and motorists living and/or owning property in Zone 193 during the nighttime hours, and to assign rights-of-way for the safety of pedestrians and motorists by defining a specific path during all hours of the day.

Streets are constructed for the safe and convenient travel of vehicles and pedestrians. They also provide an area for underground and overhead utilities. These elements are a distinct and special benefit to all developed parcels in Zone 193. Streetlights are installed on and are for street purposes and are maintained and serviced to allow the street to perform to the standards it was designed.

Streetlights are determined to be an integral part of "streets" as a "permanent public improvement." One of the principal purposes of fixed roadway lighting is to create a nighttime environment conducive to quick, accurate, and comfortable seeing for the users as well as a sense of safe motoring and pedestrian experience of traffic egress and ingress into the facility. These factors, if attained, combine to improve traffic safety and achieve efficient traffic movement. Fixed lighting can enable the motorist to see detail more distinctly and to react safely toward roadway and traffic conditions present on or near the roadway facility.

The system of streets within Zone 193 is established to provide access to each parcel in Zone 193. Streetlights provide a safer street environment for owners of the parcels served. If the parcels were not subdivided to provide individual parcels to owners within Zone 193, there would be no need for a system of streets with streetlights. Therefore, the installation of streetlights is for the express, special benefit of the parcels within Zone 193.

The proper maintenance of the fossil filters specially benefit parcels within Zone 193 by improving water quality control.

Finally, the proper maintenance of streetlights, the traffic signal and fossil filters and appurtenant structures, provides an enhanced quality of life and sense of well-being for properties within Zone 193.

Based on the benefits described above, streetlights, the traffic signal and fossil filters are an integral part of the quality of life of Zone 193. This quality of life is a special benefit to those parcels with a commercial land use within Zone 193 and do not include government owned easements, utility easements, and flood channel parcels. Government-owned easement, utility easement and flood channel parcels do not benefit from the improvements due to their use and lack of habitation on such parcels. Parcels of this nature are usually vacant narrow strips of land or flood control channels and therefore do not generate or experience pedestrian or vehicular traffic. Nor do these types of parcels support dwelling units or other structures that would promote frequent use of the parcels by the traveling public. As a result of this lack of activity on such parcels they do not receive any benefit from streetlights, traffic signals or fossil filters and are not assessed.

Because the properties consist of varying lot or parcel sizes, some of which will not support independent commercial development unless combined with other parcels, and have limited accessibility, future changes in number and configuration of parcels is foreseen. The benefit of the services provided by Zone 193 by any parcel configuration would be proportional to the lot size. Therefore, the proportionate share of the costs and expenses for the maintenance and servicing of the streetlights, traffic signal and fossil filters are apportioned on a per acreage basis for all benefiting parcels within Zone 193.

SPECIAL BENEFITS OF LANDSCAPE & LIGHTING MAINTENANCE DISTRICT NO. 89-1-C STREET LIGHTING ZONE 193 AUTHORIZED SERVICES:

The special benefits of street lighting are the provision of energy, convenience, safety, security of property, improvements and goods. This includes the following:

- Enhanced deterrence of crime such as vandalism and other criminal activities which would reduce damage to improvements or property.
- Improved visibility to assist police in the protection of property.
- Increased nighttime safety on roads and streets by reducing nighttime accidents and personal property loss.
- Improved traffic circulation.
- Improved ability to see for pedestrians and motorists.
- Improved visibility for ingress and egress to the property.

The special benefits of traffic signals are the provision of traffic control and restriction, convenience, safety, security of property, improvements and goods. This includes the following:

- Increased daytime and nighttime safety on roads and streets by reducing accidents and personal property loss.
- Improved ability of pedestrians and motorists to drive and walk safely.

- Improved ingress and egress to the property.
- Improved traffic circulation.

The special benefits of fossil filters are the provision of improved water quality control.

General Benefit

The total benefit from the works of improvement is a combination of the special benefits to the parcels within Zone 193 and the general benefits to the public at large and to adjacent property owners. A portion of the total maintenance costs for streetlights, a traffic signal and fossil filters, if any, associated with general benefits will not be assessed to the parcels in Zone 193, but will be paid from other Riverside County Funds. Because the streetlights and fossil filter improvements are located immediately adjacent to properties within Zone 193 and are maintained solely for the benefit of the properties within Zone 193, any benefit received by properties outside of Zone 193 is nominal. Therefore, the general benefit portion of the benefit received from the streetlight and fossil filter improvements for Zone 193 is zero. However, the traffic signal improvement provides general and specific benefit to Zone 193. It has been determined that the costs and expenses for the traffic signal improvements for Zone 193 at the intersection of Harville Avenue and A Street are 15% of the County's total maintenance cost. The percentage was derived from the budget prepared by Riverside County Transportation Department. Therefore, only the costs directly related to the specific benefit of the traffic signal improvements will be assessed to Zone 193.

The benefits received by each parcel within Zone 193 would be proportional to the lot size. Therefore, the proportionate share of the costs and expenses for the maintenance and servicing of the streetlights, traffic signal and fossil filters are apportioned on a per acreage basis for all benefiting parcels within Zone 193.

B. Maximum Assessment Methodology

The following methodology was previously adopted by the Riverside County Board of Supervisors in the annual Engineer's Report approved on November 29, 1994. Such methodology has been maintained in preparation of this Report. The purpose of establishing a Maximum Assessment formula is to provide for reasonable increases and inflationary adjustments to annual assessments without requiring costly noticing and mailing procedures, which would add to Zone 193 costs and assessments.

The Maximum Assessment formula shall be applied to all Assessable Parcels of land within Zone 193. For Zone 193, the initial Maximum Assessments for Fiscal Year 2015–2016 are as follows:

- The initial Maximum Assessment established within Zone 193 shall be \$7,722.

The initial Maximum Assessment is subject to an annual inflator starting in Fiscal Year 2016–2017. The initial Maximum Assessment may be adjusted by the greater of two percent, the cumulative percentage increase in the CPI-U for All Items, or CPI-U for Electricity Index (as applicable) published by the BLS, if any. The annual CPI-U for All Items or CPI-U for Electricity (as applicable) adjustment will be based on the cumulative increase, if any, in the Index as it stands in March of each year over the base Index of 2015.

The Maximum Assessment is adjusted annually and is calculated independent of the Zone 193's annual budget and proposed annual assessment. The proposed annual assessment applied in any fiscal year is not considered to be an increased assessment if it is less than or equal to the Maximum Assessment amount. In no case shall the annual assessment exceed the Maximum Assessment.

The Maximum Assessment is designed to establish a reasonable limit on Zone 193 assessments. The Maximum Assessment calculated each year may require an increase to the annual assessment. However, the Initial Maximum Assessment per Acre may not increase except by escalation and, as parcel configuration changes occur, the assessment per parcel will adjust according to each parcel's acreage.

To impose an increased assessment, the County of Riverside must comply with the provisions of the Constitution Article XIII(D) (Section 4c), that requires a public hearing and certain protest procedures including mailed notice of the public hearing and property owner protest balloting. Through the balloting process, property owners must approve the proposed assessment increase. If the proposed assessment is approved, then a new Maximum Assessment is established for Zone 193. If the proposed assessment is not approved, the County may not levy an assessment greater than the adjusted Maximum Assessment previously established for Zone 193.

C. Annual Assessment

The Method of Apportionment of the Assessment is based upon the relative special benefit derived from the improvements and conferred upon the assessable real property within Zone 193 over and above general benefit conferred upon the assessable real property within Zone 193 or to the public at large. The benefits received by each parcel within Zone 193 would be proportional to the lot size. Therefore, the proportionate share of the costs and expenses for the maintenance and servicing of the streetlights, traffic signal and fossil filters are apportioned on a per acreage basis for all benefiting parcels within Zone 193. Any Exempt Property within Zone 193 is specifically excluded from the apportionment calculation and are exempt from assessment.

The Assessment per Assessable Parcel within Zone 193 is calculated by dividing the total Annual Balance to Levy by the Net Assessable Acres, the quotient of which is multiplied times the acreage of each parcel that is not Exempt. Total Zone 193 acres less Exempt Property acres, if any, equals Net Assessable Acres. The

Annual Balance to Levy is the Total Annual Street Lighting, Traffic Signal, and Fossil Filter Costs as seen in Part III – Cost Estimate.

The Assessment Rate per Acre is calculated as follows:

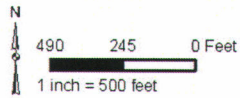

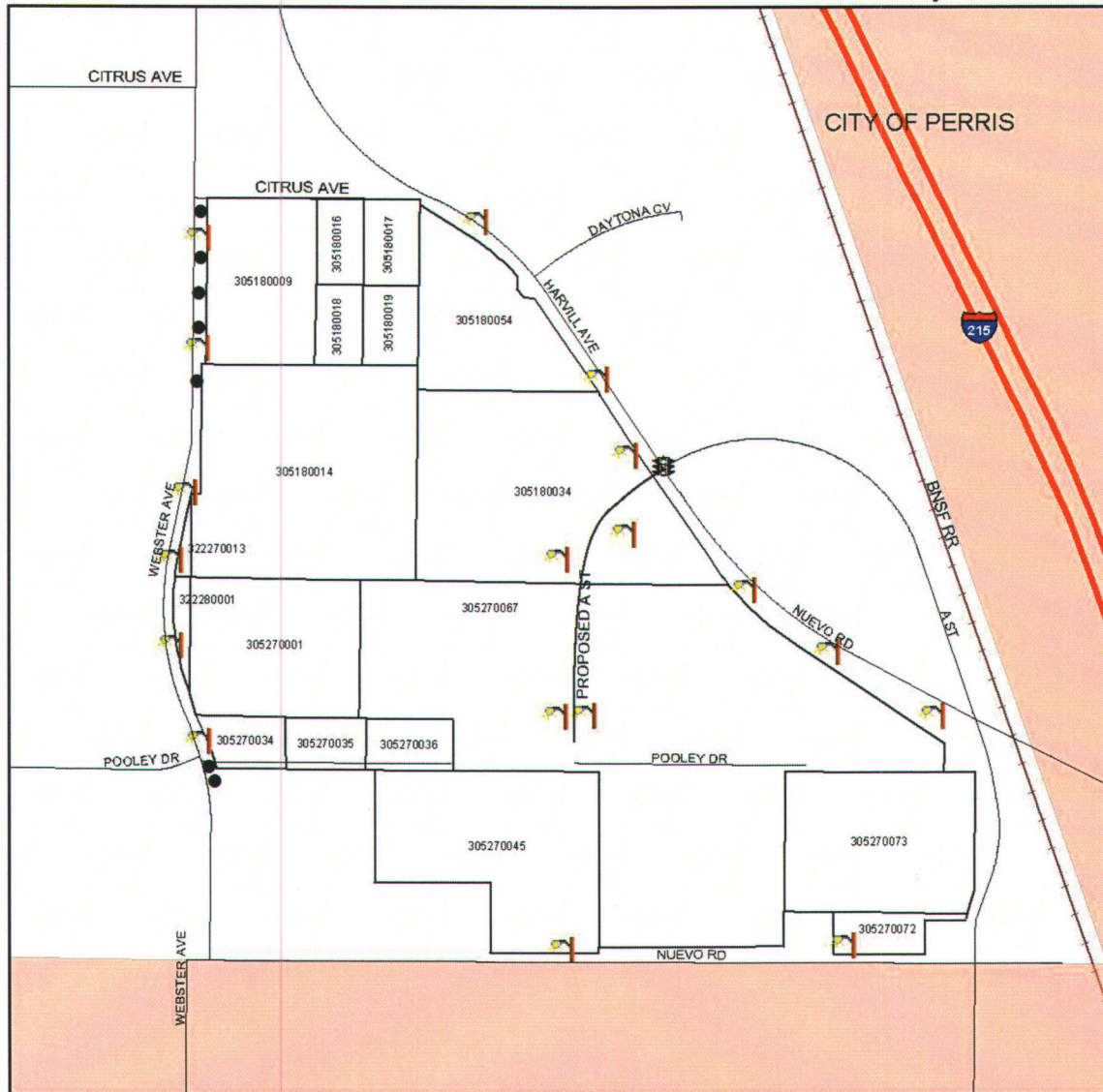

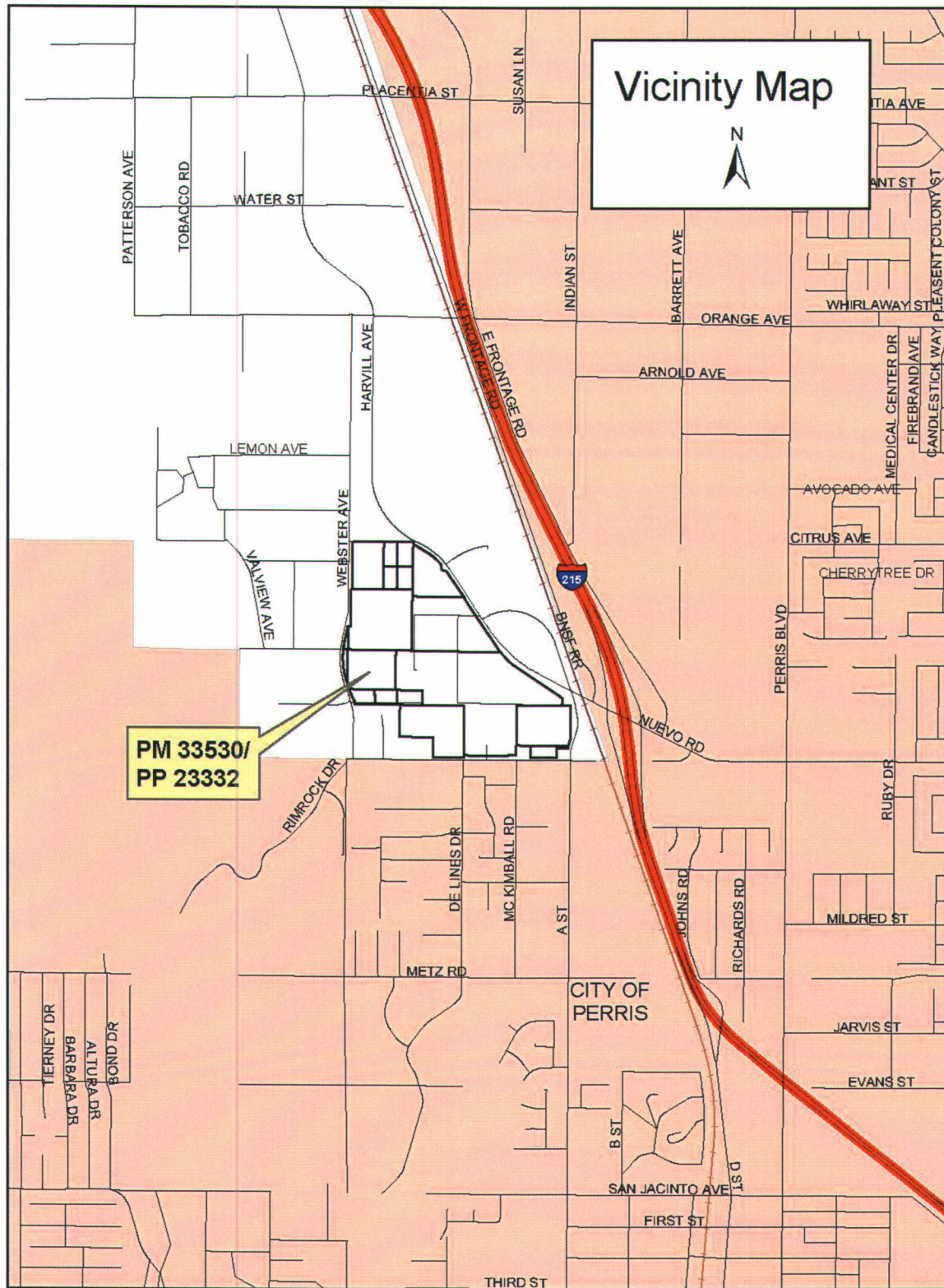

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF RIVERSIDE DECLARING ITS INTENT TO ORDER THE ANNEXATION OF ZONE 193 TO LANDSCAPING AND LIGHTING MAINTENANCE DISTRICT NO. 89-1-CONSOLIDATED OF THE COUNTY OF RIVERSIDE PURSUANT TO THE LANDSCAPING AND LIGHTING ACT OF 1972 FOR THE MAINTENANCE AND SERVICING OF FOSSIL FILTERS, STREETLIGHTS, AND TRAFFIC SIGNALS; ADOPTING THE PRELIMINARY ENGINEER'S REPORT; GIVING NOTICE OF AND SETTING THE TIME AND PLACE OF THE PUBLIC HEARING ON THE THE ANNEXATION OF ZONE 193 ; ORDERING AN ASSESSMENT PROCEEDING; ORDERING A MAILED BALLOT ELECTION; AND DIRECTING NOTICE OF THE PUBLIC HEARING AND THE ASSESSMENT BALLOT TO BE MAILED PURSUANT TO SAID ACT AND ARTICLE XIID OF THE CALIFORNIA CONSTITUTION AND SECTION 4000 OF THE ELECTIONS CODE

WHEREAS, the Board of Supervisors (hereinafter the "Board of Supervisors") of the County of Riverside (hereinafter the "County") has adopted Resolution No. 2015-066 on May 12, 2015 initiating proceedings for the annexation of Zone 193 (hereinafter "Zone 193"), as described and shown in Exhibit "A", which is attached hereto and incorporated herein, to Landscaping and Lighting Maintenance District No. 89-1-Consolidated of the County of Riverside, State of California, (hereinafter "L&LMD No. 89-1-C") pursuant to the Landscaping and Lighting Act of 1972 (hereinafter the "Act"), which is Part 2 (commencing with Section 22500) of Division 15 of the Streets and Highways Code (hereinafter the "Street and Highways Code"), and ordering the preparation of a report (hereinafter the "Report") regarding the proposed annexation of Zone 193 and the assessments to be levied within Zone 193 each fiscal year beginning fiscal year 2015-16 for the maintenance and servicing of fossil filters, streetlights, and traffic signals within the public right-of-way within said Zone; and

WHEREAS, such proceedings shall comply with the requirements of Article XIID of the California Constitution (hereinafter "Article XIID:"), the Act, and Section 4000 of the Elections Code requiring voter approval of the proposed assessment to be levied by L&LMD No. 89-1-C for Zone 193; and

WHEREAS, the Board of Supervisors by Resolution No. 2015-066 directed the Director of the Transportation Department, or his designee (hereinafter the "Engineer"), to prepare and file the Report with the Clerk of the Board of Supervisors in accordance with Sections 22608 and 22585 et. seq. of the Street and Highways Code and Section 4 of Article XIID; and

WHEREAS, said Engineer has filed the Report with the Clerk of the Board of Supervisors and the Report has been presented to and considered by the Board of Supervisors; and

WHEREAS, the Applicant has executed a "Waiver and Consent Regarding Date of Assessment Ballot Election" allowing for the election to be held on June 30, 2015; and

WHEREAS, it is necessary that the Board of Supervisors adopt a resolution of intention pursuant to Section 22624 of the Streets and Highways Code, which fixes and gives notice, pursuant to Section 22626 of the Streets and Highways Code, of the time and place of a public hearing on said Report, the annexation of Zone 193, and the assessments to be levied on parcels within Zone 193 beginning in fiscal year 2015-16;

NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED by the Board of Supervisors in regular session assembled on May 12, 2015 as follows:

Section 1. Findings. The Board of Supervisors, after reviewing the Report, finds that:

- (a) The foregoing recitals are true and correct;
- (b) The Report contains all matters required by Sections 22565 through 22574 of the Streets and Highways Code and Section 4 of Article XIID and may, therefore, be approved by the Board of Supervisors;
- (c) The annual assessment for fiscal year 2015-16 on all parcels within Zone 193 will be \$76 per acre.

Section 2. Intent. The Board of Supervisors hereby declares its intention to order the annexation of Zone 193, as described and shown in Exhibit "A", to L&LMD No. 89-1-C, and to levy and collect an annual assessment on all assessable lots and parcels of property within Zone 193 commencing with the fiscal year 2015-16 as set forth in the Report. The Report expressly states that there are no parcels or lots within Zone 193 that are owned by a federal, state or other local governmental agency that will benefit from the services to be financed by the annual assessments. The annual assessments will be collected at the same time and in the same manner as property taxes are collected, and all laws providing for the collection and enforcement of property taxes shall apply to the collection and enforcement of said assessments.

Section 3. Boundaries. All the property within boundaries of Zone 193 is proposed to be annexed to L&LMD No. 89-1-C and shall include that property in the unincorporated area of the County as described and shown in Exhibit "A".

Section 4. Description of Services to be Provided. The services authorized for Zone 193 of L&LMD No. 89-1-C are:

(a) The maintenance and servicing of fossil filters within the public right-of-way including the removal of petroleum hydrocarbons and other pollutants from water runoff; and

(b) Providing electricity to and the maintenance and servicing of streetlights and traffic signals within the public right-of-way including incidental costs and expenses.

Section 5. Amount to be Levied. The assessment to be levied upon each parcel that benefits from the annexation of Zone 193 to L&LMD No. 89-1-C will be \$75 per acre for fiscal year 2015-16. As stated in the Report, the total budget for Zone 193 for the fiscal year 2015-16 is \$7,772.00; there are 18 parcels that are to be assessed that aggregate to 92.15 acres. Each succeeding fiscal year the special assessment may be subject to an annual adjustment that is the greater of two percent (2%) or the cumulative percentage increase, if any, in the Consumer Price Index for all Urban Consumers ("CPI-U") for the Los Angeles-Riverside-Orange County California Standard Metropolitan Statistical area ("Index") published by the Bureau of Labor Statistics of the United States Department of Labor. The annual CPI-U adjustment will be based on the cumulative increase, if any, in the "Index" as it stands on March of each year over the base Index for March of 2015. Any increase larger than the greater of 2% or the CPI-U annual adjustment requires a majority approval of all the property owners in Zone 193. The Board of Supervisors will levy the assessment in each subsequent fiscal year until the Board of Supervisors undertakes proceedings for the dissolution of Zone 193 of L&LMD No. 89-1-C. The annual assessment will fund the services described in Section 4 of this Resolution. For further particulars, reference is to be made to the Report on file in the Office of the Clerk of the Board of Supervisors.

Section 6. The Property to be Annexed. The property to be annexed to L&LMD No. 89-1-C is Zone 193. The boundaries of Zone 193 are located within the unincorporated area of the County and are described and shown in the Report and Exhibit "A".

Section 7. Report. The Report, which is on file with the Clerk of the Board of Supervisors and which has been presented to the Board of Supervisors, is hereby approved. Reference is made to the Report for a full and detailed description of the services, the boundaries of Zone 193, and the annual assessment to be levied upon assessable lots and parcels within Zone 193 proposed to be annexed to L&LMD No. 89-1-C.

Section 8. Public Hearing. The question of whether Zone 193 shall be annexed to L&LMD No. 89-1-C and an annual assessment levied beginning with fiscal year 2015-16 shall be considered at a public hearing (hereinafter the "Public Hearing") to be held on June 30, 2015, at 9:30 a.m. at the meeting room of the Board of Supervisors of the County at 4080 Lemon Street, 1st Floor, Riverside, California.

Section 9. Majority Protest. Each owner of record of property within Zone 193 is to receive by mail an assessment ballot that shall conform to the requirements of Section 4 of Article XIID and Section 4000 of the California Elections Code. The assessment ballots are to be returned prior to the Public Hearing. The agency shall not impose an assessment if there is a majority protest. A majority protest exists if, upon the conclusion of the hearing, ballots submitted in opposition to the assessment exceed the ballots submitted in favor of the assessment. In tabulating the ballots, the ballots shall be weighted according to the proportional financial obligation of the affected property.

Section 10. Information. Any property owner desiring additional information regarding Zone 193 of L&LMD No. 89-1-C, the Report, or the proposed assessment is to contact Ms. Brigitte Hahn, Senior Engineering Technician, Transportation Department of the County of Riverside, 4080 Lemon Street, 8th Floor, Riverside, California, 92501, or by telephone at 951-955-6263, or by e-mail at bhahn@rctlma.org.

Section 11. Notice of the Public Hearing. Notice of Public Hearing with regard to the annexation of Zone 193 to L&LMD No. 89-1-C shall be given consistent with Section 22626 of the Streets

and Highways Code and Section 4 of Article XIID. The Clerk of the Board of Supervisors shall give notice of the Public Hearing by causing a certified copy of this Resolution to be published once in an appropriate newspaper at least ten (10) days prior to the date of the Public Hearing that is June 30, 2015. Publication of this Resolution is to be effected by the Clerk of the Board of Supervisors. Notice shall also be given by mailing first-class, postage prepaid, those notices, as prepared by County Counsel, assessment ballot and information sheets as required by Section 4 of Article XIID and Section 4000 of the California Elections Code to all owners of record of property within Zone 193 as shown on the last equalized assessment roll of the County. Mailing is to be made by the Engineer and deposited with the U. S. Post Office at least forty-five (45) days prior to the Public Hearing on June 30, 2015.

Section 12 **Effective Date.** This Resolution shall take effect from and after its date of adoption.

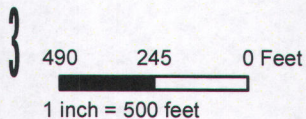

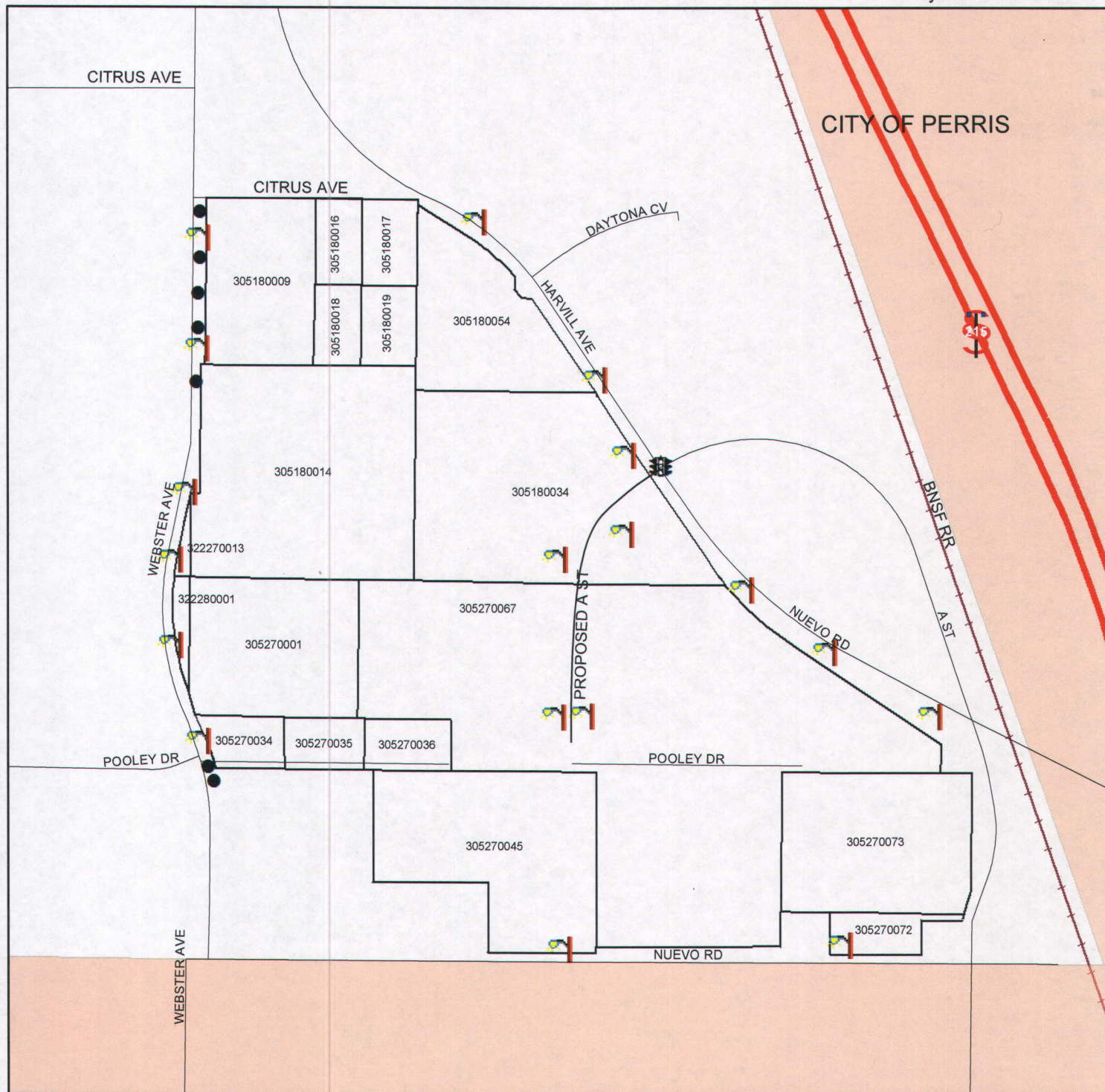
