BACKGROUND:

Summary

The Board approved a contract with H & H General Contractors, Inc. in the amount of \$6,999,014 as Agenda Item Number 11-11 on December 17, 2013. The total payment of the contract is \$7,289,877. This includes the change order due to flooding that occurred during construction, additional paving of Midway Street, additional work for EMWD, additional Traffic Control and overages due to quantity adjustments. The sum total represents a cost increase of 4.15% over the original contract amount and is less than the 10% project contingency. The District does not anticipate any claims for additional compensation from the Contractor.

BACKGROUND:

Summary (continued)

Final inspection of the above referenced project was made, and the project was found to be complete according to plans and specifications. A brief project description and location map are attached.

Impact on Residents and Businesses

The District constructed a segment of drainage infrastructure described in the District's San Jacinto Master Drainage Plan, which remedies the ongoing flooding problems at the intersections of San Jacinto Avenue and Menlo Avenue, San Jacinto Avenue and Midway Street, and Santa Fe Street and Midway Street. Consequently, the removal of ponding water at these intersections during storm events improves traffic and pedestrian safety and public access to the businesses along San Jacinto and Menlo Avenues. The District partnered with the City of San Jacinto to further improve normal residential traffic safety by replacing and reconstructing Midway Street between San Jacinto Avenue and Santa Fe Street.



SAN JACINTO MDP LINE C STAGE 2, LINES C-4, C-5 & B PROJECT NO. 4-0-0124



San Jacinto MDP Line C, Stage 2, Lines C-4, C-5, and B involves the construction of reinforced concrete box and reinforced concrete pipe within the cities of Hemet and San Jacinto. The reinforced concrete box ties into the upstream terminus of the District's existing Line C, Stage 1 facility and extends south 2,800' in an undeveloped field. The box then extends southeast for 800' before extending east along Midway Street for 630' prior to transitioning to a reinforced concrete pipe. The pipe extends 650' east along Midway Street, and then extends 2,000' south along San Jacinto Street before extending east and terminating 200' along Menlo Avenue. Lateral Line C-4 extends 260' south along Santa Fe Street from the mainline junction at the Midway Street intersection. Lateral Line C-5 extends 670' east in the undeveloped field to Santa Fe Street from the mainline junction located 1,615' from the upstream terminus of Line C, Stage 1.
