When he retired in 1989, the city council proclaimed it "Jim Wheaton Day" in recognition of his accomplishments and years of service.



His first radio news job was in Janesville, Wisconsin, followed by a "newsman" position at WREX-TV in Rockford, Illinois. He moved up to become News Director at WAAP in Peoria and then relocated to Riverside, California to be News Director of KPRO.

While living in Riverside, Bob broadcast RCC basketball, every race at Riverside International Raceway, the early years of racing at the Ontario Motor Speedway, and the Long Beach Grand Prix. Most of his career was spent as a newsman at KMPC in Hollywood working for Gene Autry. He garnered ten Golden Mike awards, broadcast UCLA football and basketball games and, as KMPC's Washington correspondent, traveled with President Ford on his trip behind the Iron Curtain to the Helsinki Accord. He also wrote a weekly column for the Riverside County Record for over 20 years and voiced his column on InlandNewsToday.com for the past three years. For his achievements in sports broadcasting, he has been inducted into the Riverside Sports Hall Fame.



Eventually, he created Venture Communications with a partner building and then selling small cable systems in California, Arizona, and Nevada.

Born on January 10, 1924 in Wausau, Wisconsin, Richard was a Veteran of World War II, the Korean War, and the Vietnam War and served his country with pride and distinction for twenty-seven years. After graduating from high school in 1942, he enlisted in the U.S. Navy during World War II and was shipped to Great Lakes Naval Training Center in Chicago for basic training. He was assigned to the USS Omaha, which he picked up in Bahia, Brazil and served in the Atlantic and Mediterranean until the end of the war.

Deciding to make the Navy his career following World War II, Richard served aboard the Ozette I and then was stationed for shore duty at the Chicago Great Lakes Naval Station and the Philadelphia Naval Station before being assigned to the USS Valley Forge during the Korean War.
