

Summary

In October 2014, RUMC Pharmacy began a pharmacist managed and staffed Hepatitis C clinic that has proved to be both beneficial to patients and profitable to the hospital. BACKGROUND:

Summary (continued)

Treatment of Hepatitis C using newly released drugs. We also accept patients who have Medi-Cal and Molina coverage. These new drugs show great promise in eradicating the virus but are quite costly. The course of therapy is between 8 and 20 weeks and usually results in no detectable virus.

Because of the program's success, it has grown faster than was expected when this year's budget was submitted to the Board.

We now project that the cost from November 2014 thru the end of this fiscal year will be approximately \$7 million. This additional cost is covered by the \$8.7 million in new revenue that will be received for the program.

We, therefore, request that \$7 million be added to cover the costs of the Hepatitis C program, along with the new revenues that will be generated.

Of additional concern is the hospital's nurse registry budget. Nurse registry costs were \$10.3 million last year and will be reduced to \$7.6 million, a decrease of more than 25 percent this year. While these are excellent results, the original FY14/15 budget of \$5.1 million has turned out to be too aggressive. There will be additional patient revenue to compensate for this additional cost.

We, therefore, request that \$2.5 million be added to cover the additional nurse registry expenditures, along with the additional patient revenues that will offset the cost.

Impact on Citizens and Businesses

This service impacts the patients residing in Riverside County receiving care from Riverside University Medical Center. The requested adjustments allow the hospital to continue to provide essential services with no negative impact on the budget.
