On motion of Supervisor Tavaglione, seconded by Supervisor Ashley, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, July 7, 2015, be adjourned in memory of Wayne C. Keith, a 92-year-old resident of Corona, California who passed away on June 28, 2015.

Born on September 8, 1922 in Traer, Iowa, Wayne graduated from Iowa State University with a degree in mechanical engineering and worked for NASA before going to Alcoa. He moved throughout the company with stops in Cleveland, Detroit, and Pittsburgh before coming to Corona in 1968. He was influential in developing and then convincing General Motors that aluminum alloys were cost effective and a safe alternative to the steel wheels being used on large trucks and other vehicles. He also wrote on the subject of aluminum and was the co-holder of a patent for stair treads. Relocating to Corona as General Manager of Alcoa's premium casting division, he oversaw construction of the plant and went on to establish additional operations in El Paso, Texas, and Paris, France.

An instrumental force in the industry and community, Wayne was a member of the Corona Rotary Club, Corona-Norco United Way, Good Samaritan Boys Home, First Congregational Church, Navy League, Peppermint Ridge, Corona-Norco Family YMCA, Corona Chamber of Commerce, Corona Community Hospital, Corona-Norco Unified School District, City of Corona, Good Samaritan, California Manufacturer's Association, Riverside Community College Foundation, Boys Club, and the Wagner. He also served on numerous boards, including Western Municipal Water District, United Way, and Navy League. He was named Corona's Citizen of the Year in 1976, and in 2003 received the Ira D. Calvert Award from the Chamber of Commerce. In 2013, he was honored with the Lifetime Achievement Award from Peppermint Ridge, and in 2015 the Lifetime Achievement Award from the Chamber of Commerce.

Wayne was a loving and devoted husband, father, grandfather, great-grandfather, and friend whose memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be greatly missed, but never forgotten.

The 2013 biopic also received a Golden Globe Award for Best Picture.

Before his success with movies, Jerry spent more than 20 years promoting concerts for some of the top musical acts in the world, including Elvis Presley and Frank Sinatra. He also worked with Bob Dylan, Neil Diamond, John Denver, and The Carpenters.

An instrumental force in the community, Jerry had a home in Bighorn, Palm Desert and spent a lot of time in the Coachella Valley. He served on Eisenhower Medical Center's Board of Directors in Rancho Mirage and supported many other charities.

Born on January 21, 1930 in Utopia, Texas, Ben's family moved to California when he was nine years old. His successful newspaper career began as a news hawker selling papers on Main Street and then at the age of 12, advanced to delivery carrier. He worked his way up to Assistant Circulation Manager of the Imperial Valley Press and Circulation Manager of the Brawley News. Since his heart was in the mechanics of production, he became an expert typesetter, machinist, and Master Printer, working at various papers from Brawley to Northern California to Alaska.

In 1960, Ben was recruited by Publisher Carl Schooss to work as Production Director in Palm Springs, where The Desert Sun was located in a small shopping center on Indian Avenue. To meet demands of the growing newspaper, he was instrumental in developing and carrying out equipment and construction plans for moving the operation to a new facility in Sun Center. After several years, he convinced the publisher and owner Leonard Firestone to convert the operation from "hot metal" to the coming computer and offset printing processes, lobbying for new equipment and presses in a larger facility to handle the growth of The Desert Sun. Eventually, he worked with the new owner Gannett Corp. in planning and building The Desert Sun's facilities on Gene Autry Trail.
