**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Ratify and authorize the Chairman to execute the Sixth Amendment with Hanger Prosthetics and Orthotics, Inc. effective July 1, 2015 on a month to month basis not to exceed a total amount of \$150,000 through December 31, 2015; and
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to sign amendments that do not change the substantive terms of the agreement and authorize the Purchasing Agent to increase the compensation amount not more than ten percent, as approved by County Counsel.

**BACKGROUND**

**Summary:**

Riverside County Regional Medical Center (RCRMC) surgeons require a contractor to provide orthotic and prosthetic patient care services with trained and experienced critical care service provider.

**BACKGROUND:**

**Summary**

Hanger Prosthetics and Orthotics, Inc. has provided services since 2010. As the hospital and its clinic(s) continue to develop and expand, considerable demand for prosthetic and orthotic services is needed. The professional services contract with Hanger Prosthetics and Orthotics, Inc. ends June 30, 2015 with no additional renewal options remaining. This extension amendment will aid in continuing the medical services until a new awarded vendor is determined as a result of a Request for Proposal (RFP) / bidding process is complete.

**Impact on Citizens and Businesses**

This service impacts the patients in Riverside County receiving care from Riverside County Regional Medical Center.

**Contract History and Price Reasonableness**

On August 10, 2010, agenda item number 3.54, the Board approved the Professional Services Agreement with Hanger for \$180,000 annually and on July 26, 2011, agenda item number 3.59, the Board approved to increase the aggregate amount to \$230,000 annually as the Low Income Health Program (LIHP) developed and help to treat additional patients eligible for the program.

Hanger's fee schedule will remain the same with this amendment, equivalent to Medi-Cal rates for the procedures billed.

**SIXTH AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT**

**WITH**

**HANGER PROSTHETICS & ORTHOTICS, INC.**  
(Prosthetic & Orthotic Services)

That certain Agreement between Riverside County Regional Medical Center ("COUNTY") and **Hanger Prosthetics & Orthotics, Inc.**, ("CONTRACTOR"), initially approved August 10, 2010, Agenda Item No. 3.54, first amendment approved July 26, 2011, second amendment approved December 6, 2011, third amendment approved June 8, 2012, fourth amendment approved May 20, 2013, and fifth amendment approved May 14, 2014, is hereby amended as follows:

1. Delete Section 3.0 Period of Performance, and replace with the following:

"This Amendment extends the period of the Agreement effective July 1, 2015 and shall continue month-to-month not to exceed December 31, 2015 or unless terminated as otherwise provided herein."

2. Delete Section 4.4 and replace with the following:

"Maximum payments by COUNTY to CONTRACTOR shall not exceed the aggregate amount of one hundred fifty thousand dollars (\$150,000) for the period between July 1, 2105 through December 31, 2015. The COUNTY is not responsible for any fees or costs incurred above or beyond the contracted amount and shall have no obligation to purchase any specified amount of services or products. COUNTY shall not be responsible for payment of any of CONTRACTOR's expense related to this agreement"


3. All other terms and conditions of this Agreement are to remain unchanged.


