
1. Approves the use of Community Improvement Designation funds for the United Way of the Desert and Feeding America Riverside San Bernardino.

BACKGROUND:

Summary

1. United Way of the Desert is sponsoring nine weekly walks and a workplace wellness program starting on August 22, 2015 and continuing through October 24, 2015. This is a no-cost community health program designed to encourage healthy habits and lifestyles for families and residents in the Coachella Valley. The weekly walks will take place in Desert Hot Springs; Cathedral City; Indio; Palm Springs; Coachella; La Quinta; Indian Wells; Rancho Mirage and Palm Desert. In addition, United Way of the Desert is engaging business partners through a workplace wellness challenge to coincide with the nine weekly walks. The CID funds will be used for supplies and materials such as water and food and for printing expenses.
2. Feeding America Riverside San Bernardino is supporting the Drought Food Assistance Program (DFAP). DFAP is a temporary food assistance program created by the State and developed in response to the Drought Emergency Declaration. Feeding America RSB will be handing out boxes of food at the Riverside County Fairgrounds in Indio on July 25 and in August and September 2015 to Coachella Valley residents. This temporary program is available to the underserved residents of Coachella Valley at no-cost. The CID funds will be used for the rental cost of the county fairgrounds.
