BACKGROUND:

Summary (continued)

Riverside County Ordinance 695.4 established an on-going program to abate hazardous vegetation, while at the same time, protecting rare and sensitive plant and animal species and the environment. The purpose of the Hazard Reduction program is to reduce or eliminate fire hazards created by vegetative growth and the accumulation of combustible debris, which poses a danger to the health, safety and welfare of the residents in the vicinity of any real property. Fire Prevention Technicians annually inspect unimproved parcels within the unincorporated areas of the County of Riverside, as defined by Riverside County Ordinance 695.4. Once all inspections were completed, an "Order to Abate" was sent to each owner of record. The order advised the parcel owner of their obligation to have the parcel in compliance within thirty days from the date of notice. Upon re-inspection, the Riverside County Hazard Reduction program turned over any parcel, found to be non-compliant, to the County Contractors for abatement. At the conclusion of the abatement, a bill was issued to the parcel owner of record. If not paid, then the county has the ability to recover abatement costs by assessing real property. This assessment incorporates the contractor's costs and the County administrative fee of \$254.00. The properties that are subject to this assessment are attached as Attachment "A" to the resolution. At the close of the public hearing on July 21, 2015 the Board of Supervisors would adopt this resolution and confirm the special assessments for the cost of abating hazardous weeds.

Impact on Citizens and Businesses

The hazard reduction program is designed to protect life, property and the environment. Voluntary compliance is the primary goal for the program. The owner of record, for each parcel, is provided the opportunity to abate the property prior to the county conducting the abatement. The owner also has an opportunity to reimburse the county the cost of abatement prior to the lien process being initiated. The adoption of Resolution 2015-094 in the public hearing on July 21, 2015 of the list of those parcels not in compliance and subject to the abatement fee is the final step required under the Health and Safety Code Section 14910 and County Ordinance 695.4 to establish assessments and liens on those parcels.

SUPPLEMENTAL:

Additional Fiscal Information

The abatement charges for any work performed by the contractor and the county administrative fee will be included in the property owner's property tax statement as a special assessment. The Board of Supervisors approved the administrative fee of \$254.00 by Resolution No. 2011-080 with a public hearing on June 28, 2011. The fee has not increased since 2011. The current total parcels are 444 and the total amount to be assessed is \$179,486. The assessments will reimburse the department costs, which are funded by the General Fund.

10 WHEREAS, Health & Safety Code Section 14875 et seq. provides for
11 the abatement and removal of hazardous weeds; and

12 WHEREAS, Riverside County in Ordinance No. 695.4 has established
13 a methodology for the removal of hazardous weeds in various areas of
14 the unincorporated portions of western Riverside County; and

15 WHEREAS, Section 6A of Ordinance No. 695.4 provides for the
16 mailing of individual notices to the owners of such parcels advising
17 them of their obligation to remove the weeds on such lands or be
18 charged for the costs of such removal when the work is done by the
19 County or by a contractor hired by the County; and

20 WHEREAS, such property owners have had the opportunity to object
21 through filing a written request, within fifteen calendar days of the
22 postmark on the Notice to Abate, as stated in the appeals procedure
23 established in Section 6C of Ordinance No. 695.4; and

24 WHEREAS, on those parcels, where the removal was not carried out
25 by the owners, the County, acting through various contractors, has now
26 carried out the removal work required; and

27 WHEREAS, the charges placed upon the parcels is the cost of
removal where the work was not carried out by the owners and is not a
charge based upon the value of the parcels; and

WHEREAS, pursuant to Section 6F of Ordinance No. 695.4 the Fire
Department shall render to the Property Owner an invoice demanding

1 payment within 15 days covering the costs of the work necessary for
2 such abatement; and

3 WHEREAS, the billing for those parcels listed on the
4 attached Exhibit "A" remain unpaid; now, therefore;

5 BE IT RESOLVED AND ORDERED by the Board of Supervisors of the
6 County of Riverside, State of California, in regular session assembled
7 on 7/21/15, that the list of parcels and costs of abatement for
8 removal of hazardous weeds for each parcel as shown on Exhibit "A" are
9 hereby confirmed and that henceforth said costs shall constitute
10 special assessments against the respective parcels of land, and are
11 liens on said lands in the amounts of the respective assessments.

12 BE IT FURTHER RESOLVED AND ORDERED that a copy of this Resolution
13 shall be transmitted on August 13, 2015 to the Auditor-Controller of
14 Riverside County who shall enter the amounts of the respective
15 assessments against the respective parcels of land as they appear on
16 the current assessment roll. Said assessments shall be collected at
17 the same time in the same manner as ordinary municipal ad valorem
18 taxes as provided by Section 6G of Ordinance No. 695.4.

BACKGROUND:

Summary (continued)

Riverside County Ordinance 695.4 established an on-going program to abate hazardous vegetation. The purpose of the hazard reduction program is to prevent fire hazards created by vegetative growth and the accumulation of combustible debris. Fire Prevention Technicians annually inspect unimproved parcels within the unincorporated areas of the County of Riverside, as defined by and adhering to Riverside County Ordinance 695.4.

Once an inspection is completed, a "Notice to Abate" is sent to each owner of record. The notice advises them of their obligation to comply within thirty days from the date of notice. If the property is not abated, then the county abates the property using abatement contractors. At the conclusion of the abatement, a bill is issued to the parcel owner of record to reimburse the county for the expense of abatement along with an administrative fee of \$254. The administrative fee was approved by the Board of Supervisors by Resolution No. 2011-080 with a public hearing on June 28, 2011. If not paid, then the county has the ability to recover abatement costs by assessing real property. The county is then able to recover costs through the property tax process. This assessment incorporates the contractor's costs and the administrative fee.

The properties that are subject to this assessment are attached as Exhibit A to the resolution. The resolution and exhibit will also be included in the the presentation for the public hearing on July 21, 2015. The adoption of Resolution 2015-094 in the public hearing on July 21, 2015 of the list of those parcels not in compliance and subject to the abatement fee is the final step required under the Health and Safety Code Section 14910 and County Ordinance 695.4 to establish assessments and liens on those parcels.

Impact on Citizens and Businesses

The hazard reduction program is designed to protect life, property and the environment. Voluntary compliance is the primary goal for the program. Each parcels owner of record is provided the opportunity to abate the property prior to the county conducting the abatement. The owner also has an opportunity to reimburse the county the cost of abatement prior to the lien process being initiated.

SUPPLEMENTAL:

Additional Fiscal Information

The abatement charges for any work performed by the contractor and the county administrative fee will be included in the property owner's property tax statement as a special assessment. The administrative fee was approved by the Board of Supervisors by Resolution No. 2011-080 with a public hearing on June 28, 2011. The current total parcels are 444 and the total amount to be assessed is \$179,486. The assessments will reimburse the department costs, which are funded by the General Fund.
