Accomplishments for 2014/15

- Women of the Year – On April 14, 2015, five amazing women were honored for working to bring about social and economic change, promote women's equality, serve as an outstanding role model to women and girls, work on behalf of women's issues or provide outstanding performance within a profession to further advocate for women's rights and improve the status of women in Riverside County. Each woman selflessly dedicates her time to improving our County.
- Young Lady of the Year – For the second time, the Commission honored young ladies, representing each of the districts, who serve as role models to girls and worked to improve the status of girls in the County.
- On October 17, 2014, Commissioners Martin, Rundle, and Liaison Sayles volunteered at the V.A.L.O.R. Stand Down event on behalf of the Commission.
- July 23- 26, 2014, Commissioners Mazingo and Martin attended the National Association of Commissions for Women conference in Florida.
- Support of Amelia's Light – For the third year, commissioners came together during the holidays to help support the families at Amelia's Light, a transitional shelter for women and children on the March Air Reserve Base.
- The Commissioners participated in Operation Safehouse "Stuff the Bus" event on November 5, 2014. "Stuff the Bus" is sponsored by Operation SafeHouse and provides emergency shelter, intervention, and outreach services to run away, homeless, and other youth in crisis in Riverside County. When the bus stopped at the County Administrative Center, Commissioners helped to fill the bus.
- Commissioners Then, McGensy, and Spiegel participated in the planning for the Women's Leadership Program Annual Conference set for September 2015.
- Women's Policy Summit Attendance – A representative from the Commission attended the Women's Policy Summit in January obtaining information on the current status of women in California. Many important topics were discussed.
- The Riverside County Commission for Women's Facebook received a facelift with a new name, RiversideCounty Commissionfor Women.

- Shondi Lee, Riverside County Educational Support Program, presented various working styles and assessment analysis at the August 2014 meeting. The MBTI Assessment Analysis was given and results were summarized.
- Eliza Daniely - Woolfolk, Chief Executive Officer, Riverside County Coalition Against Domestic Violence presented on the topic of Domestic Violence and Trends at the September 2014 meeting.
- Erin Whitt, Inland Empire Program Coordinator, Safe Families for Children, Olive Crest presented information and statistics for the non-profit organization offering an innovative collaboration between area churches, volunteers, and child care professionals designed to support at-risk children and parents in crisis and who need a safe place.

- Kayla Romero, District I Supervisor Jeffries Youth Council Coordinator, and Trish Field, Riverside County EDA Program Coordinator for the Board of Supervisors Intern Program presented an update regarding the annual activities of the Riverside County Youth Advisory Councils to the Commission at the January 22, 2015 meeting.
- On March 26, 2015, Lisa Marie Dryan, Coordinator Inland Empire Perinatal Mental Health Collaborative and Director of Mental Health at the Wylie Center gave a presentation on the upcoming Women and Children's Mental Health 2015 Legislative Breakfast that was held on May 22, 2015.
- At the April 23, 2015 meeting, Fabio Duarte, Systems Administrator, Riverside County Technology Department, presented information on website solutions.
- Det. Roberta Hopewell, City of Riverside Police Department, spoke before the Commission on May 28, 2015 on the topic of backlogged rape cases and processing rape kite. With new procedures in place, the department has been able to review approximately 200 backlogged cases.
