**BACKGROUND:**

**Summary**

On February 26, 2013, The Board of Supervisors approved the professional services agreement between the County of Riverside and MTGL in the amount of \$196,141. Amendment No. 1 to MTGL's agreement will provide additional consultant services which are needed through the extended construction period and will compensate MTGL in the amount not-to-exceed \$59,000 for a revised contract value of \$255,141.

Riverside County Purchasing conducted a bid process for a generator to provide power to RCRMC during the energizing of the Education Building transformer. A total of three responses were received; pursuant to review by County Purchasing and the Economic Agency, Global Power was determined to be the lowest, responsive and responsible bidder.

On June 30, 2014, the Riverside County Purchasing issued a purchase order to Global Power in the amount of \$137,000 and a date was set for the electrical power cut-over. A delay occurred when the Office of Statewide Health Planning and Developing issued a necessary permit after the date the electrical power cut-over was intended to occur. As a result of the delay, demobilization, remobilization and testing of the generator equipment are necessary to provide power to RCRMC during the energizing of the transformer to the Nursing and Allied HE Building project. Change Order No. 1 to the purchase order will compensate Global Power in the amount of \$99,853 for the additional work caused by the delay.

**Impact on Citizens and Businesses**

The RCRMC Nursing and Allied HE Building will be a free-standing building, separate from the RCRMC hospital. The building will provide essential space for services currently provided within the hospital; including nursing orientation, specialty training, new program development and training, patient education, coordination of outside speakers and clinical affiliation coordination.

Monies are expected to be expended in FY 2015/16. All costs associated with this agreement will be 100% funded by CORAL Bond Proceeds (debt service to be paid by RCRMC Enterprise Fund), thus no net county costs will be incurred. The overall project budget is \$18,728,365, Amendment No. 1 for MTGL and Change Order No. 1 for Global Power is within the project budget; therefore no budget adjustment is required at this time.

5 THIS FIRST AMENDMENT TO THE AGREEMENT FOR PROFESSIONAL  
6 SERVICES is made and entered into by and between the COUNTY OF RIVERSIDE,  
7 (“COUNTY”), and MTGL, Inc., herein referred to as “CONSULTANT”.

8 **RECITALS**

9 **WHEREAS**, the COUNTY entered into the Original Agreement with  
10 CONSULTANT on February 26, 2013 (“Original Agreement”);

11 **WHEREAS**, the COUNTY has determined that additional services are needed  
12 and CONSULTANT has agreed to provide such additional services to COUNTY;

13 **NOW, THEREFORE**, in consideration of the mutual covenants contained herein  
14 and providing that all other sections not amended remain in full force and effect, the  
15 parties hereto agree as follows, effective March 24, 2015.

16 I. Section 1. SCOPE OF SERVICES: of the Original Agreement is hereby  
17 amended to add the following sentence at the end of the first paragraph:

18 “CONSULTANT shall provide the additional professional services, as outlined  
19 and specified in Exhibit “A-1”, consisting of (1) page, attached hereto and  
20 incorporated herein by this reference.

21 II. Section 2. PERIOD OF PERFORMANCE: of the Original Agreement is hereby  
22 amended to read as follows: “CONSULTANT shall commence performance of  
23 services within (1) calendar day after execution of this Agreement, and shall  
24 diligently perform services to the full completion of the Project as required and  
25 in accordance with the revised, extended construction schedule of September  
16, 2015 developed by County, unless sooner terminated as specified in

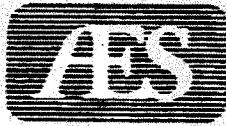
