BACKGROUND:

Summary (Continued)

Creating a list of pre-qualified architectural and engineering firms is in conformance Board with Policy H-7 and is intended to enable EDA to quickly respond to client needs and accelerate the delivery of active capital projects. In accordance with the policy, the period of qualification for the selected firms will remain in effect for a maximum of three years from the date of Board approval.

Per Board Policy H-7, a selection committee was established to review each firm's qualifications. After reviewing the submitted qualifications, the selection committee made the following recommendations for pre-qualified consultants in the disciplines listed in Attachment A and summarized below:

- 25 Firms for Architecture
- 10 Firms for Landscape Architecture
- 16 Firms for Civil Engineering
- 4 Firms for Structural Engineering
- 8 Firms for Commissioning/Building Automation Systems
- 9 Firms for Mechanical Engineering
- 13 Firms for Electrical Engineering
- 9 Firms for Plumbing Engineering
- 4 Firms for Specialty Engineering

Each firm offers particular strengths that may apply to different types of projects. The consulting services will be retained on an as-needed basis via the issuance of a contract or purchase order for negotiated services including, but not limited to, agreement on the scope of work, terms, conditions, and funding availability. The consultant services fees will not exceed \$100,000 per project and in accordance with Board Policy B-22 any project with a total budget estimated to exceed \$100,000 will be subject to the requirements of the Capital Improvement Program.
