BACKGROUND:

Summary (continued)

1. The donation to the Smiles for Seniors Foundation will be used to help low income seniors with emergency situations like obtaining medication, food, utility assistance and other emergency necessities that require an urgent response.
2. The donation to Inspire Life Skills will be used to help sponsor their 10th Annual Homecoming Festival where funds will be raised so they can continue to provide housing, life skills and guidance to aged-out foster youth.
3. The donation to the Jurupa Valley Adopt a Family will be used to help provide many services such as adopting low income families at the holidays, as well as to help with scholarships, a youth development academy, tutoring, and workshops to assist seniors with issues such as scams, nutrition and financial planning.
4. The donation to the Corona-Norco Family YMCA will be used for the Calvert Building Fund, which helps renovate and make repairs at various Y program sites. The current project is improvements at the YMCA Youth Center at Home Gardens and the YMCA Youth Center at Jurupa.
