- 3. If the owners or whoever has possession of the real property do not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the excess outside storage and accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. BACKGROUND:

- 1. An inspection was made on the subject property by Code Enforcement Officer John Game on October 23, 2013. The Inspection revealed accumulation of rubbish on the subject property in violation of Riverside County Ordinance No. 541. The items included but were not limited to: household trash, broken furniture, discarded wood, discarded cardboard boxes and other miscellaneous items.
- 2. A subsequent inspection was conducted by Officer Game on March 27, 2014. The inspection revealed excessive outside storage of materials on the subject property in violation of Riverside County Ordinance No. 348. The items included but were not limited to: motorcycle parts, building materials, wood, metal, tools, personal items and other miscellaneous items.
- 2. There have been approximately eleven (11) subsequent follow up inspections, with the last inspection being July 27, 2015. The property continues to be in violation of Riverside County Ordinance Nos. 348 and 541.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of the excess outside storage and accumulated rubbish.

DECLARATION OF CODE ENFORCEMENT OFFICER **BRIAN BEALER**

[RCO Nos. 348 & 541]

- I, Brian Bealer, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:
- I am currently employed by the Riverside County Code Enforcement Department as a Senior Code Enforcement Officer. My current official duties as a Senior Code Enforcement Officer include inspecting property for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. I am informed and believe and thereon allege that on October 23, 2013, Officer John Game conducted an inspection of the real property described as Vacant Parcel on Raley Avenue and Blackwell, Lakeland Village, Riverside County, California and further described as Assessor's Parcel Number 381-245-004 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Jeff Haneline and Heidi Haneline (hereinafter referred to as "OWNERS"). A certified copy of the County Equalized Assessment Roll for 2015-2016 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B." The property is located within the C-1/C-P (General Commercial) zone classification. Since this is an unimproved parcel, no amount of outside storage is allowed on THE PROPERTY. Accumulated rubbish is not permitted to be located on any property within the County of Riverside.

- 4. Based on the Lot Book Report from RZ Title Service dated July 14, 2015, it is determined that other parties may potentially hold an interest in THE PROPERTY, to wit: Internal Revenue Service (hereinafter referred to as "INTERESTED PARTY"). A true and correct copy of the Lot Book Report is attached hereto and incorporated herein by reference as Exhibit "C."
- 5. I am informed and believe and thereon allege that on October 23, 2013, Officer John Game drove to THE PROPERTY to conduct an inspection. Officer Game observed accumulated rubbish on THE PROPERTY. The accumulated rubbish consisted of, but was not limited to: household trash, broken furniture, discarded wood, discarded cardboard boxes and miscellaneous items. A subsequent inspection was conducted by Officer Game on March 27, 2014. Officer Game observed excess outside storage of materials on THE PROPERTY. The excess outside storage of materials consisted of but was not limited to: motorcycle parts, building material, wood, metal, tools, personal items and other miscellaneous items. This condition causes THE PROPERTY to constitute a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") Nos. 348 and 541.
- 6. On October 29, 2013, a Notice of Violation was mailed to OWNER, Jeff Haneline, by first class mail.
 - 7. On July 15, 2015, a Notice of Violation was mailed to OWNERS by first class mail.
- 8. On July 22, 2015, a Notice of Violation was mailed to INTERESTED PARTY by first class mail and was posted on THE PROPERTY on July 27, 2015.
- 9. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "D."
- 10. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "E."
- 11. There have been approximately eleven (11) subsequent follow up inspections, with the last inspection being July 27, 2015. Each inspection revealed the accumulated rubbish and excess outside storage of materials remained on THE PROPERTY in violation of RCO Nos. 348 and 541.

- 12. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 13. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO Nos. 348 and 541.
- 14. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNERS and INTERESTED PARTY, by first class mail and was posted on THE PROPERTY. True and correct copies of the Notices, together with the Proofs of Service, and the Affidavit of Posting of Notices are attached hereto and incorporated herein by reference as Exhibit "F."
- 15. The removal of all accumulated rubbish and excess outside storage of materials currently on THE PROPERTY is required to bring THE PROPERTY into compliance with RCO Nos. 348 and 541, and the Health and Safety Code.
 - 16. Accordingly, the following findings and conclusions are recommended:
- (a) the excess outside storage of materials and accumulated rubbish on THE PROPERTY to be deemed and declared a public nuisance; and
- (b) the OWNERS, or whoever has possession or control of THE PROPERTY, be required to remove all outside storage of materials and accumulated rubbish on THE PROPERTY in strict accordance with the provisions of RCO Nos. 348 and 541.
- (c) that if the materials and rubbish are not removed and disposed of in strict accordance with all Riverside County Ordinances, including but not limited to RCO Nos. 348 and 541, within ninety (90) days of the date of the posting and mailing of the Board's Order to Abate Nuisance, the outside storage of materials and accumulated rubbish may be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor, or the Sheriff's Department upon receipt of owner's consent or a Court Order when necessary under applicable law.
