Summary

California Elections Code §§ 10002, 10402, and 10403 allow jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct and consolidate elections by submitting a resolution requesting these services. The attached Exhibit A listed jurisdictions have requested the Registrar of Voters to conduct their elections. The Registrar of Voters has the resources to provide these services. The County will receive reimbursements from the jurisdictions for the full cost of conducting their election.
