MEETINGS:

The Riverside County Historical Commission met in 2014 and 2015 on a quarterly basis in February, May, August and November at various locations including Lake Elsinore, Temecula, Idyllwild, Indio and Riverside.

HISTORICAL COMMISSION ACTIONS FOR 2014-15:

- elected an Archives Commission Representative
- approved the proposal to print and distribute the marketing letter, accepted a list of facilities for donations of the books, and created a repricing of the current inventory
- approved the request by the Archives Commission to investigate the possibility of holding a joint Historical Commission/Archives Commission meeting
- approved the recommended changes in language and asked that the request be forward to EDA to change the sign located on the BOS table in the lobby of the CAC
- approved the concept of developing a subcommittee to review and create a process for annual history awards
- approved the request to create a subcommittee to propose ideas and events, and assist in the planning of the 125th Anniversary
- elected Historical Commission officers for FY 2014-15
- approved the 2015 Historical Commission meeting calendar
- approved the Outstanding Contribution to Local History Awards criteria and nomination form with the noted changes
- approved the nomination of Lawler Lodge as a historical landmark

OVERALL COMMISSION ACTIVITIES:

Commissioners supported the Park District by being active in their respective districts on behalf of historical issues, historic preservation, and history museums. They also attended park events throughout the year, including any one of the three employee/volunteer appreciation luncheons held in 2015.

The Riverside County Historical Commission will continue with its purpose to advise on historical matters throughout the County and to work with the District to achieve its strategic aims.

The Riverside County Regional Park & Open-Space Trails Committee met quarterly in August and November, 2014; and February and May, 2015, at Crestmore Manor, Jurupa Valley.

TRAILS COMMITTEE ACTIONS for 2014-15:

- Elected Trails Committee officers for FY 2014-15
- Approved the Trails Committee Meeting Calendar for FY 2014-15
- Wine Country Trails Plan Ad Hoc Committee developed Trail Plan Map, which Trails Committee adopted the map as a planning tool including potential trails

COMMITTEE MEMBERS & COMMUNITY INVOLVEMENT:

Committee members supported the Park District by attending events throughout the year, including, but not limited to: the Annual Employee/Volunteer/Support Group luncheon, the public information meeting on the Box Springs Trails Master Plan, Multi-Species Reserve (MSR) Management Committee meetings, and District Advisory Commission (DAC) meetings.

In addition to the subcommittees, members of the Trails Committee actively participated in community events including trail user meetings, trail rides, races, Adopt-A-Trail Program clean-ups and trail repair efforts, and the Murrieta Creek Trail Grand Opening.

The Committee provided feedback to District Planning staff on projects such as the Box Springs Trails Master Plan.

Committee Member Lynn Mattocks was recognized for his many years of service on the Trails Committee, community organizations, and his country by the District, Trails Committee members, Senator Stone, Supervisor Ashley, Rancho California Horsemen's Association, Santa Rosa Plateau Riding Club, De Anza Trail Caballeros, and Temecula Equine Riders.

Committee Member Phil Bremenstuhl attended the annual Trails and Open-Space Conference, held this year at Yosemite, to gather successful strategies and learn from other agencies.

OVERALL COMMISSION ACTIVITIES

The Trails Committee continues to work on the Riverside County Adopt-A-Trail Program, and to advocate to communities and resource agencies for the preservation and expansion of trails supporting hikers, bikers, equestrians, and all non-motorized users throughout the County – especially trails connecting communities, such as the Santa Ana River Trail.

The Trails Committee has worked in partnership with County departments to enhance efforts to provide, protect, and maintain the multi-use trail systems throughout the County.

The Trails Committee expresses appreciation to the Riverside County Regional Park & Open-Space District, Riverside County Transportation and Land Management Agency, Planning, Flood Control District, and the Board of Supervisors for assisting the Trails Committee in its mission to acquire, maintain, and promote equestrian, biking, and hiking recreation trails in Riverside County.

The Trails Committee wishes to continue to serve the people of Riverside County by being actively involved as members of the Riverside County Trails Committee and representing the varied interests of all trail users when considering trial programs and development.
