**BACKGROUND:**

**Summary (continued)**

1. The donation to the Debbie Chisholm Memorial Foundation will be used to fulfill the mission of granting wishes for catastrophically ill children, and providing respite-vacations to severely abused kids in Riverside and San Bernardino counties. This donation will also assist with their "Spirit of Christmas Program" where a family with a catastrophically ill child receives food and gifts so they can enjoy the holiday without financial burden.
2. The donation to the California Riverside Ballet will be used to help sponsor the 24<sup>th</sup> annual "Ghost Walk" which is a celebration of art, dance and storytelling. There will be 5 story tours followed by a kid's carnival on the Main Street Mall and is open to the entire community.
3. The donation to Peppermint Ridge will be used to sponsor their annual "Love Run" which is a short walk to raise money to support the residents of Peppermint Ridge, who provides residential services to adults with developmental disabilities.
4. The donation to Christian Arts and Theater will be used to offer scholarships to low and moderate income families so their children have an opportunity to study acting, singing, and dancing, which are art forms that has been removed from many public schools throughout California.
