BACKGROUND:

Summary

The Economic Development Agency received a request to replace the boiler at the Riverside CAC located at 4080 Lemon Street, Riverside, California. The work included demolition and removal of the existing absorption chiller and associated piping, installation of a new concrete pad for the new boiler; new hot water pump and piping, isolation and control valves; and electrical and insulation of hot water piping.

On July 1, 2014, the Board of Supervisors approved the construction agreement for Job Order Contract No. 006 between the County of Riverside and Pub. Pursuant to the contract, a job order was issued for the replacement of the boiler at the Riverside CAC in the amount of \$181,008.

The project has been inspected and found to comply with the contract requirements. This Board action will release the contract retention funds of \$9,050 to Pub after the Notice of Completion has been filed and the 35 day lien period has expired. The contract retention funds are within the overall project budget and no additional funding is required.

Impact on Citizens and Businesses

The new energy efficient boiler and associate components meet the requirements of the Southern California Air Quality Management District. Installation of the new boiler will decrease energy consumption and reduce operating costs while providing improved levels of heat to the facility.




