### **BACKGROUND:**

### Summary

By Minute Order dated June 30, 2015 (Agenda Item 3-63), the Board of Supervisors authorized the Clerk of the Board to advertise for the pavement resurfacing of three Transportation Department maintenance yards located in El Cerrito, Hemet, and Perris.

The environmental clearance for the project has been documented by the Notice of Exemption, which was approved by the Board of Supervisors on June 30, 2015 (Agenda Item 3-63).

The resurfacing work consists of grinding the existing asphalt concrete pavement to remove up to three inches, grading the site and compacting the existing subgrade, and resurfacing with new hot mix asphalt. The resurfacing work will be limited to the existing paved parking areas.

During the advertisement period, one addendum was issued to all registered plan holders as a supplement to the specifications. Bidders were required to acknowledge and take into account the issued addendum on their Contractor's Bid in order to be considered for award. The addendum was issued to clarify and modify the approved contract documents. The addendum is attached and designated as Addendum Number 1.

The construction contract includes the following schedules of work:

Base Bid Schedule:

Resurfacing of three maintenance yards

Alternate Bid Schedule 1:

Additional area to resurface at El Cerrito Maintenance Yard

Alternate Bid Schedule 2:

Additional area to resurface at Perris Maintenance Yard

The contractor is qualified to perform the work as outlined in the bid, has executed the contract, and has provided bonds and insurance documents, which meet the requirements of the contract.

### Impact on Residents and Businesses

The proposed improvements will improve surface drainage and benefit the project area by significantly increasing the service life of the existing infrastructure and provide a safer paved surface to the Transportation Department's Operation and Maintenance staff.

The construction work will take approximately three weekends to complete and will be phased to keep the maintenance yard locations open during construction, continuing to service public needs.

### **SUPPLEMENTAL:**

### **Additional Fiscal Information**

The contract is recommended to be awarded to All American Asphalt for the total amount of \$361,156. The project is funded with Gas Tax.

There are no General Funds used in this project.

### **Contract History and Price Reasonableness**

Seven bids were received on August 5, 2015, ranging from \$361,156 to \$622,400. The bid received from Jacobsson Engineering Construction, Inc. (Jacobsson) was found to be nonresponsive due to the missing bid price for bid items 9, 10, and 11. Jacobsson was notified by a letter dated August 7, 2015. A copy of the letter is attached herewith. Their bid was the sixth highest in bid price ranking.

The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by All American Asphalt in the amount of \$361,156, which is \$61,104 (14%) lower than the Engineer's Estimate.







### Contract

THIS CONTRACT is entered into at Riverside, California as of the date set forth below is between County of Riverside hereafter called "County" and **All American Asphalt**, hereafter called "Contractor".

## WITNESSETH

### **Recitals:**

- Contractor has submitted to County his Contractor's Proposal for the construction of County Project, <u>El Cerrito, Hemet and Perris Maintenance Yards Pavement Resurfacing Project</u>, <u>Project No. 15-00008</u>, in strict accordance with the Contract Documents identified below and County has accepted said Proposal.
- 2. Contractor states that he has reexamined his Contractor's Proposal and found it to be correct, has ascertained that his subcontractors are properly licensed and possess the requisite skill and forces, has reexamined the site and Contract Documents and is of the opinion that he can presently do the work in accordance with the Contract Documents for the money set forth in his Proposal to be paid as provided in the Contract Documents.

### **Agreement:**

It is agreed by the parties as follows:

### 1. Contract Documents

The entire Contract consists of the following: (a) The Construction Contract, (b) The Notice Inviting Bids. (c) The Instruction to Bidders, (d) The Bid, (e) The Bid Bond, (f) The Payment Bond, (g) The Performance Bond, (h) The General Conditions, (i) The Special Provisions, (j) The Standard Specifications of the State of California Department of Transportation edition of May 2006 as modified in other portions of the Contract Documents and as amended by the State of California Department of Transportation, (k) The Standard Plans of the Department of Transportation identified on the plans or in the Special Provisions, (l) The Plans, (m) Addenda one, (n) The Determination of Prevailing Wage Rates for Public Work, (o) Any Change Orders issued, (p) Any additional or supplemental specifications, notice, instructions and drawings issued in accordance with the provisions of the Contract Documents. All of said Documents presently in existence are by this reference incorporated herein with like effect as if here set forth in full and upon the proper issuance of other documents they shall likewise be deemed incorporated. The Bid Bond is exonerated upon execution of this Contract and the Payment Bond and Performance Bond.

### 2. The Work

Contractor shall do all tasks necessary to construct the work generally described in Recital No. 1 in accordance with the Contract Documents.

# 3. Liquidated Damages and Time of Completion

Attention is directed to the provisions in Section 8-1.06,"Time of Completion", and in Section 8-1.07 "Liquidated Damages", of the Standard Specifications and these Special Provisions.

Standard Specification Section 8-1.03, "Beginning of Work" is modified to read as follows:

The Contractor shall begin work within <u>fifteen (15)</u> calendar days, or as revised in the Special Provisions, of the date stated within the written "Notice to Proceed".

The Contractor shall notify the Engineer, in writing, of the Contractor's intent to begin work at least 72 hours before work is begun. If the project has more than one (1) location of work, Contractor shall submit a separate notice for each location. The notice shall be delivered to the Transportation Department's Construction Engineer and shall specify the date the Contractor intends to start at said location.

Should the Contractor begin work in advance of receiving a written "Notice to Proceed", any work performed by the Contractor in advance of the date stated in the "Notice to Proceed" shall be considered as having been done by the Contractor at his own risk and as a volunteer and subject to the following:

- A. The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
- B. All work done according to the Contract, prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
- C. The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".

### 4. Compensation

Contractor shall be paid in the manner set forth in the Contract Documents the amount of his Proposal as accepted by County, the above rates, subject to additions and deductions as provided in the Contract Documents. Said Proposal is on file in the Office of the Clerk of the Board of Supervisors of County.

## Item 5: Clearing and Grubbing

Refer to section "Clearing and Grubbing" on page 11 of Special Provisions. Following additional requirement included and made part thereof.

Clearing and Grubbing work shall include the removal and disposal of existing gravels/crushed rocks near northerly yard boundary west of existing building at Perris maintenance yard. Contractor shall keep 5' wide setback from the fence for removal of gravels/crushed rocks. The approximate area of removal is 435 Square Feet.

Note: County Forces will clear the sites of all three maintenance yards to keep County owned construction materials and equipment out of the way of contractor.

## Item 6: Hot Mix Asphalt

Refer to section "Hot Mix Asphalt" and fifth paragraph under subsection entitled "Applying Asphalt" on page 14 of Special Provisions. Delete the fifth paragraph entirely from Liquid Asphalt...through...specified in the Special Provisions.

Following provisions added and made part thereof:

### Perris Maintenance Yard:

Contract shall protect existing concrete pad around the building and new pavement shall be joined 0.1' below the concrete pad surface.

#### Alternate Bid Schedule 2

If alternate bid schedule 2 was selected for award, contractor's attention is directed to the stockpile that exists in the "Area 2" delineated on Exhibit for Perris yard. County forces will remove the stockpile prior to contractor's operation. Removal of AC berm around the stockpile area and pavement under the stockpile shall be considered as included in the pavement removal work for Alternate Bid Schedule 2 and no additional compensation will be allowed therefor.

### Hemet maintenance yard:

Contractor shall remove existing ribbon gutter where marked on the existing pavement prior to resurfacing. The existing ribbon gutter is approximately 60 feet in length and 8 feet in width buried under the AC surface. Ribbon gutter removal area shall be backfilled and compacted prior to resurfacing.

Contractor shall pave flush to the building pad as it currently exists and as close as possible to existing fence.

Note: the unidentified utility line seen at the Hemet Yard was not active, and has been removed by County forces. No trenching to remove or relocate this line is required. Contractor is to assume electrical lines not seen are shallow.

## **Protect Existing Facilities:**

Contractor must protect existing utilities, irrigation lines, fence/gate, and all other structures those needed to be protected from being damaged by construction activities.
