On motion of Supervisor Benoit, seconded by Supervisor Ashley, and duly carried by unanimous vote, IT WAS ORDERED that the meeting of Tuesday, October 6, 2015, be adjourned in memory of Daniel Thompson, a 94-year-old "inventor" and longtime resident of Palm Desert who passed away on September 3, 2015.

Born on January 16, 1921 in Winnipeg, Canada, Daniel's family moved to Los Angeles, California at the end of 1921 and opened a bakery in Boyle Heights. By the age of 11, he was enlisted to help his father build a "bagel-making machine" that could produce a bagel the way a handmade bagel was formed but faster and in larger quantities. After several failed attempts, their endeavor was put on hold until after World War II.

Daniel attended the University of California, Los Angeles but left to join the U.S. Military. He proudly flew 35 missions as navigator/bombardier on a B-29 Superfortress while stationed on Saipan during the war in the Pacific. When the war was over, he resumed his education at UCLA to earn a teaching credential in Industrial Arts. Since "Machine Shop" was one of the required subjects, he helped his father build his next prototype "bagel-making machine" in UCLA's Industrial Arts Building. After graduation, he continued to help his father during his free time.

In 1950 Daniel invented the first folding Ping-Pong Table on wheels and received a U.S. Patent on July 14, 1953, which he sold to buy tools to perfect a "bagel-making machine." By 1958 he created a machine that could produce 2,400 bagels an hour. That summer he started building the "Thompson Bagel Machine" and retained a mechanical engineer to design a production prototype. In 1961 Daniel and his wife Ada incorporated their new business, Thompson Bagel Machine Manufacturing Corporation. Murray Lender of Lender's Bagels in New Haven, Connecticut leased the first machine, and in August 1963 the machine was installed and would soon "revolutionize" the bagel industry. Daniel eventually quit teaching and went into the bagel-making machine business full-time. The Los Angeles-based company is now run by his son Steve.


