FIRST AMENDMENT TO THE AGREEMENT BETWEEN COUNTY OF RIVERSIDE

COUNTY OF RIVERSIDE AND

CITY OF BLYTHE

(Animal Shelter Services)

Agreement No. 15-013 between the County of Riverside through its Department of Animal Services (COUNTY) and City of Blythe (CITY), approved on June 30, 2015, executed by the Board of Supervisors item 3.7, is hereby amended for the first time effective on the later date of execution by both Parties as follows:

- 1. To incorporate into the Agreement, in Exhibit A, Scope of Animal Shelter Services, the following section "3.27 Animals Surrendered by their Owners: Any pet surrendered by the owner to an Animal Control Officer and transported to the COUNTY shelter shall incur the prevailing owner surrender charges. Such fees shall be collected from the owner and conveyed to the COUNTY, or be charged directly to the CITY at the established stray animal rate for the shelter."
- 2. All other terms and conditions of this Agreement are to remain unchanged.
