BACKGROUND:

Summary

This is a cost reimbursement grant award, therefore the awarded amount is not received in advance.

FY14-15, the Sheriff's Department expended \$375,290 of grant funds for the BJA program. The program provided resources in the County to educate, prevent, intervene, and treat victims of sex trafficking, labor trafficking and exploitation.

For FY15-16, the Sheriff's Department is now requesting a budget adjustment of \$124,710 for the remaining grant funds. The grant performance period was October 1, 2013 to September 30, 2015. A no-cost grant extension has been approved through March 31, 2016.

Remaining grant funds will continue to ensure multi-disciplinary participation with federal, state and local law enforcement agencies, prosecution and non-governmental organizations for the purpose of identifying trafficking victims.

Impact on Citizens and Businesses

The grant mission is to identify, investigate and prosecute human trafficking crimes and improve and expand comprehensive services to all victims of human trafficking through outreach, training and public awareness in Riverside County.
